**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of the Epson America, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document and any amendments for more specific provisions.

**A. General**

The Plan is a defined contribution plan that was established in 1984 by Epson America, Inc. (the “Company”) to provide retirement benefits for eligible employees, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was amended and restated in its entirety to comply with the Economic Growth and Tax Relief Reconciliation Act (“EGTRRA”) and other legislative changes.

**B. Administration and Expenses**

The Company appointed a 401(k) Committee (the “Administrative Committee”) to manage the operation and administration of the Plan. T. Rowe Price Trust Company (“T. Rowe Price”) serves as Plan trustee; T. Rowe Price affiliate serves as third party administrator to maintain the records of participant data. Investment fund management fees and operating expenses are charged directly to the fund and are thereby factored into each fund as a reduction in investment return. Other costs of administering the Plan may be paid from the Plan or paid by the Company at the discretion of the Administrative Committee.

**C. Eligibility**

All employees are eligible to participate in the Plan as of the second payroll period following the date of employment except leased employees, any employee who is a Japanese citizen on temporary assignment from Seiko Epson Corporation and accruing benefits under the Seiko Retirement Plan in Japan, and any person not classified as an employee by the Company for which such person performs services.

**D. Participant Contributions**

Participants may elect to have the Company contribute their eligible compensation on a pre-tax or Roth basis, as defined in the Plan, up to the amount allowable under the Plan document and current income tax regulations. Participants age 50 and older may make additional catch-up contributions, up to applicable Code limits.

Newly hired employees, including those who do not make an affirmative election to defer compensation to the Plan, are auto-enrolled at a pre-tax contribution rate of 5% of eligible compensation with an annual contribution accelerator feature of 2% each year up to a maximum of 15%.

Participants are allowed to make rollover contributions of amounts received from other tax-qualified retirement plans subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant’s investment directions.

**E. Employer Contributions**

The Company matches 75% of the participant’s contribution up to the first 5% of eligible compensation and matches 25% of the next 5% of eligible compensation. Each year, the

**E. Employer Contributions (Continued)**

Company also makes a retirement contribution of 4% of eligible compensation for eligible participants. Eligible compensation includes commissions limited to 20% of the participant's base salary or base wages and Section 125 compensation, which would include pre-tax payroll dollars deducted to pay benefits covered under a flexible benefit plan. Effective April 27, 2020, the Plan was amended to make Company matching and retirement contributions discretionary.

**F. Participant Accounts**

Each participant's account is credited with the participant's contributions, rollovers, employer matching contributions and an allocation of Plan earnings or losses and expenses. Plan assets are invested based solely on instructions received from participants.

The contributions of participants who decline to make an investment election are invested in a default investment option as determined by the Administrative Committee until the participant makes investment elections under the Plan.

**G. Vesting**

Participants are immediately vested in their elective deferral contributions, rollover contributions, qualified non-elective contributions, qualified matching contributions plus actual earnings thereon. Vesting in employer matching contributions is based on the following schedule:

After 2 years	50
After 3 years	75
After 4 years	100

Participants also become fully vested upon reaching normal retirement age (65), death while in the employ of the Company, termination by reason of disability or termination of the Plan by the Company.

**H. Payment of Benefits**

Upon termination of service, death, disability or retirement, a participant or beneficiary may choose to maintain his or her account in the Plan or receive benefits in a lump sum payment or installment payments equal to the value of the participant's account balance. If a terminated participant's account balance is between \$1,000 and \$7,000 and no distribution election has been received from the participant or beneficiary of the account, the account will be rolled over to an individual retirement account at the direction of the plan administrator. If such account does not exceed \$1,000, the balance will be paid in a lump sum distribution. Under limited circumstances, the plan administrator may approve hardship withdrawals. Additionally, an in-service distribution can also be made to participants who have attained the age of 59½.

**I. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$500 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan within one to ten years. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

**J. Forfeitures**

Forfeitures of nonvested account balances are applied first to restore the forfeited portions of Company contribution accounts of rehired participants. Any remaining forfeitures are applied to reduce future Company contributions. At December 31, 2024 and 2023, the Plan had \$89,944 and \$16,872, respectively, in forfeitures, included with investments available to reduce future Company contributions. During 2024, the Plan had a \$446,413 reduction to contributions from forfeited nonvested accounts and \$511,676 in forfeitures.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

**B. Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

**C. Investment Valuation and Income Recognition**

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 7).

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual funds capital gains distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market fluctuations and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statement of changes in net assets available for benefits.

**NOTE 3 - PARTY-IN-INTEREST TRANSACTIONS**

Certain investments held by the Plan are issued and managed by the trustee or an affiliate of the trustee. Transactions related to these investments qualify as party-in-interest transactions; however, they are exempt from the prohibition under ERISA.

**NOTE 4 - INCOME TAX STATUS**

The Plan is based on a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service on August 19, 2020 stating that the form of the plan qualifies under Section 401 of the Code. The Plan has since been amended. However, the Company believes that the Plan is being operated in accordance with and continues to qualify under the applicable requirements of the Code and related state statutes, and that the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date, which will be treated as the valuation date.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price, the trustee of the Plan.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

GAAP establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are based on quoted prices in an active market. Level 2 inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds valued at quoted market prices. The following tables summarize the Plan's investments at December 31 based on the inputs used to value them:
