We have audited of the financial statements of Unex Corporation 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit] for the year ended December 31, 2024 and have issued our report thereon dated October 8, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Ascensus LLC, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter to you dated July 21, 2025. Professional standards also require that we communicate to you the following information related to our audit.

Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Unex Corporation 401(k) Profit Sharing Plan and Trust are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. There were no significant estimates affecting the financial statements and the financial statement disclosures are neutral, consistent, and clear.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all known and likely misstatements identified during the audit other than those that are trivial, and communicate them to the appropriate level of management. There were no misstatements identified during our audit.

Disagreement with Management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated October 3, 2024.

Other Matters

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution



agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Other Audit Findings and Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

We will review the status of these comments during our next audit engagement. We have already discussed many of these comments and suggestions with you and we will be pleased to discuss these comments in further detail or to assist you in implementing the recommendations. Our comments are summarized as follows:

Investment Policy Guidelines

We noted the Plan has not adopted a formal written investment policy. ERISA imposes a fiduciary responsibility requiring a Plan, among other things, to manage plan assets solely in the interest of participants and beneficiaries and to diversify investments in order to minimize any risks.

We recommend that the Plan Sponsor adopt investment policy guidelines that outline the roles and responsibilities of those individuals involved in the Plans' administration, and in order to ensure that Plan assets are prudently and effectively managed. Such a policy should also address permitted investments, asset mix, and concentration, as well as provide for a method of reviewing, monitoring and taking appropriate action with regard to the Plans' overall investment performance. This can be accomplished by documenting these guidelines in the form of a written document.

Fiduciary Responsibility

As plan sponsors, the management of Hytorc has a fiduciary responsibility with respect to the Plan. Fiduciary responsibilities include but are not limited to acting solely in the interest of the plan participants and their beneficiaries and with the exclusive purpose of providing benefits to them, carrying out those duties prudently, following the plan documents (unless contrary to ERISA), diversifying plan investments and paying only reasonable plan expenses. They have a duty to avoid prohibited transactions or transactions that are a conflict of interest. It is important that a fiduciary be aware of these responsibilities.

Plan sponsors have an additional responsibility regarding disclosures on fees paid by the plan. Sponsors must prominently display on participants' quarterly statements the administrative costs for running the plan and on annual statements any investment-related fees. It is important that these fees be monitored to ensure that the plan is paying reasonable fees, as this is part of the fiduciary responsibilities.




Forfeiture Account

During our audit, we noted that the forfeiture balance from 2023 of over \$156,000 has increased as of December 31, 2024, to a balance of over \$172,000. We urge you to continue to clear out the forfeiture balance, as DOL requires that funds in the forfeiture account be used as soon as possible to either reduce the employer contribution, or allocated to the remaining participants in the Plan.

We recommend that the Plan Sponsor make every effort to clear out the forfeiture account as soon as reasonably possible.
