NOTE 1 – PLAN DESCRIPTION AND RELATED INFORMATION

The following description of The Clarke Group, Inc. Cash or Deferred Profit Sharing Plan and Trust (the “Plan”) provides only general information.

General: The Plan is a defined contribution plan covering substantially all employees of The Clarke Group, Inc. (the “Company”). Employees are eligible to participate after six months of full-time employment or 1,000 hours of service in a 12 month period as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may contribute an amount from 1% to 100% of their annual compensation as either pretax or Roth after-tax salary deferrals, as defined in the Plan, up to the maximum allowed by Internal Revenue Code (IRC 401(g)(i)) (Code), adjusted annually for the cost of living. This amount was \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes a match determined by the Company’s Board of Directors, which is equal to the lesser of 50% of the amount the participant contributed or 6% of the participant’s compensation. Additional discretionary amounts may be contributed at the option of the Company’s Board of Directors. The employer matching contributions are paid into the Plan with each payroll period along with the employee deferrals. Discretionary amounts are paid in arrears in the third quarter of the following year. For the year ended December 31, 2024, the Company’s profit sharing contribution was \$0.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) plan earnings; and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Company’s matching and discretionary contribution portion of their accounts plus actual earnings thereon according to the following schedule:

1 st year of service	33 1/3%
2 nd year of service	33 1/3%
3 rd year of service	33 1/3%

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding note balance in the participant’s account during the prior 12-month period or (b) 50% of their vested account balance. Note terms range from one to five years; however, notes used to purchase a primary residence may be up to 15 years. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator.

Payment of Benefits: On termination of service due to death, retirement, disability, or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the vested portion of their account or a distribution by other methods as described in the Plan. In-service distributions are allowed upon the participant’s attainment of age 59 ½ and participation in plan for at least five years or accumulation of plan assets for at least two years.

In certain circumstances, participants may make “hardship withdrawals” as defined in the Plan. Distributions are subject to the applicable provisions of the Plan agreement.

Forfeitures: Forfeitures are available to offset contributions which would otherwise be payable by the Company in accordance with the Plan agreement. At December 31, 2024 and 2023, the forfeiture account balance totaled \$1,594 and \$9,469, respectively. During 2024, \$9,469 of forfeitures were used to contribute to the Plan’s discretionary profit sharing contribution.

Administrative Expenses: In general, administrative expenses of the Plan are paid by the Company. Investment management fees, recordkeeping and loan charges are paid by the Plan. Investment management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accounting principles and procedures followed by the Plan conform to accounting principles generally accepted in the United States of America. The financial statements of the Plan are prepared under the accrual basis of accounting.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants’ account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Investment Valuation and Income Recognition: The Plan’s investments are stated at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan’s principal or most advantageous market for the asset or liability. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Interest and dividend income are recorded when received by the Plan.

Risks and Uncertainties: The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Estimates: The preparation of financial statements in conformity with the accrual basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 29, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following description of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan:

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust – Stable Value Fund: The fair values of participation units held in the stable value collective trust are based on the net asset values of the trust, as reported in the audited financial statements. The investment objective of the collective trust held by the Plan is to preserve principal and provide interest income reasonably obtained under prevailing market conditions and rates, while also maintaining liquidity. The trust seeks to maintain a \$1.00 net asset value per unit. The collective trust provides for participant units to be issued and redeemed at the end of each day, provided that redeeming participant plans comply with a required one-year notice provision.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America, N.A. (Bank of America), the trustee of the Plan.

NOTE 5 – PARTIES-IN-INTEREST TRANSACTIONS

Notes receivable from participants are considered party-in-interest transactions. Fees paid to Bank of America for administrative services and investment management fees qualify as party-in-interest transactions.

The Plan is administered by an administrative committee consisting of plan trustees and certain Company employees. The employees are compensated by the Company and do not receive compensation from the Plan.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The Internal Revenue Service (IRS) issued an opinion letter dated November 24, 2014 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
