**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Purcell Construction Corp. Employee Savings and Protection Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Opinion**

## NOTES TO FINANCIAL STATEMENTS

#### NOTE A--DESCRIPTION OF THE PLAN AND SUBSEQUENT EVENT

The following description of the Purcell Construction Corp. Employee Savings and Protection Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Purcell Construction Corp. (“Plan Sponsor”/“Company”). An employee is eligible to participate in the salary deferral feature and wage rate contributions (see description below) upon commencement of employment. An employee is eligible to participate in the discretionary matching contribution feature upon commencement of employment so long as the employee is not receiving wage rate contributions. The Plan is subject to the provisions of ERISA. The Plan Trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Contributions and Subsequent Event: Each year participants may contribute tax-deferred and after-tax Roth dollars through payroll deductions of up to the maximum in any calendar year as set forth in the Internal Revenue Code (“IRC”). Current tax law limits each participant’s total pretax and Roth deferrals to \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 as determined by the Internal Revenue Service (“IRS”) for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company also makes contributions (“wage rate contributions”) for participants working on projects covered by prevailing wage rate schedules issued by the DOL under the Davis-Bacon Act, New York State Department of Labor under Article 8, Section 220 of the New York Labor Law and/or any other state department of labor. The contribution is equal to the fringe benefit pension rate determined for the participant multiplied by the number of hours the participant worked. Wage rate contributions for 2024 and 2023 were \$-0- and \$186, respectively. Plan provisions permit the Plan Sponsor to match a discretionary percentage of all eligible participants’ elective deferral contributions. The discretionary matching contributions equaled 100% of elective deferral contributions made to the Plan up to a maximum of 6% of annual compensation for 2024 and 2023. Discretionary matching contributions totaled \$375,368 and \$412,718 for 2024 and 2023, respectively. Contributions are subject to certain IRS limitations.

Effective January 1, 2025, the Plan was amended to allow for safe harbor employer matching contributions in an amount equal to 100% of the first 6% of eligible compensation, contributed to the Plan as salary deferral contributions.

NOTE A--DESCRIPTION OF THE PLAN AND SUBSEQUENT EVENT--Continued

Participant Accounts: Each participant's account is credited with the participant's contributions, discretionary matching contributions and wage rate contributions as well as allocations of Plan earnings and losses and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants have full and immediate vesting in all of their account balances.

Receivables--Notes From Participants: Participants are not permitted to borrow from their accounts.

Payment of Benefits: Distributions from the Plan are based upon retirement, death, termination of employment, proven hardship, or disability. A participant may elect to receive a lump-sum amount equal to the value of the participant's account, one of several annuity options or a series of installments chosen by the participant. For termination of service for other reasons, a participant may receive the value of his or her account as a lump-sum distribution. If a terminated participant's vested account balance is between \$1,000 and \$5,000, and they fail to make a distribution election, a lump-sum amount will be rolled over to an individual retirement account without their consent in the sixth month after employment was terminated. If a terminated participant's vested account balance is \$1,000 or less, and they fail to make a distribution election, a lump-sum amount will be paid to the participant without their consent in the sixth month after employment was terminated.

Forfeitures: All participant account balances are fully vested and nonforfeitable.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note H for discussion of fair value measurements.

Purchases and sales of shares in registered investment companies and units of the collective trust are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable: Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant salary deferrals. There were no excess contributions payable for the plan year ended December 31, 2024. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Payment of Benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Custodial fees, as applicable, are also included in administrative expenses.

Events Occurring After Reporting Date: The Plan's management has evaluated events and transactions that occurred between December 31, 2024 and October 8, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements. Other than the event described in Note A, there were no such events or transactions identified by the Plan management.

NOTE D--RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan has not considered Company contributions to the Plan or benefits paid by the Plan to participants as party in interest transactions. The Plan invests in shares in registered investment companies and units of a collective trust managed by Hand Benefits & Trust Company. Hand Benefits & Trust Company is the custodian of the Plan and therefore, these transactions qualify as party in interest transactions and are exempt from the prohibited transaction rules. Fees incurred by the Plan for the custodial services are included in administrative expenses. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### NOTE D--RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS--Continued

Hand Benefits & Trust Company receives revenue from the investment fund service providers for services Hand Benefits & Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Hand Benefits & Trust Company for administrative services provided to the Plan. There were no revenues received in excess of the cost of administrative services provided by Hand Benefits & Trust Company to the Plan during 2024 and 2023.

#### NOTE E--PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions and/or terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants maintain their 100% nonforfeitable interest in their account balances, and the custodian will distribute to each participant the balance of their account in a single lump-sum payment.

#### NOTE F--TAX STATUS

The Plan uses a non-standardized form of pre-approved plan. The pre-approved plan provider, Benefit Plans Administrative Services, LLC, the recordkeeper, has received an opinion letter dated June 30, 2020 from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### NOTE G--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### NOTE H--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, "Fair Value Measurements and Disclosures", are described as follows:

Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2     Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Shares in registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust: Valued at the NAV of units of the collective trust. The NAV, as provided by Hand Benefits & Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, Hand Benefits & Trust Company reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
