## Independent Auditors' Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Kirkwood Holding Inc. Retirement Savings Trust and Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

NOTES TO FINANCIAL STATEMENTS

**Note 1. Summary of Accounting Policies**

**Basis of Accounting:**

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition:**

Empower Annuity Insurance Company of America ("Empower") served as the Custodian of the Plan and Empower Trust Company, LLC was the Trustee for 2024 and 2023.

CapTrust Financial Advisors ("CapTrust") was hired as plan and investment advisors. CapTrust provides plan management with advisory services that are independent of the Plan's Custodian and Trustee.

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, Custodian and Trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a settlement-date basis. Interest and dividend income are recorded when received. There is no significant difference between this methodology and the accrual basis of accounting for the periods presented. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes Receivable From Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Note 1. Summary of Accounting Policies (Continued)**

**Benefits Payments:**

Benefits payments are recorded when paid.

**Administrative Expenses:**

All administrative expenses of the Plan are paid by Kirkwood Holding Inc. (the "Company") or the Plan at the option of the Company, or are offset with revenue sharing payments received by the Plan Trustee and recordkeeper from investment fund managers. Expenses offset with revenue sharing payments totaled \$38,281 and \$20,137 for the years ended December 31, 2024 and 2023, respectively. These amounts are recorded on a net basis within administrative fees. In addition, \$4,755 of revenue sharing payments were received during 2024 that are recorded within net appreciation in fair value of investments for the year ended December 31, 2024. \$68,625 and \$54,082 remain in the Plan's revenue sharing account at December 31, 2024 and 2023, respectively.

**Subsequent Events:**

The Plan has evaluated subsequent events and transactions for potential recognition and presentation through the date the financial statements were available to be issued, October 3, 2025.

**Note 2. Plan Description**

The following description only provides general information of the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Effective February 1, 1989, Kirkwood Industries, Inc. established the Kirkwood Industries, Inc. Retirement Savings Trust and Plan. In 2005, the aforementioned plan was assigned to and assumed by the Company and was renamed Kirkwood Holding Inc. Retirement Savings Trust and Plan. The Plan provides participants or their beneficiaries with retirement and other benefits as described in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**Participation:**

Substantially all employees are eligible to participate in the Plan on the entry date following thirty days of continuous service. The entry date for the Plan is the next available payroll following the date a participant meets the eligibility requirements.

**Administration:**

Certain administrative functions of the Plan are performed by officers or employees of the Company or its affiliated companies. No such officer or employee receives compensation from the Plan.

## NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 2. Plan Description (Continued)****Contributions:**

Participants may make pre-tax contributions of an amount they elect up to 100% of their eligible compensation, subject to certain Internal Revenue Service ("IRS") limitations. Participants may also elect to make after-tax Roth contributions to the Plan, subject to the same limitations. In addition, employees fifty years or older are eligible to make catch up contributions up to \$7,500 for 2024 and 2023. The Plan employs an automatic deferral format in which new employees are automatically enrolled when they become eligible. Unless otherwise directed by the participant, 3% of eligible earnings is withheld and invested in the Plan's qualified default investment alternative. The automatic deferral includes an escalation provision where a participant's deferral percentage increases on January 1 of each plan year as follows, unless the participant elects annually to opt out of this increase:

The Company may make discretionary matching and profit sharing contributions to all active participants. The matching contributions were at a rate of 50% of each participant's 1% of deferral, with a maximum match of 3% for 2024 and 2023. For 2024 and 2023, the Company did not make a profit sharing contribution to the Plan. The matching and profit sharing contributions are subject to change at the discretion of the Company.

**Participant Accounts:**

The Plan maintains an individual account for each participant. This account is credited with the participants' contributions, Company contributions and related earnings and charged with an allocation of any expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants elect to maintain their accounts in any combination of the eleven investment options. Separate accounting for each of the funds is made pursuant to the participant's designated election.

**Forfeited Accounts:**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$24,247 and \$49,293, respectively. For 2024, \$56,175 of the forfeiture balance was utilized to reduce employer contributions. For 2023, \$19,607 of the forfeiture balance was utilized to pay administrative expenses of the Plan.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 2. Plan Description (Continued)**

**Vesting:**

Participants are at all times fully vested in their elective deferral contributions and earnings thereon. Participants vest in the Company contributions 20% each year starting with the second year of service until fully vested after six years, or in the event of death, disability or attaining early or normal retirement age as defined by the Plan.

**Payment of Benefits:**

A participant, upon retirement, termination or disability, or a participant's beneficiary, upon the participant's death, may elect to receive either a lump-sum amount equal to the value of his or her account or installment payments. In the case of a severe financial hardship, the administrator, at its sole discretion, may approve the distribution of all or a portion of a participant's account, subject to certain restrictions. The Plan also provides for in-service distributions upon attaining age 59½.

**Notes Receivable From Participants:**

The Plan permits limited borrowing by a participant against the value of his or her account and repayments are made through payroll deductions under the Plan. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the account balance or \$50,000. Only one loan per participant can be outstanding at any given time. Interest is charged based on the prevailing rate at the time of the loan. Repayments of principal and interest are credited to the participants' separate accounts within the funds as elected by the participants. Until such repayments are received, the notes receivable are accounted for in the participant loan fund.

**Termination Provisions:**

The Company anticipates that the Plan will continue indefinitely; however, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan by an action of its Board of Directors, subject to the provisions of ERISA. In the event of termination of the Plan, participants would become 100% vested in their accounts. Any unallocated assets of the Plan at the time of termination would be allocated to participant accounts and distributed in accordance with the plan document.

**Note 3. Federal Income Tax Status**

The Plan has adopted a prototype plan document. This plan document obtained its latest opinion letter on September 16, 2022, in which the IRS stated that the document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax-exempt as of the financial statement date.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 3. Federal Income Tax Status (Continued)**

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

**Note 4. Unaudited Information**

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received certifications from Empower Annuity Insurance Company of America, the Custodian of the Plan, and Empower Trust Company, LLC, the Trustee of the Plan, acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, the related investment and loan interest activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 5. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities
- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs for which little or no market data exists

The following is a description of the valuation methodologies used for assets of the Plan measured at fair value at December 31, 2024 and 2023:

- Registered investment companies: Valued based on their quoted market prices in active markets for identical investments and are classified as Level 1.
- Pooled separate account: The investment in the pooled separate account is held and manager by Empower. The fair value of investments held in this account is based on its reported net asset value ("NAV"). The NAV is based primarily on observable inputs and the market value of the underlying investments, and is classified as Level 2.

**Note 5. Fair Value Measurements (Continued)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6. Guaranteed Investment Contract**

The Plan has a guaranteed investment contract with Empower which meets the fully benefit-responsive investment criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contributions are maintained by Empower in a non-participating separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan regardless of the performance or market values of the securities in the separate account.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but is guaranteed to be no less than 1.5%. Such interest rates are reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

**Note 6. Guaranteed Investment Contract (Continued)**

The plan administrator does not believe that any events which would limit the ability of the Plan to transact at contract value with participants are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 7. Transfers From Other Qualified Plans**

The Plan accepts diversification from the Kirkwood Holding Inc. Employees' Stock Ownership Trust and Plan (the "ESOP") made at the direction of employees who have been participants in the ESOP for at least ten years and who have attained age 55. During the years ended December 31, 2024 and 2023, \$409,739 and \$12,887, respectively, were transferred into the Plan under elections made by participants.

**Note 8. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9. Party-in-Interest Transactions**

Certain Plan investments are held in a pooled separate account and a guaranteed investment contract of Empower, Custodian of the Plan. In addition, administrative expenses were paid to Empower or its affiliates from the Plan during the years ended December 31, 2024 and 2023. Therefore, these transactions qualify as party-in-interest transactions.
