Opinion

We have audited the accompanying financial statements of American Limousine, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the American Limousine, LLC 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution retirement plan covering eligible employees of Addison Lee, American Limousine LLC dba RMA Worldwide Chauffeured, TriStar Worldwide, Transportation Technology Services Inc., American Transportation Holdings, ATH Transportation, Tristar Services US, and Tristar Chauffer Management (the "Companies" or "Employers"). Employees, excluding union, nonresident aliens, and leased employees, become eligible to participate in the Plan upon attaining age twenty-one and completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") as amended.

Contributions

Upon completing the eligibility requirements, employees are automatically enrolled into the Plan at a rate of 4% of eligible compensation for pre-tax deferrals unless they affirmatively opt out. Employees may contribute a percentage of their eligible compensation, through payroll deductions made on a pre-tax basis or after-tax basis (Roth). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount. Participants may also contribute amounts representing distributions from other qualified plans.

The Companies make discretionary matching contributions in an amount equal to the lesser of 1% of a participant's eligible compensation or 25% of a participant's contributions, subject to Internal Revenue Service ("IRS") limitations. The Employers may make a discretionary profit sharing contribution to the Plan for participants who have completed one year of service and who are employed on the last day of the year. For the year ended December 31, 2024, no profit sharing contributions were made to the Plan.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Companies discretionary matching and profit sharing contributions is as follows:

Vesting (continued)

Regardless of the vesting schedule, a participant will become fully vested upon death or total and permanent disability.

Participant Accounts

Each participants account is credited with the participant's contributions and allocations of (a) the Companies' contribution and (b) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account. All investments are participant directed.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,657 and \$215. These accounts will be used to pay administrative expenses or reduce future Employer contributions. During 2024, forfeitures of \$2,445 were used to pay administrative expenses and no forfeitures were used to reduce employer contributions.

Payment of Benefits

Upon termination of service due to death, disability, attainment of age 59½, retirement or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at prime rate plus one percentage point. Principal and interest is paid ratably through payroll deductions. The loan must be repaid within a period not to exceed five years from the date the participant receives the loan, unless the loan is for the purchase of the participant's principal residence, in which case the loan may be repaid within a period in excess of five years. A participant may only have one loan outstanding at any time.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will see the investment for an amount different than the reported NAV. The brokerage accounts are self-directed accounts and are valued based on the account's underlying investments held as of the end of the plan year. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded. The brokerage accounts consist of: mutual funds, common stocks and money market funds.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 28, 2025.

Common/Collective Trusts

The Plan invests in 5 common/collective trusts (the "Trusts"). Great Gray Trust Company is the trustee of the Trusts. The NAV for each of these Trusts is determined each business day. Issuances and redemptions of units are transacted at the NAV of the Trusts determined as of the close of business each day. These Trusts have no unfunded commitments at December 31, 2024 and 2023.

4. Party-in-Interest Transactions

Certain investments of the Plan are managed by an affiliate of the Plan's custodian, Fidelity Personal Trust Company. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

5. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Companies contributions.

6. Tax Status

The Plan's prototype plan document preparer has obtained an opinion letter dated November 30, 2020 from the IRS stating that the Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter, however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
