Significant Accounting Estimates and Related Disclosures

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter, which could be significant to the Plan's financial statements or the auditor's report. No such disagreements arose during the course of the audit.

Representations Requested from Management

We have requested certain written representations from management, which are included in a separate letter dated the same as this letter.

Management's Consultations with Other Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters. Management informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

Other Significant Matters, Findings, or Issues

In the normal course of our professional association with the Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, business conditions affecting the Plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.

Other Matters

The ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, were subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

There is a balance in the revenue sharing account that has not been used to reduce employer expenses. We recommend working with Empower to use the credit balance to reduce Hungry Cats, Inc. Profit Sharing/401(k) Plan and Trust expenses.

We noted that hire and termination dates are not being updated timely. Due to this, force-outs are not being caught and removed from the Hungry Cats, Inc. Profit Sharing/401(k) Plan and Trust. We suggest working with your store managers to update participant data more timely. Additionally, please work with Empower to force-out terminated participants with balances under \$5,000.

Management has been unable to reconcile payroll. We recommend that management implement procedures to reconcile payroll records on an annual basis. This should be reviewed to ensure all wages and compensation are accurately reported.

Other Matters (Continued)

Plan compensation is defined as all W-2 wages. We noted two participants who had bonuses excluded from deferrals and match, that should have been included. We recommend making sure all pay codes are correctly defined.

Review of the online authorized users with Empower showed a terminated administrator as an authorized user. This administrator was terminated shortly before the 2024 audit. We recommend working with Empower to remove her immediately. Additionally, a review of authorized users should be done on a regular basis and updated when there is a change in personnel.

Our responsibility also includes communicating to you any information which we believe is a material misstatement of fact. Nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information, or manner of its presentation, appearing in the financial statements.

This report is intended solely for the information and use of the Plan Administrator and Board of Directors, and management of the Plan and is not intended to be and should not be used by anyone other than these specified parties.
