### **Opinion**

#### NOTE A – DESCRIPTION

The following description of the I.B.E.W. Local Union 64 Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- 1.) **General** – The plan is a defined contribution plan as defined in the Employee Retirement Security Act of 1974 (ERISA). Established in 1979, the Plan’s purpose is to provide additional financial security upon retirement, death or termination of service. It is subject to the provisions of ERISA.
- 2.) **Contributions** –The Plan agreement provides that the employers will make monthly contributions to the Plan of a specified amount for each hour worked as determined by the collective bargaining agreement. For inside journeyman, contributions are calculated at 13% from January 1, 2023 through November 28, 2023 and 13.5% from November 29, 2023 through December 31, 2024. For teledata wiremen, the contribution rate was 7% of the employee’s gross wages from January 1, 2023 through December 31, 2024. For residential wiremen, the contribution rate was 10% of the employee’s gross wages from January 1, 2023 through December 31, 2024.
- 3.) **Participant Accounts** – Effective April 1, 2004, the participants began to direct the investment of their contributions into various investment options offered by the Plan. The investment options are a variety of mutual funds and stable value collective trust.
- 4.) **Vesting** – The participant’s interest in their account shall be totally vested upon their completion of thirty (30) days of service or upon the accumulation of \$50.00 in the participant’s account, whichever occurs first, upon the attainment of their normal retirement age, or upon their death or total and permanent disability. If a participant terminates employment before satisfying the vesting requirements, the amount in their account shall be forfeited.
- 5.) **Payment of Benefits** – Upon termination of service, death, total and permanent disability or hardship, a participant may elect to receive either a lump-sum amount equal to the value of his account or annual installments until the credit account is exhausted.

#### NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- 1.) **Basis of Accounting** – The accompanying financial statements have been prepared using the accrual basis of accounting.
- 2.) **Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s trustees determine the Plan’s valuation policies by utilizing the information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as those held during the year.

- 3.) **Payment of Benefits** – Benefits are recorded when paid.
- 4.) **Use of Estimates** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.
- 5.) **Administrative Expenses** – The Plan’s expenses are paid by the Plan as provided by the plan document. Expenses incurred in connection with the general administration of the Plan and investment related expenses that are paid by the Plan are recorded as deductions in the statement of changes in net assets available for benefits.
- 6.) **Subsequent Events** – The Plan has evaluated subsequent events through August 5, 2025, the date the financial statements were available to be issued.

### NOTE C – INVESTMENTS

The plan’s investments are held by a custodial institution.

### NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable or substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market Funds* – Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual Funds* – Valued at the daily closing price reported by the Fund. The funds are open-ended and are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. These funds are deemed to be actively traded.

*Common/ Collective Trusts* – Valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Common/Collective Trust – The common/collective trust invests in various investment contracts with the objective to provide preservation of capital, relatively stable returns consistent with its comparative low risk profile, and liquidity for benefit-responsive payments. The Plan can redeem quarterly from the Trust at the net asset value at the time of redemption.

**NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Trustees have the right under the Plan to discontinue the operations of the Plan and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

**NOTE F – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan assets are invested in funds managed by custodians of the Plan. As described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA.

**NOTE G - TAX STATUS**

The IRS has determined and informed the Plan by a letter dated June 26, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain potion that more likely than not would not be sustained upon examination by the Internal

Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.
