Opinion

We have audited the accompanying financial statements of the McCreary Modern, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of Plan

General

The following description of the McCreary Modern, Inc. (“Company”) Employee Stock Ownership Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

The Plan operates as a stock bonus plan under Section 401(a) and an employee stock ownership plan (“ESOP”) designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (“IRC”) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan primarily invests in the Company’s common stock, which was originally acquired through the issuance of a \$15,450,000 note payable in 2008. However, as the note payable was fully repaid in 2014, all shares were released from collateral and are allocated to participant accounts as of December 31, 2024 and 2023.

Eligibility

To be eligible to participate in the Plan, an employee must have attained the age of 21 and completed one year of service with at least 1,000 hours. Employees may begin participation as of the June 30th or December 31st coinciding with or following the date on which they meet the eligibility requirements.

Contributions

The Plan does not permit participant contributions. The Company may make discretionary contributions to be determined annually by the Board of Directors. The Company made discretionary contributions of approximately \$88,000 and \$81,000 in 2024 and 2023. The Board of Directors may also declare dividends paid to shareholders of the Company’s common stock. Dividends received by the Plan on Company stock were approximately \$7,799,000 and \$7,515,000 for 2024 and 2023. Contributions are subject to certain limits set by the Internal Revenue Service (“IRS”).

Participant Accounts

Participants will be provided accounts in their name called the “Company Stock Account” and “Other Investments Account.”

- The Company Stock Account will be credited annually with their (a) allocable share of company stock purchased and paid for by the Plan or contributed in-kind as an employer contribution, (b) allocable share of forfeitures from other nonvested company stock accounts, and (c) any stock dividends.
- The Other Investments Account will be credited annually with their (a) allocable share of employer cash contributions, (b) allocable share of forfeitures from other nonvested other investments accounts, (c) cash dividends on company stock, and (d) any net income (loss) of the trust. It will also be reduced by any payments made to purchase company stock and for administrative expenses.

Account allocations are based on participant compensation, account balances, and/or specific transactions as defined. Participants who have not completed at least 1,000 hours of service during such plan year or are not employed on the last working day of a plan year are generally not eligible for an allocation of Company contributions or forfeitures for such year. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of Plan (Concluded)

Company Stock and Voting Rights

The Company has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, present separately the assets and liabilities and changes therein pertaining to:

- (a) the accounts of employees with vested rights in allocated stock (“allocated”)
- (b) stock not yet allocated to employees (“unallocated”), if any

All Company stock held in the trust shall generally be voted by the trustee. However, with respect to any matter which requires a shareholder vote regarding corporate mergers, consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all of the corporate assets or other similar matters, each participant shall be entitled to exercise voting rights attributable to the shares allocated to his or her account and will be notified by the trustee prior to the time that such rights are to be exercised.

Vesting

Participants vest in their accounts based on years of continuous service according to the following schedule:

Forfeitures

Forfeited balances are reallocated to the remaining eligible participants on the same basis as Company contributions. In 2024 and 2023, forfeitures of approximately \$23,000 and \$21,000 were reallocated within the Plan.

Benefit Payments

Upon termination of service due to death, disability, retirement, or separation, a participant will generally receive a lump-sum payment or annual installment payments of up to five years, at the discretion of the Company. Distributions will generally occur as soon as feasible in the year following the distributable event.

Diversification

Participants who have satisfied certain age and participation requirements are eligible to diversify a percentage of their account balance as defined by the Plan. A participant may also elect to roll the balance into the McCreary Modern, Inc. Employees’ 401(k) Plan if actively participating in that plan. Benefits paid to participants include diversifications into the McCreary Modern, Inc. Employees’ 401(k) Plan of approximately \$1,947,000 and \$1,598,000 during 2024 and 2023.

Administrative Expenses

The plan sponsor absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Other fees, including those for recordkeeping, valuation, and audit services, are paid by the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. The common stock of the Company is valued at estimated fair market value as determined by an annual independent appraisal. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through September 30, 2025, the date that the financial statements were available to be issued, and has determined no events have occurred that require adjustments to or additional disclosure in the financial statements.

4. Risks and Uncertainties

The Plan invests primarily in McCreary Modern, Inc. common stock, which is exposed to various market risks, such as interest rate, market, and credit risks. Due to the level of risk associated with the common stock, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the participants' accounts and the amounts reported in the statements of net assets available for benefits.

The Plan also deposits cash in financial institutions. Balances at times may exceed federally insured limits. To mitigate credit risk, the Company places its cash with high credit quality financial institutions.

5. Income Tax Status

The IRS has determined and informed the Company by a letter dated August 8, 2013, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC. Therefore, no provision for income taxes has been recorded in the Plan's financial statements.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to provisions of the Plan and ERISA. Upon such termination of the Plan, the interest of each participant will be distributed as prescribed by plan provisions and the IRC.

7. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

Basis of Fair Value Measurement

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no material changes in the methodologies used at December 31, 2024 and 2023.

Common stock: The value of the McCreary Modern, Inc. common stock held by the Plan is valued at estimated fair value based upon an independent appraisal and is classified within Level 3 of the valuation hierarchy. Consistent with the prior year, the valuation was based upon a weighting of two widely-accepted valuation approaches: market approach and income approach. The valuation methods were also applied on a debt-free basis and include a 5% discount for lack of control and marketability at December 31, 2024 and 2023.

Plan management accumulates the data for the appraiser from the financial statements of the Company. The appraiser prepares a preliminary report which plan management, along with the ESOP trustee, reviews in detail, discusses, and approves.

Money market and deposit accounts: Money market and deposit accounts are carried at cost plus accumulated interest and are classified within Level 1 of the valuation hierarchy.
