## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of the UEI Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of UEI Group, Inc. and its wholly owned subsidiaries (collectively, the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Eligibility**

All employees of the Company, other than those subject to a collective bargaining agreement or leased employees, are immediately eligible for participation in the Plan, and may elect to participate in the Plan on the first day of the month immediately following the employee's employment commencement date.

#### **Contributions**

Eligible employees may contribute up to 80% of annual eligible pre-tax compensation, not to exceed certain Internal Revenue Service (IRS) limits, to the Plan. Participants can also elect to make Roth 401(k) contributions of after-tax compensation. Participants age 50 and older may also contribute amounts representing catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (participant rollover contributions).

The Plan allows discretionary Company matching contributions. Discretionary Company matching contributions of 25% of the participant deferrals, not to exceed 5% of eligible compensation, were made in 2024 and 2023 for participants employed on the last day of the Plan year and working at least 1,000 hours during the Plan year. The Company may also make discretionary nonelective contributions to the Plan. There were no discretionary nonelective contributions made in 2024 or 2023. The total of the annual participant and Company contributions on behalf of each participant cannot exceed certain IRS limitations.

### Notes To Financial Statements (*Continued*)

A participant may direct contributions to any of the investment options offered by the Plan. Contribution allocation changes and fund transfers can be done daily; however, elective deferral contribution amounts can only be changed the first day of each pay period. Each participant's directed account is credited/charged with an allocation of the directed investment's earnings/losses and credited with the following contributions:

- Participant's elective deferral contributions;
- Participant's rollover contributions;
- Discretionary Company matching contributions; and
- Discretionary Company nonelective contributions (allocated to participants based on their eligible compensation)

#### **Payment Of Benefits**

Upon a participant's death, retirement or termination of service, the participant becomes eligible to receive distributions. If a participant's vested account balance is greater than \$5,000, the participant may elect to receive a lump sum distribution as soon as administratively feasible or may postpone distribution until the required beginning date, as defined by the Plan Agreement. If a participant's vested account balance does not exceed \$1,000, a lump sum payment is automatically made as soon as administratively feasible. Under terms of the Plan, normal retirement age is 62.

In-service distributions may be made to a participant who has not separated from service provided the participant has attained the age of 59½.

#### **Hardship Withdrawals**

The Plan provides for hardship withdrawals, as set forth in accordance with applicable sections of the Internal Revenue Code (the Code), not to exceed the total of the participant's actual contributions to the Plan, which must result from an immediate financial need of the participant as determined on a nondiscriminatory basis by the Plan Administrator.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years except notes for the purchase of a primary residence may be for up to 15 years. The notes are secured by the balance in the participant's account. The interest rate charged on notes receivable from participants shall be a reasonable rate of interest based on prevailing interest rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

#### **Vesting And Forfeitures**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company contributions, plus earnings thereon, is based on years of service as follows:

Forfeited nonvested Company matching contributions are used to reduce Company contributions to the Plan. For the years ended December 31, 2024 and 2023, forfeitures of \$4,850 and \$6,434, respectively, were used to offset Company contributions. At December 31, 2024 and 2023, forfeited nonvested amounts were \$6,585 and \$11,914, respectively.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net change in fair value of investments.

## **2. Summary Of Significant Accounting Policies**

### **Basis Of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

### **Use Of Estimates**

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States. Those estimates and assumptions affect the reported amounts of assets and liabilities, and changes therein, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could vary from those estimates.

### **Investment Valuation And Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on the trade-date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments includes gains and losses on investments bought and sold as well as investments held during the year.

### **Payment Of Benefits**

Benefit payments to participants are recorded when paid.

### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the Plan Agreement. Notes receivable from participants are secured by participants' vested account balances.

#### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at either December 31, 2024 or 2023.

#### **Subsequent Events**

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

### **3. Certified Investment Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule of assets held at end of year, that was prepared by or derived from information certified by Fidelity Management Trust Company (Fidelity), and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Fidelity that the information provided to the Plan Administrator related to the following information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule of assets held at end of year related to the following assets as of December 31:

#### 4. Fair Value Measurements

The Plan utilizes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2      Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies and inputs used for assets measured at fair value:

#### **Mutual Funds**

Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

#### **Self-Directed Brokerage Accounts**

Self-directed brokerage accounts are comprised of mutual funds, common stocks and money market mutual funds. Common stocks are valued at the closing price reported on the active market on which the individual securities are traded.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

## 5. Tax Status

The Plan has adopted a pre-approved plan document sponsored by FMR, LLC. FMR, LLC received an opinion letter from the IRS dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax exempt as of the financial statement date. As such, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants become 100% vested in their accounts.

### 7. Party In Interest Transactions

Plan investments consist of certain investments managed by Fidelity. In addition, certain participants in the Plan have outstanding loans with the Plan as of December 31, 2024 and 2023.

These transactions qualify as party in interest transactions allowable under ERISA.

### 8. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
