1. Description of Plan

The following description of the Network for Teaching Entrepreneurship 403(b) Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by the Network for Teaching Entrepreneurship (the “Company”) as of July 1, 1993 covering all eligible employees who have attained the age of 18. Eligible participants can make elective deferrals beginning on their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Massachusetts Mutual Life Insurance (“MassMutual”) and AXA Equitable Life Insurance Company (“AXA”) are the recordkeepers of the Plan. Assets of the Plan are held by AXA Empower Retirement, LLC (“Empower”).

Contributions

The Company makes a discretionary matching employer contribution on behalf of each eligible participant in an amount equal to one-half of the participant’s contribution percentage up to 6% of the participant’s eligible compensation on a per payroll basis. Participants are eligible for the Plan’s matching contributions after completing at least 1,000 hours of service with the Company during the year.

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans, subject to limitations defined in the Plan agreement. Any rollover amount into the Plan is fully vested and non-forfeitable. Contributions are subject to certain limitations as permitted under the Internal Revenue Code.

Investment Options

All of the Plan’s investment options are fully participant directed. Participants may direct the investment of their account balances into any of the Plan’s available investment options.

Participant Accounts

The Plan maintains individual accounts for each Plan participant. Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions and an allocation of the Plan’s investment earnings and losses and charged for benefits paid and certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. These loans are secured by the balance in the participant's account, require approval of the Plan administrator, and bear interest equal to the prime rate plus 1% at the time of loan origination.

Loan payments are made through payroll deductions in equal installments over a period that may not exceed thirty years for the purchase of primary residence and five years for other loans, from the date the loan was made. The maximum number of loans a participant can have at one time is four.

Forfeited Accounts

If a participant leaves the Company before becoming fully vested, any nonvested employer contributions, if any, and investment earning thereon are forfeited. These forfeitures are used to either reduce subsequent employer matching contributions to the Plan or reduce reasonable expenses for administering the Plan. The balance in the forfeitures account as of December 31, 2024 and 2023 was \$3,974 and \$3,302, respectively.

Vesting

Participants become vested in the Company's contributions as follows:

Payment of Benefits

The payment of benefits can be made upon severance from employment, disability, or death, as defined by the Plan. For termination of services for other reasons, a participant may receive the value of the vested interest in his/her account as a lump-sum distribution.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Retirement Committee determines the Plan’s valuation policies utilizing information provided by investment advisors, custodians, and insurance companies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent Events

Plan management has reviewed subsequent events and transactions that occurred after December 31, 2024 through the date of the independent auditors' report and the date the financial statements were available to be issued, September 30, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles. Management has determined that there are no non-recognized subsequent events that require additional disclosure.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts:* Valued at their accumulation unit value (“AUV”) which approximates fair value. The AUV is determined daily based on the net asset value of shares of the underlying fund, the fund’s dividends and the separate account charges (i.e., the daily asset charge). The Plan’s investments in the pooled separate accounts may be redeemed daily. There are no redemption fees or notice periods and no unfunded commitments.

*Guaranteed interest option (“GIO”):* The value of the GIO is reported at contract value which approximates fair value. Fair value equals accumulated cash contributions and interest credited to the Plan’s contract, less any withdrawals and applicable fees. The GIO is not deemed to be a fully benefit-responsive contract.

5. Exempt Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by MassMutual, AXA, and Empower. AXA and Empower are the Trustees as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

6. QNEC Contribution

It was determined that the incorrect breakout of Roth and Pre-tax elections were used for one participant during 2023. In order to properly correct this matter, the Plan has entered the self-correction program. In 2023, the Plan Sponsor made a qualified non-elective contribution in the amount of \$3,128 to correct this error.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts.

8. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

As of the date of the financial statements, the Plan was not required to have a favorable determination letter from the Internal Revenue Service to confirm its tax-exempt status. However, in the opinion of the Plan's administrator, the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statement of net assets available for benefits.
