INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of the Guidewire Software Retirement Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

Notes to Financial Statements

1. Description of the Plan

Guidewire Software (the Company) established the Guidewire Software Retirement Trust (the Plan), effective January 1, 2002, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. A Retirement Administrative Committee, consisting of Company employees, helps administer the Plan and is responsible for selecting investment options offered under the Plan and monitoring investment performance. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and record keeper. Fidelity holds, invests, and reinvests Plan assets in the interest of and at the direction of the participants and their beneficiaries. The Company has engaged NEPC, LLC as an investment advisor. NEPC, LLC assists the Plan Committee in selecting investment options offered under the Plan and monitoring investment performance.

Eligible Participants:

Eligible employees, as defined by the Plan agreement, may participate in the Plan on their first day of employment.

Contributions:

Participants are permitted to make voluntary pre-tax salary deferrals, Roth post-tax, and after-tax contributions of up to 60% of eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 can elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers), subject to Code regulations.

The Plan provides for automatic enrollment on the date participants become eligible for the Plan. The automatic election for eligible participants is 6% of compensation, unless the participants request a different amount to be contributed or formally decline to participate. Participants may adjust their salary deferral rate or discontinue their contributions at any time.

1. Description of the Plan (continued)

Contributions: (continued)

The Company may make discretionary matching and non-elective contributions to the Plan, as determined by the Company's Board of Directors. In 2024, the Company made a matching contribution equal to 50% of each participant's contribution up to 8% of the participant's eligible compensation, not to exceed \$5,000 for each participant. For matching contributions, the Plan requires an annual true-up so the aggregate matching contributions made during any given Plan year reflects an amount equal to the matching contributions had they been computed based on participant year-to-date eligible compensation contributed to the Plan. The Company made matching contributions of \$7,610,468 in 2024, of which \$185,203 related to the true-up contribution that was receivable as of December 31, 2024. The Company remitted the true-up amount to the Plan in March 2025.

Contributions are subject to certain limitations under the Code.

In-Plan Roth Conversions:

The Plan allows participants who are active employees of the Company to convert their non-Roth contributions to Roth contributions. In 2024, contributions of \$2,197,165 were converted to Roth balances.

Participant Accounts:

Participant accounts are credited with participant contributions and rollovers, an allocation of Company contributions, plus earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting:

Participants are fully vested (100%) in their participant accounts.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

1. Description of the Plan (continued)

Notes Receivable from Participants: (continued)

Participants may borrow up to one-half of their account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a longer term may be granted. Participants may only have one note outstanding at a time. Participant notes are evidenced by a written note, secured by the balance in the participant's account, and bear interest at a rate that is commensurate with local prevailing rates, as determined by the Plan administrator under the note policy. The interest rates on the notes outstanding as of December 31, 2024 ranged from 4.25% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Payment of Benefits:

Upon termination of service, participants may elect to leave their balance in the Plan or receive their benefits in a lump sum amount equal to the balance of their accounts or in partial withdrawals. Accounts with balances between \$1,000 and \$7,000 may be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Accounts with a balance of \$1,000 or less may be distributed directly to participants without participant approval. The Plan agreement also allows for certain in-service and hardship distributions to current employees. Benefits are recorded when paid.

Administrative Expenses:

Plan investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. The Company elected an unbundled fee structure in which investment fees are separated from the investment performance and separately invoiced to the Plan for payment through the Plan or directly by the Company. Participants are also charged other administrative fees and assessed a separate fee for the initiation and administration of notes.

The Company participates in a revenue credit program offered by Fidelity. Under this program, a plan is eligible to receive a fixed annual credit based on Fidelity's revenue target for the Plan and on certain plan characteristics. The revenue credit is allocated quarterly into a plan-level suspense account, which can be used to reimburse administrative expenses paid to Fidelity or other third-party providers. At the Plan sponsor's discretion, unused credits can be allocated ratably to participant accounts or used to offset future plan expenses. The amount of the revenue credit the Plan received in 2024 was not material to the financial statements.

Administrative Expenses: (continued)

All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the financial statements.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would remain fully vested in their accounts and distributions would be made to participants, as described in the Plan agreement.

2. Summary of Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Income Recognition:

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on Plan investments bought, sold or held during the year.

Investments:

The Plan's investments consisting of mutual funds and common/collective trusts, are accounted for as follows:

Mutual Funds: These funds are valued at fair value using the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

Common/collective trusts (CCTs): Except for the T. Rowe Price Stable Value Common Trust Fund (the Fund) discussed below, the CCTs are reported at fair value, as determined based on the fair value of the fixed income securities in each trust's portfolio, which is typically the amount reasonably expected to be received upon the sale of an investment. The Plan has no unfunded CCTs and investments are redeemable daily.

Units held in the Fund are valued using the NAV practical expedient for determining fair value, as valued by the Fund manager. The NAV practical expedient is based on the fair value of the underlying assets owned by the Fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of the Fund is calculated based on the compilation of primarily observable market information.

The Fund is a common collective trust and stable value fund that is composed primarily of fully benefit-responsive investment contracts and valued using the NAV practical expedient. The NAV practical expedient would not be used if it is determined to be probable the Plan will sell its investments for an amount different from their reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the Fund, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure the investments liquidated will be carried out in an orderly business manner. The Plan has no unfunded commitments with the Fund.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds and CCTs, other than the Fund, are recorded at fair value and are classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023. The Fund, valued using the NAV practical expedient, is excluded from the fair value hierarchy under GAAP.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.

- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-In-Interest Transactions

Plan investments include investments managed by Fidelity. As Fidelity is the Plan's trustee, purchases and sales of these investments by the Plan qualify as party-in-interest transactions. Notes receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
