We have performed the audits of the financial statements of Grant & Eisenhofer, P.A. 401(k) Profit Sharing Plan and Trust ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### NOTES TO FINANCIAL STATEMENTS

#### (1) Description of plan

The following description of Grant & Eisenhofer, P.A. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan is a defined contribution plan covering all employees of Grant & Eisenhofer, P.A. (the "Company" or "plan sponsor") who are twenty-one years of age and complete three months of service. The Plan excludes union employees and nonresident aliens. Participants are eligible to participate upon completing three months of service. For discretionary contributions, participants are eligible after completing one year of service, which is generally defined as 1,000 hours of service, whether or not terminated. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Employees who are eligible to participate in the Plan may elect to defer, through payroll deductions, a portion of their compensation up to the maximum dollar amount allowable by law through pre-tax or Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollover"). Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan.

The Company is required to make matching contributions to the Plan, equal to 50% of the lesser of: (1) the participant's contribution or (2) 6% of the participant's compensation, as defined. In addition, the Company may make a discretionary profit sharing contribution, which is decided annually and allocated in proportion to the compensation of those participants eligible to share in the allocations. The Company did not make a discretionary profit sharing contribution for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant investment account options** - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts, fixed interest accounts, and a collective investment trust as investment options for participants.

**Participant accounts** - Each participant's account is credited with the participant's contribution and an allocation of: (a) the Company's contribution, (b) the Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts. Allocations are based upon compensation, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of participants' accounts is based on years of service. Employer contributions are subject to the following vesting schedule:

#### (1) Description of plan (continued)

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates, as determined by the plan administrator. Repayment terms, which are determined by the Plan document, cannot exceed five years unless loan proceeds are used to acquire the participant's principal residence. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits** - On termination of service due to death, disability, retirement, or other reason, a participant or his or her beneficiary(ies) will receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Distributions are to be made as soon as administratively possible upon termination.

**Forfeited accounts** - Forfeited accounts are allocated to each participant's account based upon the relation of the participant's employer contribution to total employer contributions for the Plan year. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$171,098 and \$75,660, respectively. During the year ended December 31, 2024, there were \$75,660 in forfeitures allocated to participant accounts.

#### (2) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method of accounting.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value (except for the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the note receivable balance is reduced, and a benefit payment is recorded.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in the fair value of investments.

(3) **Information prepared and certified by the custodian**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Retirement Insurance and Annuity Company ("Voya"), the recordkeeper and custodian of the Plan.

(4) **Fair value measurements**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification Topic 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under this topic are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value (“NAV”) of units of the separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities’ liquidations will be carried out in an orderly business manner.

Collective Investment Trust: The Voya Large Cap Growth Fund - Class 8 CIT and Voya Mid-Cap Growth Equity Fund - Class 8 CIT are valued at the NAV of units of the collective investment trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There are no unfunded commitments related to these investments.
