MG Electric Inc. is in the process of engaging an independent auditor to perform the required ERISA plan audit for the 2024 plan year. Due to the need for this audit to cover multiple plan years, additional time and coordination are required to ensure accuracy and compliance with all reporting requirements.

The expanded scope of this review has resulted in delays to the audit completion; however, we are actively working with our selected auditor and expect to have the audit finalized in the coming weeks. Once completed, the final audit report will be submitted promptly to Beneco/FuturePlan to be attached to the Form 5500 filing.

Please accept this statement as a placeholder in lieu of the completed audit for the purpose of timely filing the Form 5500 by the October 15, 2025 deadline.
