**NOTE 1 DESCRIPTION OF PLAN**

The following description of the X-Ray Associates of New Mexico, P.C. (the Company, Employer, Plan administrator or Plan Sponsor) 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a Vanguard prototype nonstandardized tax-deferred retirement plan covering employees of the Company who have completed one year of service requiring 1,000 hours and are age 18 or older. The Plan is established for the benefit of employees of X-Ray Associates of New Mexico, P.C. The Plan was originally established and became effective on July 1, 1994. The Plan has been amended in prior years to comply with applicable regulatory requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

**Contributions**

The Plan uses a cross testing method to determine certain allocations of contributions to participants, as permitted by the Internal Revenue Code (IRC). For 2024, physicians and executive employees received profit sharing contributions at a rate determined on an individual basis, as allowed by the Plan. The nonphysician and nonexecutive class of employees received a profit sharing contribution of 3.61% of eligible compensation for 2024. All eligible participants receive a 3% nonelective safe harbor contribution in addition to any profit sharing contributions which are 100% vested at the date of contribution. A participant must be an eligible participant for purposes of sharing in the allocation of profit sharing and safe harbor contributions. The total safe harbor contributions were \$601,457 for the year ended December 31, 2024. The total profit sharing contribution was \$1,386,230 for the year ended December 31, 2024. Matching contributions are allowed on both pre-tax and Roth elective deferrals on a discretionary basis. No matching contributions were made in 2024.

The Plan also provides for participant contributions pursuant to a tax-deferred savings agreement and Roth contributions that are not tax-deferred. These participant contributions are subject to certain Internal Revenue Service (IRS) annual limitations.

In no event shall the aggregate of the Employer's matching contributions, profit sharing contributions, and safe harbor contributions exceed the amount allowable as a deduction by the Employer for federal income tax purposes.

Rollover contributions totaled \$225,783 for the year ended December 31, 2024.

**Investment Options**

Upon enrollment in the Plan, participants may invest all participant and Employer contributions in money market accounts, in a common/collective trust, or in any of several mutual funds managed by The Vanguard Group (including amounts held in a self-directed brokerage account). All investments are participant-directed.

**Participant Accounts**

Each participant's account is credited or charged with the participant's deferred or Roth contribution, the Employer's contributions, Plan earnings and expenses, and any applicable rollover contributions. Allocations of Employer contributions are based on the participants' compensation or on participants' voluntary contributions, as defined by the Plan document. Participants' accounts are credited with earnings and are charged with expenses based on the respective investments in each individual participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The note receivable is secured by the balance in the participant's account and bears interest at a rate commensurate with prevailing rates. Principal and interest is paid ratably through payroll deductions.

**Vesting**

Participants are immediately vested in their voluntary contributions and Employer safe harbor contributions, plus actual earnings thereon. Vesting in the Employer's matching and profit sharing contributions plus actual earnings thereon is based on years of service. The Plan provides for 20% vesting after two years of service and increases at a rate of 20% per year until 100% vesting after six years of service.

**Payment of Benefits**

Upon termination of service for any reason, vested benefits may be distributed in lump-sum or partial payments. Participants with vested balances of \$7,000 or more upon termination will receive distribution of their accrued benefit upon submission of a claim for distribution.

**Forfeitures**

Forfeited accounts totaled \$82,536 and \$47,888 for the years ended December 31, 2024 and 2023, respectively; \$63,350 was used to pay administrative expenses of the Plan for the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

**Basis of Presentation**

The financial statements are prepared using the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Valuation of Investments and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 6 for discussion of fair value measurements.

In accordance with valuing investments at fair value, the net unrealized appreciation or depreciation for the year is presented in the statement of changes in net assets available for benefits. Purchases and sales of securities are recorded on a trade-date basis, dividends are recorded on the ex-dividend date, and interest is recorded on an accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable are recorded at their net unpaid principal balances plus any accrued but unpaid interest and are considered to be fully collectible. Accordingly, no allowance for credit losses is recorded. If missed loan payments are not made by the end of the "cure period" (as defined in the Plan document), the loan is in default and will be treated as a deemed distribution. Interest income on notes receivable from participants is recognized when earned.

**Contributions**

Contributions from participants and Employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan permits, but does not require, the Plan Sponsor to pay costs of Plan administration. The Plan's administrative expenses consist primarily of investment management services, costs to administer the Plan, and the cost of the Plan's annual audit. The total expenses paid by the Plan for testing, administration, and recordkeeping were \$71,650 for the year ended December 31, 2024.

The Plan Sponsor also provides certain accounting and administrative services to the Plan for which no fees are paid. Amounts paid by the Plan Sponsor are excluded from these accompanying financial statements.

**Subsequent Events**

Subsequent events have been evaluated through October 1, 2025, the date the financial statements were available to be issued. The Plan administrator believes there are no significant events occurring subsequent to December 31, 2024, that would require adjustment to or disclosure in the financial statements.

**NOTE 3 TAX STATUS**

The Plan is placing reliance on an opinion letter from the IRS on the prototype plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 4 RELATED PARTY TRANSACTIONS**

Fees paid by the Plan for investment management and related services were \$56,300 for the year ended December 31, 2024.

**NOTE 5 INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). Vanguard Fiduciary Trust Company has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment and note receivable information reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 6 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 6 FAIR VALUE MEASUREMENTS (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market and Mutual Funds:* valued at the quoted net asset value (NAV) of shares based on published prices held by the Plan at year-end.

*Common/Collective Trust:* valued at the net asset value (NAV) of units of the bank collective trust. NAV is readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Common Stock:* valued at the closing price reported on the active market on which the individual securities are traded.

*Self-Directed Brokerage Account:* Primarily consists of mutual funds and common stock valued as described above.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed intent to do so, the Company may terminate the Plan for any reason, at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan utilizes various investment instruments. Investment securities, in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
