INDEPENDENT AUDITORS' REPORT

**To the Plan Administrator of
Tuftco Corporation 401(k) Plan**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Tuftco Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Tuftco Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Tuftco Corporation 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Change in Valuation Method of Investment

As discussed in Note 8 to the financial statements, during the year ended December 31, 2024, the Plan changed its method of valuing its investment in a common collective trust from contract value to net asset value (NAV) as a practical expedient for fair value. The effect of this change on the prior period financial statements is not material. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tuftco Corporation 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial

statements themselves, and other additional procedures in accordance with auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) DESCRIPTION OF PLAN

The following description of the Tuftco Corporation 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan which was adopted January 10, 1990, to provide retirement benefits for employees of Trade Finance International, Inc. (the “Plan Sponsor”) and the following adopting employers:

Tuftco Corporation	TuftcoSoft, Inc.	Technituft, Inc.
Tuftco Finishing Systems, Inc.	Mitchell Industrial Tire, Inc.	Tuftco-Dalton, Inc.
Tuftco International, Inc.	Tuftco Technologies, Inc.	

Adopting employers are wholly-owned subsidiaries of Trade Finance International, Inc. The Plan covers substantially all full-time employees who are age twenty-one or older and have completed three months of service (“participants”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute 1 - 100% of compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also provides that the Plan Sponsor may contribute each year an amount authorized by the Plan Sponsor’s ownership; however, an annual contribution by the Plan Sponsor is not required. There was no discretionary contribution by the Plan Sponsor for 2024. Contributions are subject to certain statutory limitations.

Participant accounts

Each participant’s account is credited or charged with the participant’s contribution and allocations of Plan Sponsor contributions, investment earnings and losses, and administrative expenses. Allocations are based on a participant’s earnings or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Participants direct the investment of the accounts into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund held in a common collective trust as options.

Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings and losses thereon. Vesting in the Plan Sponsor’s contributions is based on years of continuous service. Participants become 20% vested after two years and vest ratably in 20% increments until they become 100% vested after six years of service.

Payment of benefits

Upon a participant's termination of service due to death, permanent disability, or retirement, a participant may elect to receive a lump-sum distribution or annual installments over a specified period equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution.

Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures reduce the Plan Sponsor's contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$60 and \$51 respectively.

Administrative fee credit account

The Plan carries an administrative fee credit account used to cover plan costs. Administrative fees are collected from the Plan's investments and maintained in this account to pay recordkeeping and administrative fees. There were \$10,948 of fees paid from the account during the year and net earnings of \$11,178. The balance of unused funds in this account as of December 31, 2024 was \$231.

Administrative expenses

Personnel within the plan sponsor's participating employers perform various administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as Plan expenses. Other than fees reported as administrative expenses in the statement of changes in net assets available for benefits, all other significant administrative expenses of the Plan are paid by the plan sponsor's participating employers.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) CERTIFIED INVESTMENTS AND INVESTMENT INCOME

The Plan has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company and Newport Trust Company, LLC has certified that the following information, as well as the investment information in the notes to the financial statements and information included in the Schedule of Assets (Held at End of Year) as of and for the years ended December 31, 2024 and 2023, are complete and accurate.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(4) FAIR VALUE

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 assets are valued using quoted prices in active markets for identical investments. Level 2 assets are valued using inputs other than quoted prices. Level 2 inputs are observable, either directly or indirectly for the asset or liability through correlation with market data at the measurement date and for the duration of the instrument's anticipated life. Level 3 inputs are unobservable for the investment, indicating that the inputs reflect the entity's own assumption used in pricing an investment based on the best information available.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

The Plan uses the following methods and assumptions in estimating the fair values of the Plan's financial instruments:

Mutual Funds

The fair value of mutual funds is based on the net asset values (NAV) of shares held by the plan at year end. The NAV is based on the value of the underlying assets owned by the fund minus its liabilities, divided by the number of shares outstanding. The NAV is a quoted price in an active market and is classified at Level 1.

Common Collective Trust

The Morley Stable Value Fund is a common collective trust and is valued using its NAV as a practical expedient to fair value. This investment does not have a readily determinable fair value. The NAV is provided by the investment manager and is reviewed by management, taking into consideration the fund's investment strategy, underlying investments, and restrictions on redemptions. The common collective trust is presented at the bottom of the table as a reconciling item to total investments on the statements of net assets available for benefits.

(5) INCOME TAX STATUS

The Plan Sponsor adopted a prototype plan, which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, stating that the Plan was in accordance with the applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(6) PARTY IN INTEREST TRANSACTIONS

Ascensus Trust Company is the trustee of the Plan and, therefore, administrative fees paid to them qualify as party-in-interest transactions. The Plan made a direct payment to outside parties of \$12,448 which includes \$10,948 covered by revenue sharing out of the administrative fee credit account. The plan sponsor pays directly any other fees related to the Plan’s operations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(7) RISKS AND UNCERTAINTIES

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

(8) RECLASSIFICATION

In prior years, the Plan’s investment in the Morley Stable Value Fund (the “Fund”) was presented at contract value, which represented the amount participants would have received if they had initiated permitted transactions under the terms of the contract.

(8) RECLASSIFICATION (continued)

During the year ended December 31, 2024, the Plan changed the presentation of this investment to reflect its fair value, measured at net asset value (NAV) as a practical expedient, in accordance with Accounting Standards Codification (ASC) Topic 820, Fair Value Measurement.

The change in presentation was applied retrospectively, and the prior-year financial statements have been restated to reflect this investment at NAV as a practical expedient to fair value rather than contract value. The restatement resulted in a reclassification within investments and did not affect the total net assets available for benefits or the changes therein for any period presented.

(9) SUBSEQUENT EVENTS

In preparing these financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 8, 2025, the date which these financial statements were available for issue.
