Note 1. Description of the Plan

The following description of the Vera Bradley Designs, Inc. Profit Sharing 401(k) Plan (Plan) provides only general information. Vera Bradley Designs, Inc. is the Plan Sponsor. Participants should refer to the *Summary Plan Description* and Plan Agreement for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan covering substantially all employees of Vera Bradley Designs, Inc. and Vera Bradley Sales, LLC and subsidiaries of Vera Bradley, Inc. (collectively, the Company) who are 21 years of age or older and have at least one year of service. The Plan was adopted under the provisions of Internal Revenue Code (Code) section 401(a), with cash or deferred arrangement qualified under Code Section 401(k). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Matrix Trust Company is the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to make contributions of up to 100% of eligible compensation. Employee rollover contributions and "catch-up" elective deferral contributions are also permitted. The Company makes safe-harbor basic matching contributions for each employee participating in the Plan. This contribution equals 100% of the first 4% of eligible participant compensation contributed to the Plan plus 50% of the next 2% of eligible participant compensation contributed to the Plan. The Company may elect to make a matching contribution based on a percentage of the participant deferral for all participants who have completed one year of service during the Plan year. No discretionary Company matching contributions were made to the Plan for the years ended December 31, 2024 and 2023. In addition, the Company may, at its discretion, make a profit sharing contribution to the Plan. No discretionary profit sharing amounts were contributed to the Plan for the years ended December 31, 2024 and 2023.

Participant Investment Account Options

Participant investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, as well as any safe-harbor basic matching contributions, plus earnings thereon. Employer matching and profit sharing contributions plus earnings thereon is based on years of continuous service. A participant is fully vested in employer matching contributions after six years and profit sharing contribution after three years of continuous service. The nonvested balance is forfeited upon termination of service. Forfeitures are used to reduce the employer matching contribution. Forfeitures are then used to reinstate participant accounts for rehired employees who had not had a break in service exceeding five years. Remaining forfeitures may be used to reduce Company contributions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts available for use totaled \$0 and \$1,001, respectively. During 2024 and 2023, nonvested forfeitures of \$12,100 and \$14,002, respectively, were used to pay administrative expenses or reduce Company matching contributions.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance, whichever is less. All loans are covered by promissory notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence). Interest on loans is based on local prevailing rates determined by the Plan Administrator.

Payment of Benefits

Upon termination of service, employees may elect to receive a lump-sum amount equal to the vested value of their account. At December 31, 2024 and 2023, there were no Plan assets allocated to accounts of terminated or retired participants who have elected to withdraw from the Plan but have not yet been paid.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Revenue Sharing

At times, mutual fund companies make payments to selling agents and such amounts increase the net assets of the Plan. Administrative and other expenses of the Plan are paid from this revenue sharing arrangement. Payments received from selling agents were \$1,645 and \$1,940 for the Plan years ended December 31, 2024 and 2023, respectively, and are reported in net realized and unrealized appreciation (depreciation) in fair value of investments in the statements of changes in net assets available for benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, are used to value investments. The Plan's interest in mutual funds is valued at the market quoted net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective trust fund is valued at the NAV provided by the administrator of the funds. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding. The NAV's unit price is quoted by the administrator of the funds and the market is not active.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan operates under a standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust sponsored by Alliance Benefit Group of Indiana. This prototype plan document has been filed with the appropriate agency and has obtained a determination letter from the Internal Revenue Service stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date. The Plan has not requested or obtained a determination letter.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

During the Plan year ended December 31, 2024, the Plan received deposits for a pay period ending in 2025. The deposits are recorded as a contributions received in advance liability of \$199,407 at December 31, 2024.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification by Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan invests in certain funds of the trustees. The Company provides certain accounting, recordkeeping and administrative services to the Plan for which it receives no compensation. The Plan paid \$233,460 and \$205,007 of administrative and management fees to the record keeper, investment advisors, and trustees during 2024 and 2023, respectively.

Note 5. Disclosure About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. Level 1 investments includes the money market account and mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan has no Level 2 or Level 3 investments.

Effective June 1, 2025, the Plan was amended and restated for recordkeeping services to be converted to the nonstandardized adoption agreement in connection with a 401(k) profit sharing plan document sponsored by Ascensus, LLC.
