INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fisher & Arnold, Inc. 401(k) Profit Sharing Retirement Plan (The Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note J to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024

Note A - Description of Plan

The following description of the Fisher & Arnold, Inc. 401(k) Profit Sharing Retirement Plan (the Plan), established by Fisher & Arnold, Inc. (the Company), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees of the Company who have one month of service and are age twenty-one or older. The Plan was adopted and effective on October 1, 1986. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Participants may make elective contributions to the Plan. The Company may make matching contributions at an amount to be determined by the Company. Forfeitures of terminated participants' non-vested accounts reduce the future matching contributions by the employer. The assets of the Plan, derived from both employee and employer contributions, are allocated to the various funds at the direction of the participant. The Plan currently offers several pooled separate accounts as investment options for participants. The combined contributions may be made up to the maximum percentage allowable, not to exceed the limits of IRC Sections 401(k), 404 and 415. During the year ended December 31, 2024, the Company contributed an amount equal to the greater of 100% of the employee's contribution up to \$2,000 or 3% of employee's deferral.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Payment of Benefits - On termination of service, a participant will receive a lump-sum amount equal to the vested value of his or her account.

Vesting - Participants are fully vested in their employee contributions plus actual earnings thereon. Vesting in the Company contributions and earnings thereon is based on years of service and is determined as follows:

Participant Loans - Participants may borrow from their fund accounts up to a maximum amount equal to 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a commercially reasonable rate of interest, currently between 4.25% and 9.50%, which is commensurate with local prevailing rates as determined by the plan administrator.

NOTES CONTINUED

Note B - Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are presented on the accrual basis of accounting.

Investment Valuation - Investments are valued at fair value as of December 31, 2024. The fair values of the pooled separate accounts are based on the values of the underlying assets. The general account is valued at contract value which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on investments is reported as earned (accrual basis). Dividends are recorded on the ex-dividend date. All increases and decreases for the Plan investments are reported as appreciation or depreciation on the statement of changes in net assets available for benefits.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Forfeitures - Forfeitures of non-vested Company contributions are used to reduce future Company contributions. For the year ended December 31, 2024, \$39,102 of forfeited participant accounts were used to reduce the Company's contributions.

Income Taxes - The Plan is qualified under Section 401 of the Internal Revenue Code and is, therefore, exempt from federal income taxes.

Administrative Expenses - The majority of administrative expenses and fees associated with maintaining the Plan are paid by the plan sponsor.

Payment of Benefits - Benefits are recorded when paid.

Note C - Custodians, Trustees, and Investments

The president of the plan sponsor serves as the Plan's trustee. All accounts associated with the Plan are maintained by The Standard, the third-party administrator, and all investments are held by Minnesota Life Insurance Company, the Plan custodian.

Note D - Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Fair Value Measurement - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurement - Quoted prices which are not active, quoted prices for similar assets or liabilities in active markets, or inputs other than quoted prices that are observable (either directly or indirectly) for substantially the full term of the asset or liability.

Level 3 Fair Value Measurement - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTES CONTINUED

Note D - Fair Value Measurements - Continued

Investments are classified within the level of the lowest significant input considered in determining fair value. Investments classified within Level 3 whose fair value measurements consider several inputs may include Level 1 or Level 2 inputs as components of the overall fair value measurement.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer.

Unobservable inputs used to measure the fair value of the Plan's level 3 financial instruments include the fair value at which the contract could be exchanged for in a current transaction in a liquid market, or in the absence of a liquid market, the discounted future cash flows based on current yields of similar investments with comparable durations.

Note E - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note F - Information Certified by Custodian

The following is a summary of information prepared by Minnesota Life Insurance Company and furnished to the Plan trustees and included in the Plan's financial statements. The Plan trustees have obtained a certification from Minnesota Life Insurance Company that such information is complete and accurate.

(A) Investments held at December 31, 2024 and 2023.

(B) Interest income for the year ended December 31, 2024.

(C) Net appreciation/depreciation in fair value of investments for the year ended December 31, 2024.

Note G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note H - Unpaid Benefits

There were no participants who requested a withdrawal from the Plan that had not been paid as of December 31, 2024.

Note I - Tax Status

The trust established under the Plan to hold the Plan's assets is qualified pursuant to the appropriate section of the Internal Revenue Code and, accordingly, the trust's net investment income is exempt from income taxes. The Plan has obtained a favorable tax determination letter from the Internal Revenue Service and the plan sponsor believes the Plan continues to qualify and operate as designed. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note J - Investments

On October 1, 1986, the Plan entered into a deposit and management contract with Minnesota Life Insurance Company. Minnesota Life Insurance Company maintains the contributions in an account that is credited with actual earnings on the underlying investments. The values included in the financial statements at December 31, 2024 and 2023 are the fair values reported to the Plan by Minnesota Life Insurance Company.
