INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Brandywine Realty Trust 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Brandywine Realty Trust 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Responsibilities of Plan Management for the Financial Statements

Such information is the responsibility of Plan management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan, established as of January 1, 1987, and subsequently amended and restated, is a defined contribution plan covering employees of Brandywine Realty Trust (the "Company"), who are twenty-one years old or older. Union, non-resident alien, leased, and temporary employees who complete less than 1,000 hours in a twelve month period as well as employees classified as independent contractors are ineligible to participate in the Plan. Salary deferral eligibility requirements for these employees have been modified to reflect provisions required by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 ("SECURE Act 2.0"). Eligible participants may enter the Plan on the first day of the month following the date eligibility requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Charles Schwab Trust Bank (the "Trustee") is the trustee of the Plan.

Contributions

Elective Deferral: Participants can elect to have compensation deferred, as a tax-deferred contribution or as a Roth contribution as defined in the Plan, up to the maximum percentage allowed by law, up to a statutory dollar limit determined by the Internal Revenue Code ("IRC") (\$23,000 and \$22,500 in 2024 and 2023, respectively). Catch-up contributions as determined by the IRC are also permitted. The allocation of the contribution to one or more of the investment funds is made at the discretion of the participant. The Plan provides for automatic enrollment whereby employees who are hired or rehired will be automatically enrolled in the Plan with a default deferral percentage of 2%.

Employer Matching Contributions: The Company, at its discretion, may contribute for each participant a matching contribution equal to a percentage of the participant's elective contributions. For the year ended December 31, 2024, the Company contributed 50% of the first 6% of compensation that a participant contributed to the Plan. For the year ended December 31, 2023, the Company contributed 50% of the first 6% of compensation that a participant contributed to the Plan. The Company made employer contributions of \$751,434 and \$822,805 for the years ended December 31, 2024 and 2023, respectively. Participants who terminate employment before the last day of the Plan year for reasons other than retirement, death or disability are not eligible for the employer matching contributions.

Other Contributions: The Company may also, at its discretion, make Non-Elective Contributions and Qualified Non-Elective Contributions. Participants who terminate employment before the last day of the Plan year for reasons other than retirement, death or disability are not eligible for such non-elective contributions. Non-Elective Contributions are allocated based on the proportion of the participant's compensation to the compensation of all eligible participants, subject to certain Internal Revenue Service ("IRS") limitations for highly compensated employees. Qualified Non-Elective Contributions (an amount to be determined by the Company to satisfy certain non-discrimination tests), may be contributed to non-highly compensated employees. There were no Qualified Non-Elective Contributions used to satisfy non-discrimination tests or Non-Elective Contributions during the Plan years ended December 31, 2024 and 2023.

Rollover Contributions: The Plan administrator permits participants to contribute distributions received from other plans.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, if any, as well as allocations of the Company's discretionary nonelective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as

defined in the Plan document. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

Vesting

Participants are immediately vested 100% in their Elective Deferral, Employer Matching Contributions, Qualified Non-Elective Contribution and Rollover Contribution Accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan fund. The term of the loan cannot exceed 5 years, except for the purchase of a primary residence in which the maximum loan period is 10 years. The loans are secured by the balance in the participant's account. The interest rate applied to a loan is 1.0% over the Federal Reserve's prime rate at the time the loan is approved. Interest rates range from 4.25% to 9.50% for loans outstanding as of December 31, 2024.

Payment of Benefits

Benefits under the Plan are payable to the participants, their beneficiaries or their estates upon severance of employment, normal retirement or death. Benefits for any of these events are payable in the form of a lump-sum distribution. In-service and hardship distributions are also permitted.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and employer matching contributions, if any, are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective and qualified non-elective contributions, if any, are recorded in the year in which the related participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

All reasonable administrative expenses, including trustee, custodial and third party administration fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and are included in administrative expenses. Certain investment related expenses are included in the net appreciation in fair value of investments.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

3. Information Certified by a Qualified Institution

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The information for all mutual funds (registered investment companies), common collective trust, and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedules.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: The common collective trust is valued at NAV of units of the common collective trust held by the Plan at year-end using the fair value of underlying investments held by the common collective trust less its liabilities. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the common collective trust will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the common collective trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Galliard Retirement Income Fund seeks to provide safety of principal, adequate liquidity and competitive yield with low return on volatility. Participants may generally redeem units on a daily basis. Participant-directed withdrawals to effect a transfer of assets to a competing investment option must first be held in a non-competing investment option for at least ninety days. The trustee of the Galliard Retirement Income Fund reserves the right to require up to twelve months advanced notice for plan sponsor initiated withdrawals.

5. Related-Party and Party-In-Interest Transactions

Plan investments include mutual funds managed by the Trustee. The Trustee also provides recordkeeping, trustee and custodial services to the Plan. For the services provided, the Trustee charges the Plan administrative fees which are paid from the Plan's assets and as such qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Fees paid by the Plan for the administrative services to the Trustee were \$59,156 and \$60,469 for the Plan years ending December 31, 2024 and 2023, respectively.

During 2024, the Company failed to remit to the Plan's trustee certain employee contributions and loan repayments totaling \$86,420 within the period prescribed by the Department of Labor regulations. During 2025, the Company plans to make contributions to the affected participants' accounts to make the participants whole and compensate those participants for potential lost income due to the 2024 processing delays. The Company believes that these transactions do not affect the tax status of the Plan and is taking action prescribed by the regulations to remedy such errors.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Tax Status

Effective January 1, 2022, through the adoption of the Schwab Retirement Plan Services, Inc. Pre-Approved Defined Contribution Plan Adoption Agreement #001 for use with Basic Plan Document #13, the Plan was amended and restated. The IRS issued a non-standardized pre-approved profit sharing plan opinion letter, dated September 21, 2020, stating that the pre-approved plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Subsequent Events

Effective January 1, 2025, the Plan was amended to change the matching contribution to a per payroll period basis and remove the requirement of being employed on the last day of the plan year to be eligible for the employer matching contributions.

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
