1. Description of the Plan

The following description of the Integra Connect, LLC 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General - The Plan is a defined contribution and profit sharing plan covering substantially all employees of the participating affiliates of Integra Connect, LLC, comprised of participants employed with Integra Cloud, LLC, Integra Life Science, LLC, Integra Shared Services, LLC, Integra Population Health, LLC, Integra GPO, LLC and Centrex Revenue Solutions, LLC. All participating affiliates and employers are collectively referred to as the "Company". Employees who are age 21 or older are eligible to participate on the same date the requirements are satisfied for deferrals and for the Company contribution. To receive the Company profit sharing contributions, employees must also complete one year of eligible service as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's management oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees. The effective date of the Plan is January 1, 2015 with the most recent restatement date effective February 1, 2022.
- B. Contributions - Participants may contribute up to 100% of their aggregate compensation for each year in which they are a participant in the Plan up to the maximum allowable contributions under the Internal Revenue Code (IRC), which totaled \$23,000 in 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. For the year ended December 31, 2024, the maximum allowable amount for catch-up contributions totaled \$7,500. Participants who do not make an election are auto-enrolled with an elective deferral contribution of 5% of compensation. The Plan allows for pre-tax and after-tax (Roth) deferrals and rollover contributions.

The Company may contribute on a per payroll basis to the Plan, on behalf of each eligible participant. The Company matched 100% of the participant deferrals to a maximum of 3% deferral of eligible compensation, and 50% of the participant deferrals of 3% to 5% deferral of eligible compensation as defined by the Plan. The Company may also make discretionary profit-sharing contributions to the Plan to be allocated based on participant compensation to total compensation of all participants eligible for profit sharing contributions who are employed on the last day of the plan year. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies and a stable value fund as investment options for participants.

- C. Participant Accounts - Each participant account is credited with the participant's contributions and allocations of, (a) the Company's contribution, and (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting - Participants are immediately vested in their contributions and Company safe-harbor matching contributions plus actual earnings thereon. Vesting in the Company's non-safe harbor matching contribution and profit-sharing contribution portions of their accounts is based on years of continuous service. A participant vests 25% after one year of service and becomes fully vested over a four-year schedule. Participants shall become fully vested upon death, total and permanent disability and upon attainment of normal retirement, as defined.
- E. Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the participant's entire vested account balance, without regard to the intended use of the funds. Notes receivable are collateralized by the participant's vested account balance and are accounted for as a specific investment of the borrowing participant's account. The principal of the notes, along with interest, is repaid through payroll deductions. Notes receivable bear interest at the prime rate plus 1%. Notes receivable are to be repaid within five years.
- F. Payment of Benefits - The Plan provides for distributions of accumulated benefits upon death, disability or retirement of participants. The full value of a participant's account will be paid to the participant's spouse or designated beneficiary in the event of death or total permanent disability. On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may withdraw funds while in service at age 59½ from their vested account balance.
- G. Forfeited Accounts – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- and \$27,079, respectively. Forfeitures of non-vested accounts are permitted to be used to pay Plan expenses, reduce future Company contributions, or be reallocated to participants. During 2024, \$27,272 were used to pay Plan expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefits paid to participants are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Fees for the administration of notes receivable from participants and distributions are included in administrative expenses and charged directly to the participant's account. Expenses for recordkeeping, advisory and other fees are paid through an allocation to participants accounts and are included in administrative expenses.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Interest-bearing cash is valued at the account balance at year-end.

Investments Measured at Net Asset Value

The stable value fund is valued at the NAV of shares in each account held by the Plan at year end. The net asset value is not a publicly-quoted price in an active market. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

Gains and losses included in the changes in net assets available for benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 at the end of the reporting period. For the year ended December 31, 2024, there were no significant transfers between Levels 1 and 2 and no transfers into or out of Level 3.

5. Related-Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Empower Trust Company, LLC. Empower Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. As described in Note 2, the Company pays certain expenses related to plan operations. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA. All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

7. Nonexempt Transactions

During 2023, there were certain pay periods where employee withholdings and loan payments totaling \$317,019 were not timely remitted to the Plan by the Company. The Company made a contribution representing lost earnings to the Plan associated with the untimely remittances during 2024.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

10. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
