Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Carroll Distributing & Construction Supply, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

(a) General

The following description of the Carroll Distributing & Construction Supply, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan became effective on July 1, 1989.

(b) Plan Description

The Plan is a defined contribution plan covering all full-time employees of Carroll Distributing & Construction Supply, Inc. (Company) who have one year of service with at least 1,000 hours and are age 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(c) Contributions

Participants may make salary reduction contributions on a pre-tax basis up to the maximum allowable deferral that is set by law through payroll deductions to the Plan. There is also an elective matching contribution by the Company to the Plan. Contributions are subject to certain limitations. At the discretion of the Plan administrator, a participant may make rollover contributions, transferring funds either directly or indirectly to the Plan from another qualified plan. Participants direct all contributions into the investment options of their choice.

The Plan currently offers various pooled separate accounts, mutual funds, common/collective trusts, and guaranteed interest contracts as investment options for Plan participants.

(d) Participant Accounts

Each participant's account is credited with the participant contributions, an allocation of (1) the Company's contributions, (2) forfeitures of terminated participants' nonvested accounts, and (3) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations are based on participant earnings or account balances, as defined. The Plan allocates participant forfeitures of terminated participants' nonvested accounts as if the forfeitures were the Company's contribution or as a reduction of administrative expenses. Before allocating forfeitures to participants, they will first be used to reduce any nonelective or matching contribution.

(e) Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and earnings thereon. Vesting of the remainder of the participants' accounts is determined in accordance with the following schedule:

<u>Years of Service</u>	<u>Vested Interest</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

(f) Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator.

(g) Payment of Benefits

Upon retirement or termination of employment, a participant may elect to receive their distribution in one of the following ways:

1. A lump-sum amount equal to the value of their account.
2. In periodic installments over the life expectancy of the participant or the joint life expectancies of the participant and the participant's designated beneficiary.
3. By the purchase of a single premium nontransferable annuity contract.

(h) Forfeitures

Forfeitures will be applied to pay administrative expenses or reduce employer contributions. Any amounts remaining after reducing administrative expenses or employer contributions will be allocated to participants. Administrative expenses were reduced by \$-0- in forfeitures for the year ended December 31, 2024. At December 31, 2024 and 2023, the Plan had \$-0- and \$-0-, respectively, of forfeitures that had not been allocated.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Receivable from Participants

Loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

(d) Investment Valuation and Income Recognition

Investments are reported at fair value, as reported to the Plan by Principal Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value assessments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(e) Benefits

Benefits are recorded when paid.

(f) Excess Contributions Payable

Amounts payable to participants totaling \$17,429 and \$1,551 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to 2024 and 2023 contributions. The Plan distributed the 2024 and 2023 excess contributions prior to March 15, 2025 and 2024.

NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE

The 2024 and 2023, Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by Principal Trust Company, a member of the Principal Financial Group in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$13,906,161 and \$11,793,268 at December 31, 2024 and December 31, 2023, respectively and related net gains of \$1,332,545 for the year ended December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The Plan's valuation methodology used to measure the fair value of mutual funds was derived from quoted market prices of active markets.

Valued at the daily closing price as reported by the fund, mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value of pooled separate accounts and collective trusts are valued using the net asset value (NAV) of units held by the Plan at year-end as provided by Principal Trust Company.

The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee. The investment management fee is deducted prior to setting the daily unit value.

The investment contracts are valued by Principal Trust Company at fair value by discounting the related cash flows based on current yields of similar instruments with comparable duration considering the credit-worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The plan operates under an adoption agreement in connection with a prototype non-standardized profit sharing plan sponsored by Qualified Plan Consultants, LLC (The “Sponsor”). This prototype plan document was filed with the appropriate agency, and the Sponsor has obtained a determination letter from the IRS dated March 31, 2014 stating that the prototype plan constitutes a qualified plan under Section 401 of the IRC, and the related trust was a tax exempt as of the financial statement date. The plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status; however, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. As such, there has been no provision for income taxes made in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - ADMINISTRATIVE EXPENSE

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses of maintaining the Plan are paid by the company and are therefore excluded from these financial statements.

NOTE 9 - PARTY IN INTEREST

The Plan's investments were managed by Principal Financial Group. Principal Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund.

Plan investments are shares of mutual funds, pooled separate accounts and guaranteed interest contracts managed by Principal Financial Group. Purchases and sales of these funds are performed in the open market at fair value and qualify as party in interest transactions under ERISA regulations.

The Plan paid TPA fees to Principal Life Insurance Company that amounted to \$83,568 for the year ended December 31, 2024.

These transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

NOTE 10 - PARTICIPATING COMPANIES

In July of 2024, the Sponsor of the Plan acquired Coleman Materials, LLC.

NOTE 11 - DATE OF MANAGEMENT'S REVIEW

Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
