Opinion

Note 1 - Description of the Plan

The Madden Contracting Company, LLC (the “Company”) Employee Benefit Plan & Trust provides health and prescription drug benefits covering qualifying employees of the corporation. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The plan provides health, dental, and prescription drug benefits that cover permanent, full-time employees who work an average of 30 hours per week (and their covered dependents) that fall within the eligibility classifications of the plan sponsor and choose to participate following the employee waiting period. The employee waiting period for all full-time employees is satisfied after the first sixty days of full-time employment. The plan also provides continuation coverage as required by the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) for qualified beneficiaries who would otherwise have lost coverage under the plan. Retired owners may elect to continue coverage within certain guidelines established under the plan.

The plan provides benefits through a funding arrangement that includes a trust, which is funded by the plan sponsor and/or the participating employees. Under the plan agreement, the plan sponsor contributes in cash to the plan in a manner and at such time determined by a committee, which is a plan fiduciary. Employees may or may not be required to contribute to the plan in order to participate. Their contribution is based on the coverage elected by the participants (i.e. single, family, etc.). Former members covered under COBRA make contributions to the plan for continuation of health coverage.

Medical benefits are provided on a partially self-insured basis. The plan has purchased insurance contracts to protect the plan against excessive or unpredictable claims. The insurance contracts include specific loss provisions that cover claims in excess of \$75,000 for each individual covered under the medical plan. The insurance contracts also include aggregate loss provisions that cover the combined claims for all participants of the plan when the qualified claims for the plan year exceed a stated amount. The stated amount under the aggregate loss provisions was approximately \$2,346,110 at December 31, 2024.

Although it has not expressed the intent to do so, the plan sponsor has the right to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. Funds contributed to the plan are irrevocably restricted for the use and provision of benefits to company employees.

The foregoing description of the plan provides only general information. Employees should refer to the Summary Plan Description and Plan Document for a more complete description of the plan's provisions.

Note 1 - Description of the Plan (continued)

An outside administrator, 90 Degree Benefits – Louisiana (90 Degree Benefits) processes the claims for medical benefits and, on behalf of the trustee, disburses claim payments due in accordance with the provisions of the plan to the participant or assignee entitled thereto. The plan offers self-insured dental benefits also administered by 90 Degree Benefits on behalf of the trustee.

The plan trustee is the fiduciary of the plan, with full authority to control and manage the operation and administration of the plan.

Note 2 - Summary of Significant Accounting Policies

Basis of accounting – The financial statements of the plan are prepared under the accrual method of accounting.

Investment valuation and income recognition – Investments, if any, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan's trustees determine the plan's valuation policies utilizing information provided by the investment custodians. See Note 10 for discussion of fair value measurements.

Use of estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations, and changes therein; claims incurred but not reported; eligibility credits; claims payable; and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Payment of benefits – Health claims and insurance premiums are reported when paid. Any refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with benefit payments.

Cash – Cash in the plan consists of cash held in a noninterest-bearing bank account. Checks issued in excess of available balances are included in accounts payable and accrued liabilities. Claims of the plan are handled by its third-party administrator, 90 Degree Benefits. 90 Degree Benefits pays all of the claims through an account held on behalf of the plan.

Note 2 - Summary of Significant Accounting Policies (continued)

Benefit obligations – Benefit claims currently payable include the plan’s liability for claims incurred and processed before December 31, 2024. The plan’s liability for claims incurred but not reported (IBNR) included claims incurred before December 31, 2024, but processed after December 31, 2024. Additional IBNR is estimated based on prior claims experience and the expected time period from the date claims are incurred to the date that the related claims are submitted and paid.

Note 3 - Tax Status

The plan and trust is not pursuing tax exempt status. However, taxable income to the trust is defined in such a way that yields no tax liability for the current year. Accordingly, no tax liability or expense is reflected in the financial statements. The plan is current with all tax filings and is no longer subject to federal income tax examinations by taxing authorities before December 31, 2021.

The accounting standard on accounting for uncertainty in income taxes addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements. Under this guidance, the plan may recognize the tax benefit from an uncertain tax position only if it is more likely than not that the tax position will be sustained on examination by taxing authorities, based on the technical merits of the position. There were no unrecognized tax benefits identified or recorded as liabilities for the year ended December 31, 2024.

Note 4 - Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

ERISA requires every fiduciary of an employee benefit plan and every person who handles funds of the plan to maintain fidelity bond coverage equal to 10% of the amount of plan assets. The fiduciary does maintain such a bond.

Note 8 - Administrative Expenses

The plan pays administrative expenses that consist primarily of administrative fees paid to its third-party administrator, 90 Degree Benefits. These expenses encompass professional fees and miscellaneous healthcare fees. The administrative expenses are reported on the statement of changes in benefit obligations and net assets available for benefits.

Note 9 - Related Party Transactions

The plan paid 90 Degree Benefits, its third-party administrator, administrative fees of \$83,898 and \$65,381 for the years ended December 31, 2024 and 2023, respectively.

Note 10 - Fair Value Measurements

The framework for measuring fair values provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement* are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the trust has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 inputs must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value of financial instruments, including cash, approximate the carrying value, principally because of the short maturity of those items and are considered Level 1 or Level 2.

Note 11 - Risks and Uncertainties

The present value of benefit obligations is reported based upon assumptions pertaining to participants past and future health care costs. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
