Independent Auditor's Report

To the Trustees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Family Development Services, Inc. 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Family Development Services, Inc. 403(b) Retirement Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Note 1 –Summary of Significant Accounting Policies

The significant accounting policies followed by the Plan are summarized below.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for guaranteed investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to guaranteed investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The Plan administrator uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported additions to and deductions from net assets. Actual results could vary from the estimates that were assumed in preparing the financial statements.

Investments Valuation and Income Recognition

Pooled separate accounts are made up of mutual funds that are valued at net asset value as a practical expedient as provided by American United Life Insurance Company (American) for the years ended December 31, 2024 and 2023, utilizing quoted market prices of the underlying mutual funds less liabilities on the last business day of the Plan year. Guaranteed investment contracts are reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative costs

The administrative costs charged to the Plan are paid by the Plan or the Plan Sponsor at the Plan Sponsor's discretion. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Subsequent events

The Plan's management has evaluated the financial statements for subsequent events occurring through September 29, 2025, the date the financial statements were available to be issued.

Note 2 – Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a group deferred annuity plan under Section 403(b) of the Internal Revenue Code (IRC) which is sponsored by Family Development Services, Inc. (Plan Sponsor) for the benefit of its eligible employees as of September 1, 1997. Any employee of Family Development Services, Inc. is eligible to make salary deferral contributions after their first hour of service and is eligible to participate in employer contributions after three months following their employment commencement date. Pursuant to final DOL regulations, a plan document was adopted effective January 1, 2009, and was amended and restated as of January 1, 2024. The plan is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA).

Contributions

Plan participants may authorize the Employer to make salary deferral contributions to the Plan up to the maximum amount allowed under provisions of the IRC. Participants may also make rollover contributions from amounts distributed to them from other qualified plans. The Plan Sponsor may make discretionary contributions to the Plan.

Participant Accounts

The Plan maintains participant-directed investment accounts on behalf of each participant. A participant's account is credited with the participant's contributions, Plan Sponsor contributions, and investment earnings based on the investment options elected.

Forfeited Accounts

As of December 31, 2024 and 2023, there were \$14,968 and \$17,850, respectively, in forfeited non-vested accounts. Forfeited accounts are available to reduce future employer contributions or offset plan administrative expenses to the Plan. For the years ended December 31, 2024 and 2023, \$82,314 and \$113,558 of forfeitures were used to reduce employer contributions, respectively.

Vesting

Participants are 100% vested in their rollover contributions, salary deferral contributions and earnings thereon. Participants are 100% vested in Employer contributions after three years of service.

Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Upon termination of employment, death, disability, or normal retirement (age 65), a participant (or designated beneficiary) will receive 100% of the vested account balance in a lump sum cash payment. Distribution of a participant's salary deferral contributions (excluding earnings) may also be made in the case of certain financial hardships as per the Plan Agreement. In-service withdrawals by participants that have attained age 59 ½ from the vested account balance are also permitted. A participant may also withdraw any amount from his/her rollover account once a year. Benefits are recorded when paid.

Note 3 – Fair Value Measurements

The Plan has categorized its assets that are measured at fair value based on a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to valuation methodologies include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value.

Mutual Funds – Valued at the published net asset value (NAV) of units held by the Plan at year end. (Level 1)

Note 4 – Tax Status

Since the Plan is maintained under IRC Section 403(b), rather than Section 401(a), there is no IRS program pursuant to which an individual determination letter can be obtained for the Plan. Although the Plan has not received a favorable determination letter, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 5 – Party-In-Interest Transactions

Certain plan investments are managed by American United Life Insurance Company. As custodian, these investments and investment transactions qualify as exempt party-in-interest transactions. Plan audit and accounting fees are paid by the Employer/Plan Sponsor. Certain administrative functions are performed by officers and employees of the Plan Sponsor. These employees are also Plan participants. No such officers or employees received compensation from the Plan.

Note 6 – Investment Contract with Insurance Company

In 2017 the Plan moved its custodial services and investment platform to American United Life Insurance Company (“AUL”). The Plan entered into a guaranteed investment contract with AUL.

As described in the basis of accounting disclosure contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by AUL, represent contributions

made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

The crediting interest rate for AUL is based on a formula agreed upon with the contract holder. The guaranteed rate is declared each year for the five years following the establishment of the interest pocket and will mature the sixth year. No guaranteed rate may be less than an annual effective interest rate equal to the lesser of 3% or the average 5-year Constant Maturity Treasury Rate reported by the Federal Reserve for the month of October and rounded to the nearest .05%, reduced by 1.25% but never less than 1%. Such interest rates are reviewed on a quarterly basis for resetting. The average crediting interest rate as of December 31, 2024 was 2.00%. The average crediting interest rate as of December 31, 2023 was 1.75%.

Certain events limit the ability of the Plan to transact at contract value with the contract holder. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
