To Whom It May Concern:

We are writing to request penalty relief for the late filing related to the 2024 Form 5500. The Form 5558 (Application for Extension of Time to File) was not filed timely due to an inadvertent oversight that occurred during the plan's contract termination and transition process.

The plan was formally terminated and moved to our deleted plans list around the same time the Form 5558 would have been filed. As a result, the extension filing was mistakenly overlooked under the assumption that no further action was required for the plan year in question. Once we identified the error, we immediately took corrective action and completed the necessary filing steps.

We respectfully request that the IRS consider this reasonable cause for the delay. The omission was not due to willful neglect, and steps have since been implemented to ensure all terminated plans are reviewed for final extension and filing requirements prior to removal from our active tracking system.
