## **Note 1. Description of Plan**

The following description of Scarinci & Hollenbeck, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

### ***General***

The Plan was established on February 1, 2018, and was amended and restated on April 20, 2022. The Plan is a defined contribution plan covering all eligible employees of Scarinci & Hollenbeck, LLC (the Company and Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### ***Eligibility***

Employees are eligible to participate in the Plan immediately upon hiring date and upon attainment of 21 years of age. In addition, participants are eligible to receive a discretionary employer contribution if the participant earns a minimum of 501 hours or is employed on the last day of the Plan year. The Plan was amended September 7, 2018 to exclude certain leased employees, non-common law employees, temporary employees and interns.

### ***Contributions***

The Plan allows each participant to contribute a percentage of their annual compensation, excluding bonuses and commissions, and a catch-up contribution to the Plan, as permitted by Internal Revenue Service (IRS) regulations. Eligible employees are automatically enrolled at a rate of 1% after 35 days from their hire date, unless they opt out within the 35-day period. Participants with a deferral greater than 0% are auto escalated by 1% annually, not to exceed 8%. The Company may make a discretionary matching employer contribution calculated on a plan year basis and or a discretionary nonelective employer contribution. The Company elected not to make any contributions for the year ended December 31, 2024.

### ***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, employer contributions, and the earnings thereon. Contributions to the Plan are invested by the trustee as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

### ***Vesting***

Participants are fully vested in their own contributions and earnings. Participants vest 20% after two years of service and an additional 20% each subsequent year until fully vested after completing six years of service in the Company's contributions. Effective February 1, 2024, Warren Law Group employees hired prior to January 2, 2024, shall receive credit service for their service with Warren Law Group.

### ***Forfeitures***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,420 and \$2,140, respectively. These accounts will be used to reduce future employer contributions.

### ***Participant Loans***

Participants may borrow from their fund accounts the lesser of 50 percent of their vested balance or \$50,000 minus their highest outstanding loan amount during the prior twelve months. Loan transactions are treated as a transfer from the investment fund to the participants loan fund. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. The loans are collateralized by the balance of the participant's account and bear interest ranging from 3.25% to 8.50% percent. Repayment of the loan is required to be made at least quarterly on an after-tax basis in level payments of principal and interest, and must be completed within five years, except for the purchase of a primary residence.

***Rollovers***

An employee may rollover distributions from a former employer's qualified plan to the Plan, regardless of eligibility if it has been determined by the plan administrator to be an "eligible rollover distribution" as defined by the Internal Revenue Code (IRC).

***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten-year period. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

***Administrative Expenses***

A portion of the expenses incurred in the administration of the Plan are paid by the Company.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investments Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for the discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Subsequent Events***

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable on participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Fair Value Measurements**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

**Level 1** Unadjusted quoted prices in active markets for identical investments.

**Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023.

- *Mutual funds*: valued at unadjusted quoted prices reported in an active market at the year end
- *Money market fund*: valued at cost plus accrued interest, which approximates fair value
- *Common collective trust*: the fair value of the common collective trust is determined based on the underlying assets, which represent the net asset value, a practical expedient to fair value of units held by the Plan. The common collective trusts do not have any unfunded commitments relating to their investments. Participant redemptions can be made on any business day and do not have a redemption notice period except as provided in the trust documents.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the

**Note 5. Related Party Transactions**

The Fidelity Management Trust Company (Fidelity), the trustee of the Plan, manages certain Plan investments; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Fidelity and its affiliates were \$11,197 for the year ended December 31, 2024. Fees paid by the Plan to its investment advisor were \$10,000 for the year ended December 31, 2024.

**Note 6. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan in whole or in part at any time subject to the provisions set forth in the Employer Retirement Income Security Act of 1974 (ERISA). Upon termination, partial termination or complete discontinuance of contributions under the Plan, all participants become fully vested in their individual accounts.

**Note 7. Tax Status**

On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the plan itself, and has been amended since receiving the determination letter, however, the Plan's management believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan's investments are concentrated in funds that invest in marketable securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain securities and level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
