Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Greater Opportunities 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

(1) Description of Plan

The following description of Greater Opportunities 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan was formerly known as Opportunities for Chenango 403(b) Plan. Upon the merger of the sponsoring organizations, the Opportunities for Chenango 403(b) Plan and the Opportunities for Broome, Inc. 401(k) Plan were merged on July 1, 2020 to become the Greater Opportunities 403(b) Plan. Upon the merger, the Opportunities for Chenango 403(b) Plan was the surviving entity and the name was changed to Greater Opportunities 403(b) Plan. The Plan is a 403(b) plan sponsored by Greater Opportunities for Broome and Chenango, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on January 1, 2009 and was restated on October 18, 2018 to amend matching contributions, forfeiture allocations, acceleration of death and disability benefit post-severance distributions and in-service distribution and plan loans. Employees can make elective deferrals beginning on the first day of employment with the Company. The Plan was restated on January 1, 2021 to allow for prior service credits to employees of Opportunities for Chenango, Inc. and the Opportunities for Broome, Inc. and to change the limit on matching contributions.

(b) Contributions

Participants can elect to either (a) contribute to the Plan on a tax-deferred basis under an agreement for salary reduction executed in accordance with Internal Revenue Code (the Code) Section 403(b), or (b) make after tax contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also roll-over amounts representing distributions from other qualified plans.

Plan participants may make an elective deferral not to exceed a dollar limit set by law. Matching contributions of 100% of the elective deferral are made up to 3%. Matching contributions of 50% of the elective deferral are made from 3% to 5%.

The Company may allocate a non-elective contribution for participants who have attained the age of 21 and two years of service.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution, as well as allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of investment and administrative expenses that are paid by the Plan. Allocations are based on the participant's account balance, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(1) Description of Plan, Continued

(d) Vesting

Participants are immediately vested in their elective deferrals, including catch-up contributions, Company's nonelective contributions and rollover contributions and earnings thereon. Matching contributions are vested after one year of service.

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested balance, or \$50,000. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate of prime plus 1%. Loans generally have a maximum term of 5 years, unless used to acquire a primary residence, in which the term may be extended up to 10 years. Principal and interest is paid ratably through payroll deductions.

(f) Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant will be paid in a lump sum or in installments for required minimum distributions. Hardship withdrawals are permitted under certain conditions.

(g) Forfeited Accounts

Forfeitures of non-vested accounts will be used to reduce future employer contributions or pay administrative fees. Forfeitures totaled \$5,213 and \$2,428 of the years ended December 31, 2024 and 2023, respectively. Administrative fees of \$4,730 and \$552 were paid from forfeited accounts during the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, forfeited balances available for future use amounted to \$2,912 and \$2,345, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

(c) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

(d) Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes both the Plan's gains and losses on investments bought and sold, as well as held during the year.

(e) Contributions

Contributions from Plan participants and the Company contributions are recorded in the year in which the participant compensation is earned.

(f) Payment of Benefits

Benefits paid to participants are recorded when paid.

(g) Operating Expenses

Except for certain administrative fees, all expenses of maintaining the Plan are paid by the Company.

(h) Subsequent Events

The management of the Plan has evaluated subsequent events through the date of the report which is the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

(3) Fair Value Measurements, Continued

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- Fixed return product - Valued at fair market value which is equal to contract value less a contingent deferred sales charge, if applicable. Amounts are held in a general account and are credited on a net daily basis at annual effective rates. This investment is not considered fully benefit responsive insofar as the contract does not restrict participant-directed exchanges.

The Plan's policy is to recognize transfers as of the actual date of the event or change in circumstances that caused the transfer.

(4) Financial Certification

The incorporation of this financial information in the accompanying financial statements is based solely on their certification and has not been audited by independent auditors.

(5) Party-In-Interest Transactions

Nationwide is the custodian of the Plan's assets; therefore, transactions with Nationwide qualify as party-in-interest. Additionally, notes receivable from participants qualify as party-in-interest transactions.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall have a vested interest in their account of 100%.

(7) Tax Status

The Plan adopted a 403(b) volume submitter plan through a third party administrator. This prototype plan received a favorable determination letter on March 31, 2017 from the Internal Revenue Service (IRS) indicating that the features, as then designed, conform with the applicable requirements of Section 403(b) of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions and the DOL; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
