Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Swiss Automation, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

Note 1: Description of Plan

The following description of the Swiss Automation, Inc. 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Swiss Automation Inc. (the "Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility

Employees of the Company who are 21 years of age or older, except those covered by a collective bargaining agreement and nonresident aliens, are eligible to participate in the Plan upon completing three months of service and enter the Plan at the first day of each month following the date these requirements are met. Effective January 1, 2024 a long-term part-time employee who has not previously entered the Plan, but has attained at least 500 hours of service in at least three consecutive years beginning after December 31, 2020, are eligible to participate in the Plan. Effective February 1, 2025, the eligibility age was reduced to 18 years of age. Additionally, all eligible employees whose entry date is on or after February 1, 2025 will be automatically enrolled into the Plan.

Contributions

Participants may make either pre-tax or Roth after-tax elective contributions of eligible compensation, as defined by the Plan, in the form of payroll deductions as a percentage of eligible compensation or a flat dollar amount, not to exceed the maximum amount allowable under applicable income tax regulations. In addition, the Plan allows for eligible participants to make catch-up contributions in accordance with Internal Revenue Service regulations and rollover/transfer contributions from qualified sources as defined by the Plan.

The Plan also provides for discretionary matching contributions to be contributed by the Company at the end of the Plan year to those participants making elective contributions during the Plan year. If a participant participating in elective contributions is no longer employed on the last day of the Plan year they must have at least 500 hours of service, as defined by the Plan, in order to receive an allocation of the Company discretionary matching contribution. The Company contributed \$173,363 in matching contributions for the 2024 Plan year. In addition, the Plan allows for a Company discretionary profit sharing contribution for eligible employees. No such discretionary profit sharing contribution was made by the Company for the year ended December 31, 2024.

Vesting

Participants are immediately vested in their elective, catch-up and rollover contributions. Participants vest in their Company discretionary match and profit sharing contributions on a graduated basis based on years of credited service, as defined by the Plan, and are fully vested after six years of credited service.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Forfeitures

Forfeitures, if any, are used to reduce future Company contributions or pay administrative expenses of the Plan in the year following forfeiture. Forfeitures in the amount of \$5,947 were used to reduce Company contributions for the year ended December 31, 2024. As of December 31, 2024 and 2023, there were \$15,222 and \$8,335, respectively, of unallocated forfeitures.

Investments

Participants direct the investment of their account balance into various investment options offered by the Plan. The Plan offers several mutual funds and a common trust fund as investment options.

Participant Accounts

Each participant's account is credited with the participant's elective salary deferral contributions, catch-up, rollover contributions, discretionary Company matching and profit sharing contributions, withdrawals, as applicable, administrative fees, if applicable, and allocations of Plan earnings (losses) based on the participant's account balance in each investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their vested account balance and earnings thereon, a minimum of \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less, for specific situations as defined in the Plan. The loans are secured by the vested balance in the participant's account, bear interest at a rate established by the Plan Administrator based on the current prime lending rate and are to be repaid through payroll deductions ratably over a period not to exceed five years unless for the purchase of a primary residence which may be repaid over a period not to exceed 15 years. Interest rates on notes receivable from participants outstanding at December 31, 2024, ranged from 4.50% to 9.50%

Payment of Benefits

The Plan allows for in-service withdrawals from rollover account balances at any time and by participants who have attained the Normal Retirement Age of 59 1/2 from their vested account balances and earnings thereon. In addition, the Plan allows for hardship withdrawals from a participant's vested account balances for specific situations as defined by the Plan. Upon termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account.

Note 1: Description of Plan (Continued)

Plan Termination

Although it has expressed no intent to do so, the Company has the right under the Plan, in certain circumstances, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will immediately be fully vested in their accounts.

Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits during the reporting period and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Determination as to when participant notes are considered in default and reclassified as distributions is based on the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Excess Contributions Payable

There were no excess contributions as of December 31, 2024. At December 31, 2023 amounts payable to participants totaling \$10,732 for contributions in excess of amounts allowed by the Internal Revenue Service were recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Administrative Expenses

Administrative fees for loans and distributions from the Plan are charged to the individual participants' accounts. The asset management expenses are paid from the Plan's investment funds. Investment advisory and management fees are allocated proportionately to Plan participants based on their respective account balances. Substantially all other expenses incurred in connection with the administration of the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3: Summary of Information Prepared and Certified by Trustee

Investments at fair value and notes receivable from participants at December 31, 2024 and 2023, and total investment income and interest income on notes receivable from participants for the year ended December 31, 2024, included in the accompanying financial statements have been certified by Capital Bank and Trust Company, the Trustee, to the Plan Administrator as being complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The accompanying Supplemental Schedule of Assets Held as of December 31, 2024, has been derived from data certified by the Trustee.

Note 4: Fair Value Measurements

In measuring the fair value of the Plan's investments, Plan management utilizes a framework that provides for a fair value hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correction or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Mutual funds: - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common trust fund - Fair value is estimated using net asset value (NAV) as a practical expedient. NAV is determined by using the estimated fair values of the underlying assets held in the fund at year-end. The fund primarily invests in investment contracts issued or sponsored by various insurance companies, commercial banks, and investment funds. The use of NAV as fair value is deemed appropriate since the common trust fund does not have a finite life, unfunded commitments relating to this type of investment, or significant restrictions on redemptions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Risks and Uncertainties

The Plan holds investments in and provides investment options to participants in shares of registered investment companies (mutual funds) and a common trust fund. The underlying investment securities of the funds are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of the uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6: Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by American Funds, the record-keeper of the Plan. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Income Tax Status

The Plan has adopted a defined contribution pre-approved plan sponsored by Capital Group Retirement Plan Services. The Internal Revenue Service has determined and informed the Plan sponsor by letter dated June 30, 2020 that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
