Note 1: Plan Description

The following description of The National Football League Capital Accumulation Plan - Green Bay Packers, Inc. (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) retirement savings plan covering substantially all employees of Green Bay Packers, Inc. (the "Club") other than players. An employee is eligible to participate on the first day of the first payroll following the completion of 1 hour of service with the Club or another National Football League team during an applicable computation period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, and is administered by management of the Club.

Contributions

Participants may elect to have up to 100% of their pre-tax annual eligible compensation (as defined by the plan document) contributed to the Plan on their behalf during the plan year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also roll over amounts from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Club makes a matching contribution equal to 50% of the participant's salary deferral contributions up to the lesser of 2.5% of the participant's annual eligible compensation or \$3,750. A matching contribution is not made on amounts rolled into the Plan.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Club's matching contributions, and allocations of plan earnings or losses and is reduced by withdrawals. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant is 100% vested in his or her account at all times.

Note 1: Plan Description (Continued)

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one note outstanding at a time. Note terms range from one to five years unless the note qualifies as a home loan, of which, the term cannot exceed 10 years. The notes are secured by the balance in the participant's account and bear interest at the prime rate on the first business day of the month the loan application is received. Interest rates on existing notes at December 31, 2024, ranged from 3.25% to 8.50%. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits

Plan benefits are available at normal retirement (age 65), early withdrawal (age 59 1/2), disability retirement, death, or termination of employment. The Plan also allows for specific qualified birth or adoption distributions if certain criteria are met. In addition, hardship distributions are permitted if certain criteria are met. Rollover contributions may be withdrawn at any time.

Participants generally receive benefit payments in the form of a lump-sum distribution.

Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain investment-related expenses are included in net appreciation in fair value of investments as they are paid through revenue sharing rather than direct payment. Administrative expenses, investment advisory fees, and substantially all other expenses incurred in conjunction with the Plan are paid by the Club. Expenses paid by the Club are excluded from these financial statements.

Subsequent Events

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common/collective trust funds: Valued at the net asset value ("NAV") provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it was determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. The NAV is based on the value of the underlying investments held by the fund less its liabilities. Participant transactions (purchase and sales) may occur monthly. The Plan requires affirmative participant elections, either electronically or via paper, for redemption of these investments for all account balances that exceed \$1,000. There are no unfunded commitments as of December 31, 2024 and 2023.

Mutual fund: Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open-end mutual fund that is registered with the U.S. Securities and Exchange Commission. This fund is required to publish its NAV and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

Note 4: Information Prepared and Certified by Plan Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, accrued interest and dividends, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by PNC Bank, the custodian of the Plan.

Note 5: Party-in-Interest Transactions

Most plan investments are managed by PNC Bank. PNC Bank is the custodian of the Plan and, therefore, transactions with PNC Bank qualify as party-in-interest transactions. Certain investment-related fees incurred by the Plan are included in net appreciation in fair value of investments, as they are paid to the custodian or investment managers through revenue sharing rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Club has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7: Tax Status

The IRS has notified the Club by a letter dated June 28, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receiving the notification letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
