INDEPENDENT AUDITOR'S REPORT

To the Investment Plan Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of EnSite USA, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the EnSite USA, Inc. 401(k) Profit Sharing Plan (the “Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of EnSite USA, Inc. (the “Company”) except union employees, nonresident aliens, and leased employees. All employees who have attained age 21 are eligible to participate in the Plan on the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan as a pre-tax and/or Roth salary deferral. Participants may elect to defer up to 90% of their compensation each year and may make a separate election to defer up to 100% of any bonus, up to the maximum established by the Internal Revenue Code (IRC). Participants who are at least age 50 or will attain age 50 before the end of a calendar year may elect to defer catch-up contributions to the Plan. Rollover contributions are allowed subject to the conditions set forth in the Plan.

The Company may make a discretionary matching contribution equal to a percentage of each participants’ salary deferrals. The Company, at its discretion, may elect to make this matching contribution on a tier basis in which the Company may define by a dollar amount or percentage, different tiers of contributions and the discretionary matching percentage assigned to each tier. The tiers may be based on the rate of a participant’s salary deferrals or years of service. The Company’s discretionary matching contribution is made on a pay period basis. For 2024, the Company elected to make a discretionary matching contribution in an amount equal to 50% of a participant’s salary deferral up to 6% of eligible compensation.

The Company may also make a discretionary nonelective contribution each plan year. Eligible employees must be employed on the last day of the plan year and have completed 1,000 hours of service during the plan year. The discretionary nonelective contribution is allocated based on the employee’s eligible compensation in excess of the taxable wage base. The Company did not make a discretionary nonelective contribution for the plan year ended December 31, 2024.

The Plan is participant directed, and participants may change their salary deferral each payroll period and their investment options at any time.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions as well as allocations of earnings, including realized and unrealized gains and losses. In addition, participants are charged with any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are at all times fully vested in their contributions, and the appreciation or depreciation thereon. Participants vest in the Company discretionary matching and nonelective contributions under a three-year vesting schedule. A participant vests at 33% per year after one year of service and becomes 100% vested after three years of service. A participant will become fully vested if employed on or after their normal retirement age or upon death or total and permanent disability. Normal retirement age is the later of age 65 or the fifth anniversary of the first day of the plan year in which participation in the Plan commenced.

Payment of Benefits

Upon a participant's retirement, disability, death, or termination of employment, the vested funds in the participant's account may be distributed in a lump-sum or partial withdrawals. The Plan also allows for in-service withdrawals at age 59 ½ from a participant's vested account balance and hardship withdrawals from a participant's pre-tax and Roth salary deferral accounts. Upon termination, a participant's vested account balance that is \$5,000 or less may be automatically distributed by the plan administrator without the participant's consent.

Forfeitures

The Company may use forfeitures to pay Plan administrative expenses or to reduce employer contributions. At December 31, 2024 and 2023, the Plan's forfeiture balance was \$7,425 and \$12,632, respectively. During 2024, \$68,225 in forfeitures were used to reduce employer contributions. There were no forfeitures used to pay Plan administrative expenses.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, participants would become 100% vested and receive benefits based on their account balances accumulated to the date of termination of the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Company discretionary matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to withdrawals, and certain investment transaction fees are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund: Valued at NAV, which is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The fund seeks to maintain a stable NAV of \$1 and is a quoted price in an active market.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments measured using the NAV practical expedient are described below:

The T. Rowe Price Stable Value Common Trust Fund Class E (the "Fund") is a common trust fund with T. Rowe Price Trust Company. Investments in common trust funds are considered indirect investments in fully benefit-responsive investment contracts and, therefore, are valued at NAV, which is used as a practical expedient to estimate fair value. The Fund primarily invests in synthetic investment contracts. Participant transactions (purchases and sales) may occur daily. Certain investment options offered by the Plan may be deemed to compete with this fund, therefore, any exchanges must first be made to a non-competing fund for 90 days. Were the Plan to initiate a full redemption of the Fund, the issuer reserves the right to temporarily delay withdrawal from the Fund in order to ensure that securities liquidations will be carried out in an orderly business manner. The Plan has no unfunded commitments and no contractual obligations to further invest in this Fund.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used for valuing securities at December 31, 2024 or 2023.

NOTE 4 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in mutual funds, a money market fund, and a common trust fund managed by entities affiliated with T. Rowe Price Retirement Plan Services, Inc., the Plan's recordkeeper. Therefore, these investments qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 6 - TAX STATUS

The Plan has adopted a non-standardized defined contribution pre-approved plan which obtained its latest opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - SUBSEQUENT EVENTS

Through a provision in the Secure 2.0 Act, the Plan increased the \$5,000 automatic distribution limit to \$7,000 in 2025. The Plan will formally amended to adopt this provision prior to December 31, 2026.

Management has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.
