Reasonable Cause Explanation for Late Filing

To Whom It May Concern,

I am writing to provide a reasonable cause explanation regarding the late filing of our Form 5500-SF for the short plan year ending January 31, 2022. We had intended for the Form 5500 filed for the December 31, 2021 to be the final filing for the Plan. Based on our discussions with our third party administrator and third party accounting firm, we believed that the 2021 Form 5500 could be marked final, as there were no participants at the end of the year and the net assets of the Plan were \$0 as of December 31, 2021.

However, we subsequently received communications from the Internal Revenue Service indicating that the Form 5500 could not be the final return filed because of the \$136,679 reported as both assets and liabilities of Plan as of December 31, 2021. This amount represented the final payment to the Pension Benefit Guaranty Corporation. The amount was paid out in January 2022. No assets remained in the Plan after this date.

We are filing this final short plan year Form 5500-SF for 2022 to address the correspondence received from the IRS. Thank you for your understanding.
