Independent Auditor's Report

To the Plan Administrator

Opinion

We have audited the financial statements of Buist Electric, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management's estimates are based on information provided by an independent appraisal firm. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Note 1 - Plan Description

The following description of Buist Electric, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Buist Electric, Inc. (the "Company") established Buist Electric, Inc. Employee Stock Ownership Plan effective January 1, 2005. The Plan operates as an employee stock ownership plan and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the "Code" or IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by Buist Electric, Inc. A trustee committee, as appointed by the Company's board of directors, is the Plan's trustee. Buist Electric, Inc. Employee Stock Ownership Plan is the sole stockholder of Buist Electric, Inc.

Employees are generally eligible to participate in the Plan at age 19, providing they have been employed for the previous six months and have worked for at least 1,000 hours. Contribution allocations are based upon a participant's proportional share of total eligible compensation.

Administration

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.

Contributions

The Company makes annual contributions to the Plan, as approved by the Company's board of directors. Contributions are allocated to participants on a pro rata basis based on annual compensation, as defined by the plan document.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each year, the Company's board of directors determines the amount of the contribution, if any, to be made to the Plan. The contribution is subject to certain limitations. Participants must be eligible to participate in the Plan and be employed on the last day of the plan year to be eligible for an allocation of the contribution. Allocations are based on a participant's eligible compensation relative to total eligible compensation.

Vesting

Vesting in the Company's contribution portion of the accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company 40 percent after two years of service and another 20 percent per year thereafter until they become fully vested after five years of service.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment. Normally, plan distributions will be made in a single lump sum after the trust accounting has been completed for the plan year. An employee may request to have a distribution paid in company stock, which will be purchased from the participant at the most recent appraised valuation. If a participant's vested account balance is more than \$1,000, the participant will have the option of requesting a distribution. Payment will be made as soon as administratively possible after the end of the plan year in which the participant's employment terminates.

Note 1 - Plan Description (Continued)

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase in either a single payment or in five equal annual installments of principal together with interest on the unpaid principal balance.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investments in company stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their accounts. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 75 percent of their company stock account. In the 6th year, the participant may elect to take a distribution of a cumulative amount up to 100 percent of their remaining company stock account. In addition, there will be mandatory diversification of 25 percent at age 60, 50 percent at age 61, and 75 percent at age 63. Mandatory diversification is capped at 75 percent. For the year ended December 31, 2024, diversification distributions totaled approximately \$1,680,000.

Voting Rights

Each participant is entitled to exercise, in certain matters, voting rights attributable to the shares allocated to his or her account as long as the trustee is notified prior to the time that such rights are to be exercised.

Termination

The Company reserves the right to terminate the Plan at any time, subject to the Plan's provisions. Upon termination of the Plan, the Company shall direct the trustee to pay all liabilities and expenses of the Plan and to sell shares of financed stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the loan. Upon any full or partial termination, all amounts credited to the affected participants' accounts will become 100 percent vested, and all remaining unallocated amounts will be allocated to the accounts of all participants.

Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan's terms and the Code.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. The Company allocates forfeitures to participants based on the participant's compensation, as defined. Allocations of forfeitures are considered additional company contributions and are subject to the vesting provisions of company contributions.

Party-in-interest Transactions

Certain plan assets are in investments in the Company's stock. The Company is the sponsor of the Plan; therefore, these transactions qualify as permissible party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. The most significant assumptions and estimates relate to the valuation of company common stock. Application of these assumptions requires the exercise of judgment as to future uncertainties, and, as a result, actual results could differ from those estimates.

Risks and Uncertainties

The investment in company stock is exposed to various risks. Due to the level of risk associated with the investment in company stock, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 28, 2025, which is the date the financial statements were available to be issued.

Note 3 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 4 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Common Stock

As of December 31, 2024 and 2023, company stock is classified as Level 3 in the fair value hierarchy. The company stock is classified as a Level 3 investment based on the fair value determined by an annual independent appraisal. The appraisal is based on the income and market approaches, including the capitalization of cash flow method and guideline transaction method. The appraiser took into account historical and projected cash flow; adjusted earnings before interest, taxes, depreciation, and amortization (EBITDA); appropriate discount rates; and comparable company transactions. Significant Level 3 inputs include the financial condition of the Company, the earnings capacity of the Company, the guideline company method, and the marketability of the stock.

Interest-bearing Cash

As of December 31, 2024 and 2023, interest-bearing cash is classified as Level 2 in the fair value hierarchy. The interest-bearing cash is valued at the outstanding balance, which is the best estimate of fair value.
