**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the Higher Ground Education, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that was adopted by Higher Ground Education Inc. (the Company), effective January 1, 2016, and is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code of 1986 (IRC), as amended. The purpose of the Plan is to provide retirement benefits for all employees who meet the Plan's eligibility requirements. The Plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility**

Employees are eligible to participate in the employee deferral and employer discretionary matching contributions of the Plan after completing two consecutive months of service. Participants are eligible for a discretionary profit-sharing contribution if they meet the eligibility requirements above and are employed on the last day of the Plan year.

**Contributions**

Participants are automatically enrolled in the Plan with an initial deferral rate of 3%. Participants may opt out or change their deferral rates at any time. Participants may contribute up to 100% of their pretax annual compensation not to exceed the maximum deferral limitation, as defined in the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, which are presented as rollover contributions in the statement of changes in net assets available for benefits. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may elect to contribute after-tax contributions to a Roth account as defined by the Plan. In accordance with the plan document, the Company may make discretionary matching contributions and discretionary profit-sharing contributions to the Plan each year. The Company elected not to make any contributions for the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's discretionary match contribution, the Company's discretionary profit-sharing contribution, and allocations of plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants vest immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary profit-sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 20% vested each year after two years of service and is considered to be 100% vested after six years of credited service.

**Benefit Payments**

If a participant's employment ceases as a result of death or disability, the entire account becomes fully vested and the participant or the participant's beneficiary(ies) is entitled to receive the contents of the account. If participation is terminated for any other reason, the participant is entitled to receive only the vested percentage of the account. Participants or their beneficiaries may elect to receive benefits in a single lump sum or in installments. Vested balances less than \$1,000 may be distributed in a lump-sum amount without the participant's consent, and vested balances between \$1,000 and \$5,000 may be automatically rolled into a qualified individual retirement account in the participant's name without his or her consent. Additionally, under certain circumstances of financial hardship or upon attaining the age of 59½, participants are allowed to withdraw funds from the Plan.

**Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan. The majority of administrative expenses incurred by the Plan are absorbed by the Company except for service fees, which are deducted from the applicable participants' accounts.

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair value of investments.

**Forfeitures**

Forfeited nonvested accounts can be used to pay administrative expenses and to reduce future Company contributions. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$255 and \$71, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimated amounts.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value at December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains and/or losses are reported the day after the trade date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Brokerage fees are added to the acquisition costs of assets purchased and subtracted from the proceeds of assets sold.

**Payment of Benefits**

Benefit payments to participants are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION PREPARED AND CERTIFIED BY ASCENSUS TRUST COMPANY**

Certain information disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ascensus, LLC as agent for Ascensus Trust Company, the trustee of the Plan.

**NOTE 4 FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Fund:* Valued at its historical cost plus any accrued interest, which approximates fair value.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 RISKS, AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants would become fully vested in their accounts.

**NOTE 7 TAX STATUS**

The Plan is based on the Prototype Non-Standardized Profit Sharing Plan with Ascensus, Inc., which received an opinion letter from the Internal Revenue Service (IRS) stating that the prototype plan was designed in accordance with the provisions of the IRC. The Plan has not filed for its own determination letter from the IRS. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The related trust, therefore, is not subject to tax under present income tax law.

**NOTE 7 TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTIES IN INTEREST**

Plan investments in mutual funds and the money market account are managed by Vanguard, who also serves as an administrator of the Plan, and therefore, these investments qualify as party-in-interest transactions. The Plan also has a number of service providers. Such providers were parties in interest under ERISA.

**NOTE 9 NONEXEMPT TRANSACTION**

During 2024, the Company failed to remit employee 401(k) deferral contributions for one payroll period totaling \$38 within the time frame prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the IRC. The Company completed the process of correcting the prohibited transaction by depositing the lost earnings in September 2024.
