## Report of Independent Auditors

To the Plan Sponsor and Administrator of the

### **Baker & Hostetler LLP Basic/Step-Rate Retirement Plan**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan (“Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors’ Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

### 1. Significant Accounting Policies

#### **Investment Valuation and Income (Loss) Recognition**

The Baker & Hostetler Retirement Plan Master Trust (“Master Trust”) was established to provide a medium for commingling the assets of certain retirement plans sponsored by Baker & Hostetler LLP (“Firm”). The assets of the Master Trust were held by Fidelity Management Trust Company (“Trustee”). The Baker & Hostetler LLP Basic/Step-Rate Retirement Plan (“Plan”) had a divided interest in the Master Trust equal to the fair value of the participants’ account balances. Investment income (loss) and expenses were allocated to the Plan based on its participation in the investment options within the Master Trust. Accordingly, the Plan’s net investment income for the year ended December 31, 2024, includes its allocable share of the Master Trust’s interest, dividends and net appreciation. The Plan’s interest in the Master Trust was reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan’s valuation policies utilizing information provided by the Trustee. See Note 6 for discussions of fair value measurements.

With regard to investments and investment income (loss) recorded in the Master Trust, purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Capital gain distributions were included in dividend income. Net appreciation (depreciation) includes the Master Trust’s gains and losses on investments bought and sold as well as held during the year.

Effective December 31, 2024, in connection with the merger of the Plan into the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan, The Master Trust Agreement was merged out of existence (Note 9).

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### **Contributions**

Firm contributions are recorded in the year in which participant compensation is earned.

#### **Payment of Benefits**

Benefits are recorded when paid.

### 1. Significant Accounting Policies (continued)

#### Administrative Expenses

Certain expenses of the Plan are paid by the Firm and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and the benefit payment is recorded.

### 2. Description of the Plan

The following description of the Plan provides general information only. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

Effective December 31, 2024, the Plan was merged into the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan. In connection with the merger of the Plan, all participants ceased participation in the Plan December 31, 2024 (Note 9).

Prior to the Plan merger, the Plan was a defined contribution plan. The Plan covered eligible employees and partners of the Firm, but excluded attorneys-at-law employed as associates, of-counsel, counsel or staff attorneys. Eligible employees and partners became Plan participants on the January 1 or July 1 following the date they completed two (2) years of service and reached age 21. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan maintained a separate account for each participant. Participants directed the investment of all contributions into various investment options offered by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

## Notes to Financial Statements

### 2. Description of the Plan (continued)

For each participant who was not a partner, the Firm contributed an amount equal to 8% of the participant's pensionable compensation ("Compensation") (as defined in the Plan). Partners of the Firm were required by the Plan to fund their own contributions. Their contribution was calculated as the dollar limit on annual additions to a defined contribution plan under Internal Revenue Code ("IRC") 415(c)(1)(A) less the dollar limit on elective contributions under IRC 402(g)(3) divided by the maximum amount of compensation allowed under the IRC 401(a)(17) multiplied by partner Compensation. However, the total contribution was limited to the dollar limit on annual additions to a defined contribution plan less the dollar limit on elective contributions. For the year ended December 31, 2024, this formula resulted in a contribution equal to the lesser of 13.4% of partner Compensation or \$46,000.

Annual contributions to a participant's accounts under this Plan and other qualified retirement plans maintained by the Firm may not exceed the maximum limitations provided by the IRC.

Interest bearing loans of up to 50% of a participant's account could be requested, with a minimum request of \$1,000 and the maximum request not to exceed \$50,000 when considered with other loans from other plans sponsored by the Firm. Loans to participants were secured by the balance in the participant's account and bore interest at the prime rate in effect at the date of the loan. The repayment period could not exceed five (5) years.

A participant's account was immediately vested and was distributable at retirement or termination of service as follows: at retirement; at disability; at death; and at termination of service for any other reason. The participants had several options for receiving their distribution. A participant's account was distributable after attaining age 59 1/2 prior to termination or retirement. They could elect to receive payment in a lump sum, a partial lump sum payment without limit in terms of frequency or amount, in substantially equal annual installments over a period of time not to exceed ten (10) years, or through a schedule which will provide payments over a certain period of time which does not exceed their life expectancy. They could elect to receive a distribution of deferred amounts at any later time, but no later than April 1 of the year following the later of the year in which they reach age 73 or the year of retirement.

### 3. Income Tax Status

The Internal Revenue Service (“IRS”) determined and informed the Firm by a letter dated September 27, 2016, that the Plan and the related trust were designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believed that the Plan and related trust were designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there were no uncertain tax positions taken that would require recognition of a liability (or asset) or disclosures in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 4. Related-Party and Party-In-Interest Transactions

The Plan invested in mutual funds that were managed by Fidelity Investments. Fidelity Investments was related to the Trustee and, therefore, these transactions qualified as party-in-interest transactions which were exempt from the prohibited transaction rules.

#### 6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

*Commingled pool fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

### 8. Transfer In

In 2013, the recordkeeping agreement with the Trustee was amended to establish a Revenue Credit Account within the Plan which is funded quarterly based on revenue sharing on covered investments, as defined. The balance within the Revenue Credit Account may be used to reimburse the Firm for fees and expenses or pay such vendors directly for services provided to the Master Trust. Amounts not used to pay expenses of the Master Trust may be allocated to participants of the Plan and the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan. Amounts that are designated for allocation to participants are initially allocated to the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan and then a prorated amount is transferred to the Plan for allocation to participants. During 2024, the Plan received \$10,346 in revenue credits from the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan, which were allocated to participant accounts. The revenue credits received from the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan are reported in the financial statements as transfers in.

### 9. Plan Merger and Amendments

Effective December 31, 2024, the Plan was merged into the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan. Simultaneously, in connection with the merger of the plans, the Master Trust was amended to merge the sub-trust maintained for the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan into and with the sub-trust maintained for the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan effective December 31, 2024, and the surviving trust was redesignated as the Baker & Hostetler LLP 401(k) Retirement Plan Trust. Thus, all assets and liabilities of the Plan totaling \$510,769,981 were transferred to and became assets and liabilities of the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan.

Also, effective January 1, 2025, the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan was amended to, among other provisions, redesignate the Plan as the Baker & Hostetler LLP 401(k) Retirement Plan and incorporate certain provisions of the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan, which include fixed employer non-elective contributions on behalf of eligible participants.
