## Report of Independent Auditors

To the Plan Sponsor and Administrator of the

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of the Baker & Hostetler LLP Supplemental/401(k) Retirement Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements

### 1. Significant Accounting Policies

#### **Investment Valuation and Income (Loss) Recognition**

The Baker & Hostetler Retirement Plan Master Trust (“Master Trust”) was established to provide a medium for commingling the assets of certain retirement plans sponsored by Baker & Hostetler LLP (“Firm”). The assets of the Master Trust were held by Fidelity Management Trust Company (“Trustee”). The Baker & Hostetler LLP Supplemental/401(k) Retirement Plan (“Plan”) had a divided interest in the Master Trust equal to the fair value of the participants’ account balances. Investment income (loss) and expenses were allocated to the Plan based on its participation in the investment options within the Master Trust. Accordingly, the Plan’s net investment income for the year ended December 31, 2024, included its allocable share of the Master Trust’s interest, dividends and net appreciation. The Plan’s interest in the Master Trust was reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan’s valuation policies utilizing information provided by the Trustee. See Note 6 for discussions of fair value measurements.

With regard to investments and investment income (loss) recorded in the Master Trust, purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Capital gain distributions were included in dividend income. Net appreciation (depreciation) includes the Master Trust’s gains and losses on investments bought and sold as well as held during the year.

Effective December 31, 2024, in connection with the merger of the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan into the Plan, The Master Trust was merged out of existence (Note 10).

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### **Contributions**

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

#### **Payment of Benefits**

Benefits are recorded when paid.

### 1. Significant Accounting Policies (continued)

#### Administrative Expenses

Certain expenses of the Plan are paid by the Firm and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and the benefit payment is recorded.

### 2. Description of the Plan

The following description of the Plan provides general information only. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

The Plan is a defined contribution plan. The Plan covers all eligible employees and partners of the Firm. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligible employees and partners can participate on the later of their date of hire or the date they reach age 21. Eligible non-attorney staff members automatically participate in the supplemental portion of the Plan on the January 1 or July 1 following the date they have completed at least two (2) years of service with the Firm.

The Plan maintains a separate account for each participant. Participants direct the investment of all contributions into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Pursuant to a salary reduction agreement, a participant may elect to have the Firm make a contribution on the participant's behalf. The Firm did not elect to make any discretionary supplemental contributions to eligible participants as of December 31, 2024 and 2023. Annual contributions to participants' accounts under this Plan and other qualified retirement plans maintained by the Firm may not exceed the maximum limitations provided by the Internal Revenue Code ("IRC").

## Notes to Financial Statements

### **2. Description of the Plan (continued)**

Interest bearing loans of up to 50% of a participant's account may be requested, with a minimum request of \$1,000 and the maximum request not to exceed \$50,000 when considered with loans from this and other plans sponsored by the Firm. Loans to participants are secured by the balance in the participant's account and bear interest at the prime rate in effect at the date of the loan. The repayment period is not to exceed five (5) years.

A participant's account is immediately vested and is distributable at retirement or termination of service as follows: at retirement; at disability; at death; and at termination of service for any other reason. The participants have several options for receiving their distribution. A participant's account is distributable after attaining age 59 1/2 prior to termination or retirement. They may elect to receive payment in a lump sum, a partial lump sum payment without limit in terms of frequency or amount, in substantially equal annual installments over a period of time not to exceed ten (10) years, or through a schedule which will provide payments over a certain period of time which does not exceed their life expectancy. They may elect to receive a distribution of deferred amounts at any later time, but no later than April 1 of the year following the later of the year in which they reach age 73 or the year of retirement.

Although it has not expressed any intent to do so, the Firm has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

### **3. Income Tax Status**

The Internal Revenue Service ("IRS") has determined and informed the Firm by a letter dated October 10, 2017, stating that the Plan and the related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosures in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **4. Related-Party and Party-In-Interest Transactions**

The Plan invests in mutual funds that are managed by Fidelity Investments. Fidelity Investments is related to the Trustee and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

### 6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1     Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2     Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
  
- Level 3     Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

### 6. Fair Value Measurements (continued)

*Commingled pool fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Transfer Out

In 2013, the recordkeeping agreement with the Trustee was amended to establish a Revenue Credit Account within the Plan which is funded quarterly based on revenue sharing on covered investments, as defined. The balance within the Revenue Credit Account may be used to reimburse the Firm for fees and expenses or pay such vendors directly for services provided to the Master Trust. Amounts not used to pay expenses of the Master Trust may be allocated to participants of the Plan and the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan. Amounts that are designated for allocation to participants are initially allocated to the Plan and then a prorated amount is transferred to the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan for allocation to its participants. ### **10. Plan Merger and Amendments**

#### **Merger**

Effective December 31, 2024, the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan was merged into the Plan. Simultaneously, in connection with the merger of the plans, the Master Trust was amended to merge the sub-trust maintained for the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan into and with the sub-trust maintained for Baker & Hostetler LLP Supplemental/401(k) Retirement Plan effective December 31, 2024, and the surviving trust was redesignated as the Baker & Hostetler LLP 401(k) Retirement Plan Trust. Thus, all assets and liabilities of the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan totaling \$510,769,981 were transferred to and became assets and liabilities of the Plan.

Also, effective January 1, 2025, the Plan was amended to, among other provisions, redesignate the Plan as the Baker & Hostetler LLP 401(k) Retirement Plan and incorporate certain provisions of the Baker & Hostetler LLP Basic/Step-Rate Retirement Plan, which include fixed employer non-elective contributions on behalf of eligible participants.

### **11. Subsequent Events**

The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued and, except for the amendment disclosed in Note 10, no significant matters were identified for disclosure during this evaluation.
