**SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT**

We performed audits of the accompanying financial statements of the DFK Management, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1**    **DESCRIPTION OF PLAN**

The following description of the DFK Management, Inc. 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan Document and the Summary Plan Description for more complete information.

***General***

The Plan is a defined contribution plan that covers employees of DFK Management, Inc., Greenbrier Ford, Inc., Cavalier Ford of Portsmouth, LLC, Century Ford of Mt. Airy, Inc., Century CDJR, Inc., and Cavalier Automotive, LLC (collectively referred to as the Company) who elected to join the Plan. Employees who are at least 21 years old are eligible to participate in the Plan after completing one year of employment in which they perform at least 1,000 hours of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Each year, participants may contribute amounts of pretax annual compensation, as defined in the Plan, up to the maximum amount permitted under the Internal Revenue Code. Participants who are 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make discretionary matching or non-elective contributions.

***Investment Options***

Upon enrollment in the Plan, a participant may direct employee contributions into various investment options offered by the Plan. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

***Participant Accounts***

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*(See Independent Auditors' Report)*

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. A participant is fully vested in the Company's contributions after six years of credited service.

***Payment of Benefits***

Upon termination of service, a participant is entitled to receive a lump-sum amount equal to the vested portion of the participant's account.

***Forfeitures***

Forfeitures totaling \$10,562 were used to reduce the Company's matching contributions for the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$215 and \$3,609, respectively.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Company. In addition, the Company provides services to the Plan without charge.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the value of the interests of all participants and beneficiaries shall be determined and distributed to them in a lump sum.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Accounting Standards Codification***

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and

the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Valuation of Investments***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Risk and Uncertainties***

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

***Subsequent Events***

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 8, 2025, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan's investments were held by John Hancock Life Insurance Company, the Trustee of the Plan, at December 31, 2024 and 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. That information was not audited by the Plan's

**NOTE 4 VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is quoted on a private market that is not active; however, the share price is based on underlying investments which are traded on an active market.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 TAX STATUS**

The Company adopted the CCH Incorporated DBA ftwilliam.com Volume Submitter Profit Sharing Plan with a cash or deferred arrangement. The Plan received its latest determination letter on June 30, 2020 in which the Internal Revenue Service determined the Plan was designed and operated in accordance with the applicable sections of the Internal Revenue Code. Although the Plan was amended since receiving the determination letter, the Plan Administrator believes the Plan is designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan’s financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions as of December 31, 2024.

**NOTE 6 RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$98,100 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.
