Notes to Financial Statements

- 1. Description of the Plan** **General:** Clark Group Field Retirement Plan ("the Plan") allows eligible employees to participate in both a company contribution and a salary deferral, or 401(k), program. The Plan is a defined contribution plan. The Plan covers all hourly paid field employees (except those included in a unit covered by a collective bargaining agreement and leased employees) who have completed one year of service (as defined in the Plan document) with Clark Construction Group, LLC or certain affiliates ("the Company"). Employees are eligible for participation in the 401(k) and company contribution programs on the first day coincident with or following meeting the year of service requirement. The Plan also has a Davis-Bacon and Service Contract Act component which has no service requirement. Long-term part-time employees may also participate if certain conditions are met (as outlined in the Plan document).

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Company contribution program: Contributions under the Plan are made by each participating employer for each plan year in an amount as determined in the sole discretion of such employer's Board of Directors, in amounts of 0% to 10% of the total annual eligible compensation paid to participants of that employer. Contributions are allocated to each participant of each employer in the proportion that his or her eligible compensation for the year bears to the total eligible compensation of all participants of that employer. Participants are eligible to receive an allocation if 1,000 hours of service are completed in the Plan year unless termination is due to death, disability, or normal or early retirement.

Davis-Bacon and Service Contract Act contributions are made by participating employers based on the prevailing wage contracts, and the contributions are allocated directly to employees covered by the contracts.

Contributions in the company contribution program of the Plan are invested in the Clark Company Contribution Fund. Investments within the Clark Company Contribution Fund are invested at the discretion of the Plan Trustees.

Notes to Financial Statements

The assets in the Clark Company Contribution Fund are held in a master trust (see Note 5).

Participants who have attained age 59 ½ may direct the investment of some or all of their balance in the Clark Company Contribution Fund into the investment options available under the 401(k) program.

Employees do not become vested in their company contribution accounts and earnings thereon until the third year of service is completed, at which time they become 100% vested. Employees are always 100% vested in their Davis-Bacon and Service Contract Act contribution accounts and earnings thereon.

Forfeitures of nonvested amounts are used to reduce future contributions by the participating companies. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$149,799 and \$166,527, respectively. For 2024, the employer contribution to the company contribution program was reduced by forfeitures of \$80,000 and \$32,118 was used to reinstate participant accounts.

401(k) program: Under the 401(k) program, participants may contribute up to 50% of their compensation on a pretax basis subject to Internal Revenue Service contribution limits. Participating companies make a matching contribution in an amount equal to 50% of the participant's contribution up to a maximum deferral of 5% of the participant's eligible compensation. Employees are eligible for matching employer contributions on the first day coincident with or following meeting the year of service requirement. Each temporary employee who completes 500 hours of service in three consecutive computation periods, as defined in the Plan document, shall be eligible to contribute pretax contributions.

The above contributions are invested, at the discretion of the participant, in any of 31 funds available under the Plan. Therefore, each participant's earnings are dependent upon the performance of the selected fund(s).

Salary deferral contributions and employer matching contributions are 100% vested to the participant.

Payment of benefits: Benefits provided by the Plan are paid from net assets available for benefits. The benefit to which a Plan participant is entitled is the benefit that can be provided by the contributions and earnings and losses thereon allocated to such participant's account. Benefit payments are made upon separation, retirement at age 65, early retirement at the age of 60 with 20 years of service, total and permanent disability, or death. Hardship withdrawals and inservice withdrawals at age 59½ are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loans are not permitted from the Clark Company Contribution Fund. Participant loans bear interest at the Wall Street Journal prime rate of interest plus 1%, determined at the time the loan is requested. Loans are secured by the participant's account, have a maximum term of five years, and are recorded as notes receivable from participants in the accompanying financial statements. Participants actively employed by the Plan sponsor pay back their loans through payroll deduction. Terminated employees may elect to make monthly payments directly to the Plan custodian.

Participant accounts transferred to affiliate plan: The Company maintains a separate retirement plan for office employees. As employment classifications change, the account balances of the affected employees are transferred to the appropriate plan. The net impact of those transfers in 2024 amounted to \$531,540 transfers out of the Plan.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan have been prepared under the accrual method of accounting, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Investment valuation and income recognition: Investments and investments in the Clark Group Master Trust ("Master Trust") are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Participant contributions and matching contributions are recognized in the period the participant contribution is withheld from compensation. Discretionary contributions are recognized in the period the related eligible compensation is paid to the participant.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and certain distribution administration fees are charged directly to the participant's account and are included in administrative expenses. Participants are also charged a quarterly fee for recordkeeping. These fees are included in administrative expenses.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through October 2, 2025, which is the date the financial statements were available to be issued.

3. Investment information certified by custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants and Plan interest in Clark Group Master Trust held at December 31, 2024 and 2023, and interest and dividend income, net appreciation in fair value of investments, net investment gain from Plan interest in Clark Group Master Trust and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the custodian of the Plan.

5. **Plan interest in Clark Group Master Trust** The Plan participates in the Clark Group Master Trust along with the Clark Group Retirement Plan. Both plans have a divided interest in the Master Trust. Vanguard Fiduciary Trust Company ("Vanguard") serves as the Master Trustee.

6. Fair value measurements

The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

401(k) program assets: Mutual funds are valued at quoted market prices. The fair value of the collective trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trusts is used as a practical expedient to estimate fair value and is determined by the trustee of the funds based on the fair value of underlying assets in the trusts, less its liabilities.

Company-directed withdrawals that will exceed one million dollars from the MFS Growth Equity Fund or MFS Mid Cap Value Fund require a five business day advance written notice to the trustee of the fund. There are no other withdrawal limits, redemption frequency limits or redemption notice periods for these investments.

Clark Company Contribution Fund: Clark company contributions are invested in a custom portfolio consisting of several underlying mutual funds and collective trusts at target allocations specified by the Trustees of the Plan. This fund is held in the Clark Group Master Trust. The objective of the fund is to provide real growth of assets over time while protecting the value of the assets from undue volatility or risk of loss. Vanguard calculates a unit value each business day by dividing assets less liabilities by the number of units outstanding. The fair value of shares of mutual funds within the fund is based on quoted net asset values on the last business day of the Plan year. The collective trusts are valued using NAV as a practical expedient. Purchases and sales of the fund for participant transactions occur at the unit value. As such, the Clark Company Contribution Fund is reported at the NAV as a practical expedient. There are no withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for this investment as of December 31, 2024 and 2023.

7. Tax status

The Internal Revenue Service ("IRS") has determined and informed the Plan administrator by letter dated August 4, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- 8. Plan termination** The Company intends to maintain the Plan on a permanent basis; however, the Plan can be terminated or amended by action of the Managers of the Company at any time in the future subject to the provisions of ERISA. Amendments to the Plan will not retroactively reduce Plan participants' vested rights. In the event of Plan termination, all employees affected by the Plan termination will become immediately 100% vested in their account balances unless the Plan is replaced by a comparable plan.
- 9. Risks and uncertainties** The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.
- 10. Party-in-interest transactions** Certain Plan investments were managed by Vanguard, the custodian of the Plan. The Plan paid certain expenses related to Plan operations and investment activity to Vanguard. These transactions qualify as exempt party-in-interest transactions.
