Basis for Opinion

NOTES TO FINANCIAL STATEMENTS DDECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Crouse Community Center Employee Retirement TSA Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution plan covering all employees of Crouse Community Center, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the sponsor of the Plan. Nationwide Trust Company, FSB a division of Nationwide Bank is the custodian of the Plan's assets.

Eligibility

Employees are eligible to participate in the elective deferrals portion of the Plan immediately upon hire. Substantially all employees who have completed six months of service and have reached the age of 21 are eligible to participate in the employer match portion of the Plan.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Company contributes a matching contribution equal to 25% of the first 4% of salary deferral. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings and losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant is 100% vested at all times in their account.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 from their individual accounts up to the lesser of \$50,000 or 50% of their vested balance. Participants may not have more than one loan outstanding at any time. The term of the loan may not exceed 5 years, unless the loan shall be used for the purpose of acquiring a primary residence for the participant, in which case the maximum term of the loan is 15 years. The loans are collateralized by the vested balance in the participant's account and bear interest at the prime rate which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

1. DESCRIPTION OF PLAN (Continued)

Payment of Benefits

A participant is entitled to a distribution following termination from employment. On termination of service, the Plan will make a mandatory distribution of the participant's account balance, including rollover contributions, up to a maximum of \$5,000. Participants who receive a distribution other than a mandatory distribution may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, one of several forms of annuity options, or a series of installments selected by the participant.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from participant accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, currency, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for loan losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Allowance for Credit Losses

The Plan records a receivable for the employee and employer contributions that are remitted to the Plan after the Plan's year end. The Plan recognizes an expected allowance for credit losses that is updated to reflect any changes in credit risk since the receivable was initially recorded. The estimated allowance for credit losses is based on historical, current, and expected future conditions. No significant improvements or deteriorations are expected in the future economic conditions; therefore management has determined that no allowance for credit losses is necessary for the years ended December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Payment of Benefits

Benefits paid to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain other fees related to the administration and participants loans are included in administrative expenses.

Fair Value Measurement - Definition and Hierarchy

Fair Value Measurement framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 Inputs - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 Inputs - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.
- Level 3 Inputs - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The Plan's investments in mutual funds are valued utilizing Level 1 inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in the valuation methodologies used during 2024 or 2023.

Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. INVESTMENTS

The following information was certified as complete and accurate by Nationwide Trust Company, FSB (Nationwide), the custodian of the Plan and is included in the accompanying financial statements and supplemental schedule:

5. PARTY-IN-INTEREST TRANSACTIONS

Nationwide is the custodian of the Plan's investment assets. Consequently, these transactions between Nationwide and the Plan qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will continue to be 100% vested in their accounts.

7. INCOME TAX STATUS

The Plan is exempt from federal income tax under Section 403(b) of the IRC. Beginning in June 2013, the IRS will accept applications for opinion and advisory letters regarding the acceptability under 403(b) of the IRC of the form of prototype plans and volume submitter plans. The Plan document is based on a Nationwide prototype plan; however, Nationwide has not yet submitted an application to the IRS for determination.

7. INCOME TAX STATUS (Continued)

The Plan is required to operate in conformity with the IRC to maintain its tax-exempt status for Plan participants. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.
