Note 1. Description of Plan

The following description of the Jordan Foster Companies 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan generally provided for employees of Jordan Foster Construction, LLC (the Company) who are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective February 16, 2010, the Plan elected to be treated as a "safe harbor" plan under Section 401(k) of the Internal Revenue Code.

Administration of Plan Assets: The Plan is administered by Jordan Foster Construction, LLC (the Plan Administrator). The Plan's assets, which consist principally of mutual funds, are held by the Fidelity Management Trust Company (Trustee). Contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Contributions: All eligible employees may voluntarily contribute a specific amount or a percentage of their pretax compensation, as defined in the Plan, up to the maximum amount allowable under Internal Revenue Code limitations. Participants may also elect to make contributions to the Plan on an after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Total contributions are subject to Internal Revenue Service limitations. Participants direct the investment of their accounts to selected investment funds as made available and determined by the Plan Trustee and adopted by the Plan Administrator. Participants may change their allocation in investment options at any time, via direct phone and internet access to the Trustee.

The Company makes matching contributions under the safe harbor election. For 2024, the safe harbor matching contribution matched participant pre-tax contributions (including catch-up contributions) dollar for dollar, at a rate of 100% to the extent that such contributions did not exceed 3% of eligible compensation and 50% to the extent that such contributions exceeded 3% but do not exceed 5% of eligible compensation.

The Company may also make a discretionary non-elective matching contribution at the end of the Plan Year in an amount determined by the Company's Board of Directors. To be eligible for discretionary employer contributions, employees must complete at least 1,000 hours of service during the plan year and be employed as of the last day of the plan year. No discretionary contributions were made for the plan year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contribution and the Company's safe harbor matching contributions plus earnings thereon. Vesting in the Company's discretionary non-elective contributions is based on years of continuous service as follows:

Notes Receivable from Participants: Participants may borrow from their investment accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with national prevailing rates, as adopted by the Plan Administrator, currently ranging from 4.25% to 9.50% on loans outstanding. Participants are allowed to have only one loan outstanding at any given time. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Loans must be repaid within 5 years, unless the loan is used for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: Participants are eligible for benefit payment upon termination of employment, disability, death, or normal retirement after attaining age 59 1/2. A participant may elect to receive the value of the participant's vested interest in his or her account either in (1) a lump-sum amount, (2) installments over a certain period not extending beyond the life expectancy of the participant, (3) installments over a certain period not extending beyond the joint and last survivor's life expectancy, or (4) fixed or variable installments to equal or exceed any required minimum distributions until the balance of the account is depleted.

Forfeitures: Forfeited, non-vested account balances at December 31, 2024 and 2023 totaled \$534 and \$1,027, respectively. As specified in the Plan documents, forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Note 3 of these financial statements discusses the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivables from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued and found no additional events to disclose.

Note 3. Fair Value Measurements

FASB ASC 820-10-35, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820-10-35 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the net asset value (NAV) of shares, which is based on quoted prices for identical assets in active markets, held by the plan at year end.

Self-directed brokerage: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

Collective-trust: A fund that is composed primarily of investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities will be carried out in an orderly business manner.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Investment in Fully Benefit-Responsive Investment Contract

The Plan invests in the Managed Income Portfolio Class 1, a stable value collective trust fund that is considered a fully benefit-responsive investment contract. In accordance with ASC 962, the investment is reported at contract value in the Statements of Net Assets Available for Benefits. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment was \$373,824 and \$325,867 as of December 31, 2024 and 2023, respectively.

Note 5. Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Except for after tax fees, express mail service and loan origination fees associated with notes receivable from participants, administrative expenses of maintaining the Plan are paid by the Company.

Note 6. Information Certified by the Trustee

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the value of investments and notes receivables which were \$34,118,176 and \$889,886 as of December 31, 2024 and \$29,041,863 and \$802,134 as of December 31, 2023 certified by Fidelity Management Trust Company, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental schedule.

The Trustee also certified to the completeness and accuracy of \$1,383,841 of dividends and interest income related to the aforementioned investments and notes receivable for the year ended December 31, 2024, and a change of \$2,754,330 in net appreciation in investments, including gains and losses on investments bought and sold, as well as held during the year.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 8. Tax Status

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator

believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The

Plan Administrator believes the Plan is no longer subject to income tax examinations for plan years prior to 2021.

Note 9. Related Party Transactions

Certain plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The administrative fee paid to Fidelity Management Trust Company was \$31,746 for the year ended December 31, 2024.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
