NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Synergy Flavors, Inc. 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Synergy Flavors, Inc. (Company or Employer) and all U.S. employees of its subsidiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended by subsequent legislation. Principal Life Insurance Company serves as the custodian and recordkeeper of the Plan.

The Plan was adopted on January 1, 1986, and subsequently restated or amended. The most recent amendment, effective May 8, 2023, amended the Plan to allow voluntary after-tax contributions up to a maximum of 6% of eligible compensation.

Eligibility

All employees of the Company are eligible to participate in the Plan upon attaining the age of 18 years. Employees may enroll monthly.

Contributions

Participants may elect to contribute to the Plan a percentage of their annual compensation, as defined in the Plan, subject to Internal Revenue Service limitations. Effective May 8, 2023, the Plan was amended to allow voluntary after-tax contributions of up to 6% of eligible compensation. Eligible compensation for any plan year shall not exceed the maximum provided by the Internal Revenue Code (IRC). Age 50 and over participants can contribute an additional \$7,500 in 2024. A participant's account may include contributions made to another plan and transferred to the Plan as part of a rollover contribution.

Unless specifically declined, eligible employees are automatically enrolled into the Plan at a contribution rate of 4% of pre-tax compensation with an automatic increase of 1% annually, up to a maximum of 10% and participants are permitted to designate a portion, or all of the deferral contributions made as Roth 401(k) contributions.

All employees who are active participants in the Plan are eligible for matching contributions on the first day of the month after they are hired. The Company contributes 100% of the first 4% of eligible compensation that a participant contributes to the Plan. Discretionary contributions are made for all employees who are active participants on December 31 each year. Discretionary profit-sharing contributions are computed in accordance with the terms of the Plan and may be made at the discretion of the Company. The Company did not make any discretionary profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of: a) the Company's matching and discretionary contributions, and b) plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Company match and discretionary profit-sharing contributions in accordance with the table below. Participants are also fully vested if employed with the Company upon reaching age 65, becoming permanently disabled or at death.

Forfeitures

Forfeitures are first applied to Plan expenses and any remaining amounts will reduce the earliest Employer contributions made after the forfeitures are determined. At December 31, 2024 and 2023, \$294 and \$0, respectively, were available for future use and have been allocated to plan assets. Forfeitures of \$93,897 were used to reduce Employer contributions and pay administrative expenses in 2024.

Notes Receivable From Participants

The Plan allows loans to be taken out by plan participants. These loans are secured by participants' account balances. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by any outstanding loan balance. The participant must sign a promissory note for the loan. The participant may have only two loans outstanding at a time. The loan period cannot exceed five years unless the proceeds of the loans are used to purchase a primary residence for which the loan period shall not exceed 15 years. The loans bear interest at rates commensurate with current interest rates used by the lending industry.

Payment of Benefits

If a participant retires, the balance of the participant's account is payable at his/her option in either a lump sum or a rollover into a qualified plan or IRA, unless the participant's balance in the Plan is less than \$1,000, in which case the participant will receive a lump-sum distribution. If the balance is between \$1,000 and \$5,000, Principal Life Insurance Company automatically establishes an IRA account for the employee. Upon death or termination of a participant, the trustee of the Plan advises the beneficiary or participant of the various methods of distribution of the participant's account available to the participant or his/her beneficiary.

Participants are allowed to make in-service withdrawals from their vested interest in the Plan prior to age 59½ for reasons of financial hardship.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets, the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEES

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, Principal Life Insurance Company, and Principal Global Investors Trust Company, the trustees of the Plan, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

U.S. GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in active markets;
- Inputs other than quoted prices that are observable for the assets or liability' and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for instruments measured at fair value and their classification in the valuation hierarchy as of December 31.

Registered investment companies

The Plan's investments in registered investment companies are valued at quoted market prices of shares held by the Plan at year end.

Collective trusts and pooled separate accounts

The Plan's investments in collective trusts and pooled separate accounts are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each fund less its liabilities. The Plan's interest in the collective trust fund is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end. The Plan held various synthetic investment contracts in which the underlying investment consisted of units of various collective trust funds. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the Plan level. There are no unfunded commitments at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies

NOTE 5 - TAX STATUS

The Plan operates under a non-standardized adoption agreement in connection with a prototype profit sharing plan and trust sponsored by Principal Life Insurance Company. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter dated March 31, 2014, from the Internal Revenue Service (IRS) stating that the prototype constitutes a qualified plan under Section 401 of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable

requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust was tax exempt as of the financial statement date.

Effective with the restatement in 2021, the Plan began operating under an adoption agreement in connection with a volume submitter profit sharing plan sponsored by Principal Life Insurance Company. This volume submitter profit sharing plan has been filed with the appropriate agency and the plan sponsor has obtained an opinion letter dated June 30, 2020, from the IRS stating that the volume submitter profit sharing plan constitutes a qualified plan under Section 401 of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants would become 100% vested in their employer contributions.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Principal Life Insurance Company. Principal Life Insurance Company is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for legal, accounting and other professional services were rendered primarily by parties-in-interest. Administrative expenses paid by the Plan totaled \$89,305 in 2024. Additionally, the Plan has loans to participants that also qualify as party-in-interest transactions.

NOTE 9 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
