Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sun Terminals, Inc. 401(k) Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF PLAN

The following description of Sun Terminals, Inc. 401K Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) deferred compensation plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by a trustee appointed by Management of Sun Terminals, Inc. (the “Company”). The Plan was established effective January 1, 2018.

Eligibility

To become eligible; participants must be employees of the Company, be at least 21 years of age, and have completed three (3) months of service.

Contributions

Participants may elect to make voluntary pre-tax contributions of annual compensation including regular salary and wages, overtime pay and commissions through payroll deductions. Such contributions are excluded from the participant’s taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan. All contributions are subject to certain limitations established by the Internal Revenue Service. The maximum pre-tax contribution for the year ended December 31, 2024 and 2023 was \$23,000 and \$22,500, respectively. Additionally, if a participant has attained age 50, the participant is eligible to make an additional catch-up contribution which cannot exceed \$7,500 in 2024 and 2023.

The Plan includes an automatic salary deferral feature, which begins on the first payroll following the completion of an eligible participant’s three (3) months of employment with the Company. The Company will automatically withhold one percent (1%) of a participant’s compensation from each payroll period and contribute that amount to the Plan as a Pre-Tax 401(k) deferral, however; participants may increase or decrease their deferral at their option.

The Company will make a matching contribution equal to 100% of a participant’s elective deferral but not to exceed 4% of the participant’s eligible earnings.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account or half of your vested interest in the Plan.

Participant Loans

Participants may borrow a minimum of \$500 from their fund accounts and up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past twelve months. Loans are secured by the balance in the participant’s account. Loans must bear a reasonable rate of interest, not to exceed the legal limit. The interest rate is determined by the trustee and is reevaluated every quarter. As of December 31, 2024, interest rates on outstanding participant loans were between 4.25% and 10.50%. Principal and interest is paid ratably through payroll deductions. The maximum number of loans outstanding per participant at any one time is one.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is determined under the following schedule:

To earn a year of service, participants must be credited with at least 12-month period of service during the plan year.

A participant will also be 100% vested under any of the following circumstances:

- Death before retirement date.
- Disability before retirement date.
- Attainment of normal retirement age.
- Termination of the Plan.

In addition, a participant is immediately 100% vested in any amount which has been transferred or rolled over into the Plan from another qualified employee benefit plan.

Payment of Benefits

Participants may receive an amount equal to the value of their vested interest upon termination of employment, death, disability or retirement. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest, or annual installments over a ten year period. For termination of service due to other reasons, a participant may receive the value of the vested interest as a lump sum distribution.

Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America. In September 2009, the Financial Accounting Standards Board ("FASB") implemented the Accounting Standards Codification ("ASC") which establishes FASB ASC as the source of authoritative U.S. accounting and reporting standards for nongovernmental entities. Presented below is a summary of significant accounting principles followed in the preparation of the accompanying financial statements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions to net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants / Participant loans

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. At December 31, 2024 and 2023, notes receivable from participants were \$187,125 and \$110,545, respectively.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain expenses to maintain the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the Company. Investment related expenses are included in net appreciation of fair value of investments.

Income Taxes

The Plan is an adoption of a prototype plan. The prototype sponsor (ADP, LLC) received a favorable determination letter, in which the Internal Revenue Service stated that the prototype plan, as then designated, was in compliance with applicable requirements of the Internal Revenue Code (the "IRC").

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan's initial year was 2018. Accordingly, the Plan is not subject to income tax examination by taxing authorities prior to 2021.

Risk and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amount reported in the Statements of Net Assets Available for Plan Benefits and Statement of Changes in Net Assets Available for Plan Benefits.

Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025 the date the financial statements were available to be issued.

NOTE 3 – CERTIFYING ENTITY INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the certifying entity of the Plan.

NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company is the certifying entity of the Plan and qualifies as a party-in-interest per Department of Labor guidelines. All fees and expenses of the Plan relating to legal, accounting, and other administrative services are paid by the Company.

NOTE 5 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

ASC 820 establishes a three-level valuation hierarchy for measurement and disclosure of fair value. The valuation hierarchy is based upon the transparency of inputs used to measure fair value. The three levels are as follows:

Level 1 – asset value is based on actual quoted prices in active markets for identical securities (mark-to-market).

Level 2 – other significant observable inputs are used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.).

Level 3 – significant unobservable inputs (including management’s own assumptions in determining the fair value of investments).

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at contract value (which is deemed to be fair value) minus early withdrawal charges and categorized as a Level 2 fair value measurement. Contract value represents the amount that would have been paid if the contract had been terminated on December 31, 2024. The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been provided and certified to as complete and accurate by the trustee.

The Plan’s investments at December 31, 2024 and 2023 are reported at fair value in the accompanying statement of net assets available for benefits.
