### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

### Note 1 – Plan Description

---

The following description of TMEIC Corporation Americas 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees of TMEIC Corporation Americas (the “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor is the Plan Administrator. Assets of the Plan are held at Fidelity Management Trust Company as of December 31, 2024 and 2023 and for the year ended December 31, 2024. The Plan adopted a pre-approved plan document developed by Fidelity Management Trust Company, the Trustee, effective June 1, 2022.

#### *Contributions*

Participants may contribute up to 100% of their eligible compensation on a pre-tax, Roth and after-tax basis as defined by the Plan subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in the amount of \$7,500 into the Plan as a pre-tax contribution subject to certain IRS limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor made matching contributions of 60% of a participant’s contribution, up to 6% of eligible compensation and a safe harbor employer contribution equal to 3% of participants’ compensation. The Plan Sponsor may make a discretionary profit sharing contribution. During 2024, no discretionary contributions were made by the Plan Sponsor.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution, Plan Sponsor’s matching, safe harbor and discretionary contributions, Plan earnings, and charged with participant distributions and an allocation of administrative expenses. Earnings are allocated by fund based on the ratio of a participant’s account invested in a particular fund to all participants’ investments in that fund.

The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan Sponsor’s matching and safe harbor contributions are allocated based upon participants’ contributions to the Plan. The Plan Sponsor’s discretionary contribution is allocated based on the ratio of each participant’s compensation for the Plan year compared to the total compensation of all participants for the Plan year.

#### *Vesting*

Participants are 100% vested in all contributions immediately upon entering the Plan.

#### *Forfeitures*

Forfeited non-vested amounts related to excess Plan Sponsor contributions at December 31, 2024 and 2023 were \$3 and \$26, respectively. There were no forfeited non-vested amounts used to reduce Plan Sponsor contributions and \$146 was used to pay Plan expenses during the year ended December 31, 2024.

### *Notes Receivable from Participants*

Participants may borrow from the vested portion of their accounts an amount not less than \$500 and not more than the lesser of 50% of the vested balance or \$50,000. Notes receivable from participants terms range from one to five years (some terms may be extended when the borrowing is used in the purchase of a primary residence). A note receivable from a participant is secured by the balance in the participant's account and bears interest at a rate commensurate with market rates for similar borrowings, as defined in the Plan. Interest rates on notes receivable from participants at December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

### *Investment Options*

Participants direct the Trustee of the Plan as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time. Transfers of account balances between elected investment options may also be made at any time.

### *Benefit Payments*

Distributions to participants can be made due to retirement, death, disability, attainment of age 59½ or termination of employment and are subject to the applicable provisions of the Plan agreement. Up to 100% of the participant's account balance can be paid as a direct rollover to another qualified plan or as a lump sum to the participant or their beneficiaries.

Upon showing of "financial hardship," a participant may withdraw part or all of their deferral contributions, matching contributions, and profit sharing contributions. The Plan's provisions for hardship withdrawals comply with the Bipartisan Budget Act of 2018.

### *Administrative Expenses*

Certain of the Plan's administrative expenses, which include primarily custodial, investment management, and professional fees for services provided by parties-in-interest, are paid by the Plan Sponsor, as provided in the Plan agreement.

## **Note 2 – Summary of Significant Accounting Policies**

---

### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### *Payments of Benefits*

Benefit payments are recorded when paid to participants.

## **Note 3 – Trustee's Certification**

---

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information was certified as complete and accurate by Fidelity Management Trust Company, the Plan's Trustee. That information is as follows:

## **Note 4 – Collective Investment Funds**

---

The Plan invests in a collective investment fund with Galliard. The fund's principal objective is to provide investors with a moderate level of stable income without principal volatility. To achieve this, the fund invests in instruments which are not expected to experience significant price fluctuation in most economic or interest rate environments. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Galliard. The Plan is permitted to redeem investment units at Net Asset Value (NAV) for participant-directed transactions on the measurement date. There are no reserves against NAV for credit risk of the contract issuer or otherwise.

The Plan also invests in target date collective investment funds with Manning & Napier. These funds' principal objectives are to provide capital growth and manage risk for investors planning to retire around the year indicated in each fund's name and are managed to gradually become more conservative over time as they approach their target date. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Manning & Napier. The Plan is permitted to redeem investment units at their NAV for participant-directed transactions on the measurement date. There are no reserves against NAV for credit risk of the contract issuer or otherwise.

---

### Note 5 – Plan Termination

---

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

---

### Note 6 – Income Tax Status

---

The IRS has issued an opinion letter dated June 30, 2020, stating that the pre-approved plan document used by the Plan was designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions.

---

### Note 7 – Fair Value Measurements

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. Since the NAV is used as a practical expedient to estimate fair value, these investments are excluded from the fair value hierarchy.

### Note 8 – Investment Contracts

The Plan has investments in the Galliard Stable Return Fund E. The fund primarily invests in investment contracts and security-backed contracts issued by financial institutions. These contracts are considered to be benefit-responsive and are required to be stated at fair value. The average yield for these funds was approximately 4.88% and 4.92% for 2024 and 2023, respectively. The yield earned by the funds with an adjustment to reflect the actual interest rate credited to participants at December 31, 2024 and 2023 was 3.35% and 2.93%, respectively.

The objective of the fund is to provide investors with a moderate level of stable income without principal volatility. However, there is no assurance that this objective will be achieved.

### Note 9 – Party-in-Interest Transactions

As of December 31, 2024 and 2023, certain of the Plan's investments are funds managed by Fidelity Management Trust Company ("Fidelity"), the Plan's Trustee, and therefore these transactions qualify as party-in-interest transactions. In addition, notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants.

Fidelity provides certain administrative services to the Plan pursuant to a Retirement Plan Services Agreement (the "Agreement") between the Plan Sponsor and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the Agreement, Fidelity remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing. Administrative expenses are reported net of revenue sharing of \$29,747 for 2024.
