NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Mid-West Presort Mailing Services, Inc. (the "Company") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Company who have six consecutive months of service and are age twenty-one or older, excluding leased employees. It was established on January 1, 1999 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participation in the Plan is voluntary. Participants may elect to defer up to \$23,000 and \$22,500 of their salary annually during the years 2024 and 2023, respectively, to be contributed to the Plan. In addition to this, participants who are age 50 or older as of December 31 are eligible to make additional "catch up" contributions of up to \$7,500 in 2024 and 2023. The Plan also allows after-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation. During 2024 and 2023, the Company made a matching contribution of 25% of each participant's contribution, not to exceed 4% of compensation.

Participant Accounts

Participants direct investment allocations into the various investment options offered by the Plan. These options include a variety of mutual funds including equity funds, bond funds, target maturity funds, specialty funds and cash equivalents. Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and plan earnings, and is charged with an allocation for administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, including rollover contributions, and in the actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service. A participant is 100% vested in employer discretionary contributions after six years of credited service. All safe harbor contributions are fully vested at the time the contribution is made.

Notes Receivable From Participants

Participants may borrow from their fund accounts up to 50% of their vested account balance (excluding Roth deferrals), not to exceed \$50,000. These notes are secured by the balance in the participant's account and bear interest at a rate of between 4.25% and 9.50%, which is commensurate with the prime rate plus 1% at the time the note was approved. Principal and interest payments are generally made on these loans through payroll deductions.

Note 1. Description of the Plan (Continued)

Payment of Benefits

On termination of service due to death, disability or retirement, a participant immediately becomes 100% vested in their account balance. Participants may elect to receive either a lump-sum amount or an annuity contract for payment of benefits. For termination of service due to other reasons, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution or in installments. Account balances under \$5,000 must be paid in a single lump sum.

Operating Expenses

Certain operating expenses associated with maintaining the Plan are paid by the Company.

Forfeited Accounts

If, upon termination of employment, a participant is not 100% vested in his or her account balance, such non-vested portion will become forfeited. These forfeited accounts will be reallocated to participants in the same manner as employer contributions. At December 31, 2024 and 2023, there was \$2,105 and \$1,522, respectively, of forfeited non-vested accounts. There was \$-0- and \$12,534 of forfeitures reallocated to participants during 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

- A. Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- B. Use of Estimates – The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.
- C. Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan held no fully benefit-responsive investment contracts as of December 31, 2024 or 2023.

- D. Contributions – Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Note 2. Summary of Significant Accounting Policies (Continued)

- E. Notes Receivable from Participants – Notes receivable from participants are measured and reported at the unpaid principal balance plus and accrued but unpaid interest. Interest income is recorded on the accrual basis. The Plan has determined that no allowance for uncollectible notes receivable is required as of December 31, 2024 and 2023. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment.
- F. Excess Contributions Payable – Amounts payable to participants totaling \$-0- and \$985 as of December 31, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS"), were recorded as liabilities. The Plan distributed these excess contributions to the applicable participants prior to March 15th of the following year.
- G. Payment of Benefits – Benefits are recorded when paid.
- H. Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Loan and other processing fees charged by the trustee are charged directly to the participant's account and included in administrative fees. Investment related expenses are included in net appreciation in fair value of investments.
- I. Subsequent Events – The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Cash equivalents consist of cash and short-term investment funds that maintain daily liquidity and have a constant unit value of \$1, and are classified as Level 1 instruments.
- Mutual funds are valued based on closing market prices in active markets for identical investments are classified as Level 1.

Note 4. Certified Information

Ascensus Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of the investments and notes receivable from participants reflected in the statements of net assets available for benefits at December 31, 2024 and 2023, the related investment activity reflected in the statements of changes in net assets available for benefits for the years then ended, the supplemental schedule of assets (held at end of year) for the year ended December 31, 2024, and investment related information in the accompanying notes to the financial statements.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6. Tax Status

The IRS has determined that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Note 8. Related Party and Party in Interest Transactions

The Company provides the Plan with certain accounting, recordkeeping and administrative services for which it receives no compensation. Notes receivable from participants included a note receivable from a shareholder of the Company, totaling \$-0- and \$6,575 as of December 31, 2024 and 2023, respectively.

Merrill Lynch provides certain administrative services to the Plan. Merrill Lynch receives revenue from mutual fund service providers for services it provides to the funds. This revenue is used to offset certain amounts owed for its administrative services to the Plan. If the revenue received by Merrill Lynch from such mutual fund service providers exceeds the amount owed by the Plan, it remits the excess to the Plan on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. The Plan or Company may make a payment for administrative expenses not covered by revenue sharing.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
