- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the First Gilmer Bankshares Employee Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering full-time employees of First National Bank of East Texas (Company) who are age 18 or older. Employees are eligible to participate in salary deferrals after a ninety-day waiting period. Participants are eligible for matching and profit sharing contributions upon completion of one year of service and 1,000 hours. Entry dates for matching and profit sharing contributions will be the first day of the Plan year or the first day of the seventh month of the Plan year coinciding with or next following the date on which eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). First National Bank of East Texas is the Plan sponsor.

**PLAN ADMINISTRATION**

The managers of the Plan sponsor appoint the Plan Administrator and Plan Trustees. The Plan Administrator and Plan Trustees are employees of the Company.

The custodian of the Plan, Empower Trust Company, LLC (Empower), is responsible for managing the Plan's investment assets. Alliance Benefit Group performs the Plan's administrative duties such as preparation of the Form 5500, participant recordkeeping, and compliance testing. Employees of the Company may perform certain other administrative functions; however, such employees receive no compensation from the Plan.

**CONTRIBUTIONS**

Participants may elect to contribute tax-deferred or after-tax (Roth) amounts up to 75% of eligible compensation, as defined by the Plan, not to exceed maximum limitations imposed by the Internal Revenue Code (IRC). Pursuant to the IRC 414(v), participants who reach age 50 before the close of the Plan year may make catch-up contributions, subject to limitations imposed by the IRC. Rollover contributions from qualified plans are allowed. Participants direct the investment of contributions into various investment options offered by the Plan.

The Company may make two types of contributions to the Plan: (1) a discretionary, non-elective matching contribution and (2) a discretionary profit sharing contribution, as determined by the Company. For 2024, the discretionary match was 50% of each dollar contributed up to 5% of eligible compensation, and the profit sharing contribution was 7.5% of eligible compensation.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, the Company's contribution, and an allocation of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan, as defined in the Plan agreement. Allocations are based on participant eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants are immediately 100% vested in their elective contributions and rollover contributions, plus actual earnings thereon. In the event the Company makes a discretionary matching contribution or profit sharing contribution on behalf of active participants, vesting in the contributions plus actual earnings thereon is based on years of continuous service (1,000 hours during a plan year) as follows:

Full vesting also occurs at retirement (normal retirement age is sixty-five years), disability, or death.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. Notes are secured by the balance in the participant's account and bear interest at a fixed rate equal to 1% above the prime rate at the time of loan funding. Principal and interest are paid ratably through payroll deductions.

**PAYMENT OF BENEFITS**

Participants are entitled to the benefits that can be provided from their individual account balances, subject to vesting, upon retirement, death, hardship, or termination. Payment is required to be made as soon as administratively feasible after one of these events occurs. The participant may elect to defer distribution until April 1 of the calendar year following the calendar year in which the participant reaches 72 years of age. The vested portion of the participant's benefits may be distributed to the participant or his beneficiary in the form of a single lump-sum payment, partial withdrawals or installments (for required minimum distributions), or as a direct rollover to an IRA. Vested balances less than \$7,000 at termination of employment are paid as a lump-sum. Hardship withdrawals are allowed at any time under the Plan from participant salary deferrals for qualified expenses, subject to self-certification of financial hardship by the participant.

**FORFEITURES**

Any portion of the balance in a participant's account that is not vested will become a forfeiture upon the distribution of the entire vested account balance or upon the occurrence of a break in service, as defined by the Plan. Forfeitures can be used to pay administrative expenses of the Plan, reduce employer contributions, or serve as discretionary contributions to remaining participants of the Plan. Forfeitures are allocated to participants in the same proportion that a participant's compensation bears to the total compensation of all participants. At December 31, 2024, and 2023, forfeited non-vested accounts totaled \$9,656 and \$7,534, respectively. During 2024, \$7,534 of forfeitures were allocated to participants.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements. See Note 5 for discussion of fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when paid. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

**NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are measured at the unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments, and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on terms of the Plan agreement.

**EXCESS CONTRIBUTIONS**

Estimated excess contributions of \$7,565 and \$1,590 at December 31, 2024 and 2023, respectively, represent payments due to certain active participants to return to them excess deferral contributions, as required to satisfy the relevant nondiscrimination provisions of the Plan. These amounts are recorded as liabilities, with corresponding reductions to participant contributions. Corrective amounts were distributed to the associated participants subsequent to each year end.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**ADMINISTRATIVE EXPENSES**

The Company and the Plan participants share in the Plan expenses. All fees related to individual participant activity, including withdrawal and loan origination fees, are charged and deducted from the respective participant's account or investment income. Investment management fees and other service fees are charged to the Plan as a reduction of investment return, are included in net investment appreciation or administrative expenses reported by the Plan, and are allocated to participant accounts based on participant earnings or account balances, as defined. Expenses paid by the Company are excluded from these financial statements.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and 2023, and net appreciation in fair value of investments, and interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained from data that has been prepared and certified as complete and accurate by Empower, the custodian, and Talcott Resolution Life Insurance Company, the issuer of the group annuity contract.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation method include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

*Pooled Separate Accounts:* Valued at the per unit value of each separate investment account fund, which is based on the observable quoted price of the underlying mutual funds at year end, adjusted for expense factors disclosed in the annuity contract. The custodian reports this value daily on its plan website, which is considered the net asset value (NAV) of the fund. NAV is used as a practical expedient to estimate fair value. For each account, the redemption frequency is daily with no required notice period. There are currently no redemption restrictions or unfunded commitments.

In accordance with U.S. GAAP, investments that are measured at fair value using the NAV per share (or its equivalent) as a practical expedient have not been categorized in the fair value hierarchy.

**NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan maintains a fully benefit-responsive group annuity contract issued by Talcott Resolution Life Insurance Company (“TRLIC”) and serviced by Empower, formerly known as Great-West Life & Annuity Insurance Company. TRLIC maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3 percent. Such interest rates are reviewed on a quarterly basis for resetting. The average yield during the years ended December 31, 2024 and 2023 was 3.00%.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The investment contract is presented on the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by TRLIC and Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan Administrator does not believe any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. Empower and TRLIC are each considered a party-in-interest. The Plan holds units of pooled separate accounts and a guaranteed investment contract issued and managed by TRLIC, Empower and subsidiaries of Empower. Therefore, these investments qualify as party-in-interest investments. Fees paid to Empower and other service providers are party-in-interest transactions and are included in administrative expenses in the statement of changes in net assets available for benefits. Fees paid by the Plan for investment management services during the years ended December 31, 2024, and 2023 totaled \$29,244 and \$24,215, respectively.

Notes receivable from participants held by the Plan are also considered party-in-interest transactions.

All such party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in a variety of investment securities. Investments securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan with respect to either a portion or all of the participants by delivering to the custodian written notice of such termination. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 9 - TAX STATUS**

The Plan has adopted a prototype non-standardized profit sharing plan which received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the plan was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified under Section 401(a), and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan has concluded that there are no uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 10 - SUBSEQUENT EVENTS**

Plan Management has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.
