1. Description of the plan

The following description of the Installed Building Products, LLC 401(k) Savings Plan and Trust (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: Installed Building Products, LLC 401(k) Savings Plan and Trust is a 401(k) profit sharing plan, formed effective April 1, 1993 for the purpose of providing retirement benefits to employees of Installed Building Products, LLC and affiliated companies (the “Company”).

Eligibility: All employees as defined by the Plan document who have attained age 18 and have completed one half year of service are eligible to make compensation reduction contributions to the Plan. Participation is voluntary.

Participant Contributions: A participating employee may elect to defer up to 90% of eligible compensation to the Plan. However, total deferrals by an individual participant in any calendar year may not exceed a dollar limit set by law (\$23,000 in 2024). This limit will be increased in future years for cost of living changes. Plan participants who are at least 50 years old by the end of the year may make special “catch-up” contributions. The limit for “catch-up” contributions was \$7,500 in 2024.

Employer Contributions: At the Company’s discretion, it may choose to match up to 25% of the first 8% of compensation reduction contributions made by participants. For 2024, the Company made \$2,419,187 in discretionary matching contributions.

The Company also has the ability to make a discretionary profit sharing contribution on behalf of all qualified employees (18 years of age and one half year of service completed as of the last day of the Plan year). Each qualified employee receives a pro rata share of a profit sharing contribution based on the relationship of his or her compensation to total compensation times the amount contributed. No discretionary profit sharing contribution was made during 2024.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, employer’s matching contributions, profit sharing contributions, forfeiture redistributions and Plan earnings or losses, and is charged with his or her withdrawals and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from his or her vested account.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Notes Receivable from Participants: The Plan allows for notes receivable from participants. These notes are secured by the vested portion of the participant’s account balance. The amount a participant may borrow is limited to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest payments are made via payroll deductions or check.

1. Description of the plan (continued)

Forfeitures: Forfeitures are made available to reinstate previously forfeited account balances of reemployed participants. Remaining forfeitures are used to reduce the employer's contributions, and if so elected by the employer, to reduce administrative expenses, and/or allocated to eligible participants who are employed as of the last day of the year. During 2024, forfeitures in the amount of \$276,250 were used to reduce employer contributions. There were \$67,358 and \$33,369 of unused forfeitures at December 31, 2024 and 2023, respectively.

Vesting: Participants are immediately vested in their voluntary contributions plus earnings (losses) thereon. Participants vest in the Company's matching contribution 100% after three years of service. The Company's profit sharing contribution, plus actual earnings thereon vests at a rate of 20% per year after two years of service until they are 100% vested after 6 years of service.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum payment equal to the vested interest in his or her account, or annual installments over their life expectancy. For termination and other distributions, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or in installments. A participant may withdraw his or her vested account balance prior to normal retirement age only upon reaching age 59 ½ or upon demonstrating a hardship need as defined by the Internal Revenue Code ("IRC").

2. Summary of Significant Accounting Policies

Administrative and Investment Management Expenses: The Plan's record keeping and custodial fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation reported by the Plan. Expenses include, but are not limited to, plan management, investment, and legal and audit fees. All other expenses of the Plan are paid by the Company.

Investment Options: The participant directs both their own and the employer's contributions into the investment options offered by the Plan. At any time, participants may also elect to reallocate existing account balances between investment options or to change their investment elections for future contributions.

Basis of Accounting: The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

2. Summary of Significant Accounting Policies (continued)

Risk and Uncertainties: The Plan provides for various investment options. The investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Contribution: Contributions from Plan participants and matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Investments Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Excess Contributions: Refunds of excess participant deferral and Employer match contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals and employer match were made to the Plan.

Benefit Payments: Benefit payments to participants are recorded upon distribution.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following are descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of its investments. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in the collective trusts are based on the net asset values per unit as reported by the fund manager. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the Invesco Stable Value Fund, twelve months irrevocable written notice is required; collective trusts issued by American Century Investments have no such redemption restrictions. There are no unfunded commitments. The Plan has no contractual obligations to further invest in the funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

5. Income Tax Status

The Internal Revenue Service has issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan and related trust are designed in accordance with applicable sections of the IRC. Plan management believes that the Plan is currently designed and is being operated in compliance with applicable requirements of the IRC.

5. Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Department of Labor or Internal Revenue Service; however, there are currently no audits for any tax years in progress.

6. Parties-In-Interest Transactions

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. At December 31, 2024 and 2023, certain Plan investments were shares of mutual funds managed by Fidelity Investments. Fidelity Management Trust Company is a subsidiary of Fidelity Investments and is a trustee as defined by the Plan, and therefore, these investments qualify as party-in-interest investments. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Additionally, certain consulting services were provided to the Plan and therefore qualify as party-in-interest transactions. The Plan held notes receivable from participants which represent party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. Upon the termination of the Plan, the rights of each participant to the assets then held for his or her account under the Plan become non-forfeitable.
