A. DESCRIPTION OF PLAN

The following description of The Kuhnle Brothers Trucking, Inc. 401 (k) Plan + Trust ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General. The Plan is a defined contribution plan covering all full-time employees of the Company, who have attained the service requirement and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan.
2. Eligibility. Employees will become eligible to participate and make Elective Deferral Contributions, and receive Matching Contributions and Profit-Sharing Contributions on the first day of the calendar month, or when the employee attains age 21 and has completed six months of service.
3. Contributions. Each year, participants may elect to make a contribution to the Plan on a pre-tax basis. These pre-tax contributions are known as Elective Deferral Contributions. Federal law limits the amount you may elect to defer under this Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds offered by Ascensus Trust (AC), who is also the Plan's asset custodian. The amount of participant contributions for the year ended December 31, 2024 and 2023 totaled \$539,729 and \$530,686, respectively. The Plan may also accept rollover contributions on behalf of an eligible employee. The total amount of rollover contributions transferred into the Plan is \$42,908 and \$0 for the years ended December 31, 2024 and 2023 respectively.

The Company may, in its sole discretion, make a matching contribution on behalf of participants. Such contribution is allocated to participants based on a formula as determined by the Company. The Company may also, in its sole discretion, make a Profit-Sharing contribution to the Plan. The total of employer contributions for the years ended December 31, 2024 and 2023 are \$53,866 and \$53,034, respectively.

4. Plan Expenses. Costs of administrating the Plan are paid by the Plan or the Company, subject to limitations under ERISA.

5. Participant Accounts. Each Participants account is credited with the participant's contributions, allocation of any Company matching contributions and /or Company profit sharing contributions along with the participant's earnings (or losses) on investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
6. Vesting. Participants are immediately vested in any contribution plus actual earnings thereon. A participant is 100% vested upon acceptance into the plan and accordingly, there are no forfeitures.
7. Investments. The Plan Administrator requires participants to direct the investment of all of their accounts. The Plan Administrator may establish uniform guidelines and procedures relating to participant self-direction.

Participants may direct the percentage of their accounts to be invested in one or more of the available investment funds. Participant elections will be subject to such rules and limitations as the Plan Administrator may prescribe. After death, the beneficiary may make investment elections as if the beneficiary were the participant. However, the Plan Administrator may restrict investment transfers to the extent required to comply with applicable laws.

8. Notes Receivable from Participants. Participants may borrow from the vested portion of their fund accounts if they meet certain hardship requirements. Principal and interest is paid ratably through monthly payroll deductions. The current interest rate ranges between 3.50% to 8.50%. The outstanding balances at December 31, 2024 and 2023 totaled \$114,626 and \$90,024 respectively. The total amount of interest income recognized from participant notes receivable was \$4,479 and \$3,690 for the years ended December 31, 2024 and 2023, respectively. Fees for the administration of notes receivable from participants are charged directly to the participant's account.
9. Payment of Benefits. Upon termination of employment a participant will receive a lump sum payment equal to the value of the participant's vested interest in their account. A lump sum is the normal form of payment, however, installments are available. The current benefits paid amounted to \$863,091 in 2024 and \$450,140 in 2023.
10. Retirement. Normal retirement age is 65 but, participation may continue for late retirees.
11. Death. Upon death, the participant's beneficiary is entitled to receive the decedents vested account balance.

B. SUMMARY OF ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

1. a. Basis of Accounting. The accompanying financial statements are prepared on the accrual basis of accounting.
- b. Estimates. The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
2. Investment Valuation and Income Recognition – Investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments and sold as well as held during the year.

C. FAIR VALUE MEASUREMENTS

FASB ASC 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of fair value hierarchy are described as follows:

- Level 1: Inputs consist of unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2: Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.
- Level 3: Inputs consist of observable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

C. FAIR VALUE MEASUREMENTS (CONT'D)

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – The value of a separate account is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

The preceding methods described may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial investments could result in a different fair value measurement at the reporting date.

- (a) Certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. They are valued daily, can be redeemed daily with no restrictions, and without prior notice. There are no unfunded commitments.

D. INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust, a firm associated with VGI Vanguard Group, has certified that the following date included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024.

- Investments, at fair value
- Net appreciation in fair value of investments
- Interest income
- Schedule of Assets (Held at End of Year)
- Schedule of Transactions in Excess of 5% of Plan Assets

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

E. PLAN TERMINATION

Although the Company intends to maintain the Plan indefinitely, the Company has the right under the Plan to discontinue its contributions and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to participant accounts will become 100% vested.

F. TAX STATUS

The Internal Revenue Service has favorably determined and informed the Company by a letter dated June 30, 2020, that the Plan is properly designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plans is in compliance with their annual filings with the Department of Labor and the Internal Revenue Service. These filings can be reviewed for up to the last three years, and are still open for examination, namely years 2022, 2023, and 2024.

G. OTHER

There have not been any related party transactions during 2024 and 2023. However, there are party-in-interest transactions between the Trustee of the Plan's assets, Ascensus Trust, and the Plan's Sponsor, Kuhnle Brothers Trucking, Inc. 401 (k) Plan + Trust. These transactions are limited to assets held in various mutual funds of registered investment companies and are transacted at arm's length. In addition, there is no material difference between what has been reported in these financial statements and the financial information reported on the Form 5500 for the corresponding year.

Other party-in-interest includes Ascensus Trust, who prepares Form 5500, and Demarchi & Schaefer, the auditors.

Income from investments during 2024 includes interest of \$55,830, dividends reinvested of \$89,258, capital gain distributions of \$117,959, realized gains on investments bought and sold of \$142,056, and unrealized gains of \$212,770.

Income from investments during 2023 includes interest of \$54,648, dividends reinvested of \$73,117, capital gain distributions of \$12,867, realized losses on investments bought and sold of \$(163,886), and unrealized gains of \$620,935.

H. LITIGATION

Legal counsel and the Plan Administrator are not aware of any litigation or any other contingencies that will have a material effect on these financial statements.

I. SUBSEQUENT EVENTS

The Plan Administrator is not aware of any other subsequent events, which have been evaluated through September 29, 2025, the date of financial statement issuance.

J. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and amounts reported in the Statement of Net Assets Available for Plan Benefits.
