Prototype 401(k) Profit-Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Notes to Financial Statements

1. Description of the Plan

The following description of the 1-800-Flowers Team Services, Inc. Prototype 401(k) Profit-Sharing Plan (the Plan) provides only general information. Participants should refer to the comprehensive Plan document for a complete description of the Plan's provisions.

General

The Plan was adopted effective April 1, 1996 by 1-800-Flowers Team Services, Inc. (the Employer or Company), the Plan Sponsor. The Plan is a defined contribution plan covering substantially all employees of the Company, except for temporary and/or seasonal employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan Sponsor adopted an additional defined contribution plan effective January 1, 2018, 1-800-Flowers Team Services, Inc. 401(k) Plan (the Additional Plan), covering substantially all eligible temporary and/or seasonal employees of the Company. During calendar year 2024, net transfers of \$325,222 were made from the Additional Plan relating to employees' change in employment status and therefore being able to participate in the Additional Plan.

Trustee and Administration of the Plan

The trustee and recordkeeper of the Plan is the Fidelity Management Trust Company (Fidelity or the Trustee). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The primary objective of the Plan is to provide eligible employees of the Company with the long-term accumulation of retirement savings through a combination of employee and the potential earnings thereon.

Eligibility

To participate in the Plan, employees must be at least 21 years of age. Participation in the Plan is voluntary. All employees are eligible to participate in the Plan unless they are otherwise excluded in accordance with the Plan document.

Contributions

Participants may contribute up to 80% of their annual eligible pretax compensation providing that such contributions do not exceed the maximum allowed contribution limits established by the Internal Revenue Service (IRS) each year. For 2024, the maximum allowed contribution limit was \$23,000 with an additional \$7,500 for eligible participants who attained the age of 50 before the close of the Plan year.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Plan also has an escalation feature whereby the deferral rate will increase each year by 1%.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers) and Roth deferrals.

Notes to Financial Statements

In accordance with the provisions of the Plan, the Company makes a discretionary matching employer contribution of 50% of the first \$1,500 of annual eligible compensation contributed by the participants. The Company may also make discretionary nonelective employer contributions to eligible participants. During the year ended December 31, 2024, no nonelective employer contributions were made.

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer contributions, and an allocation of Plan earnings or losses, thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are immediately vested in their own contributions, nonelective employer contributions, if any, and earnings thereon. Participants become vested in benefits arising from Company's matching employer contributions plus earnings thereon based on years of continuous service according to the following schedule:

Years of Service	Vesting (%)
Less than 2	-
2 but less than 3	25
3 but less than 4	50
4 but less than 5	75
5 or more	100

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, or becoming disabled, as defined. Additionally, the value of a participant's contributions and earnings thereon plus all vested employer contributions are payable upon termination. Payment may be made as a lump sum.

In case of serious financial hardship, as defined by the Plan, participants may be eligible to receive an hardship withdrawal of a certain portion of their vested account balance.

Forfeitures

Forfeited nonvested amounts are used to reduce future employer contributions and/or Plan administrative fees. During 2024, approximately \$1,000 was used to reduce Plan administrative fees and approximately \$326,000 was used to fund employer match. As of December 31, 2024 and 2023, approximately \$143,000 and \$163,000, respectively, in cumulative forfeited amounts was available to offset future employer contributions and/or Plan administrative fees. Balances of forfeitures available are temporarily invested until utilized and reflect gains or losses during the period held.

Notes Receivable from Participants

Generally, participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or up to ten years for the purchase of a primary residence. The notes are secured by the participant's vested account balance and bear interest at a rate of prime plus 1%. Principal and interest are paid ratably through payroll deductions. Related fees are recorded as administrative expenses and are expensed when they are incurred. The interest rates on outstanding notes receivable at December 31, 2024 and 2023 ranged from 3.25% to 9.50%.

2. Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan to make estimates and assumptions that may affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account

and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

In addition, the Trustee provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan. If the revenue received by the Trustee from such mutual fund service providers exceeds the amounts owed, the Trustee remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During 2024, \$197,015 from the revenue-sharing account balance were used to reduce Plan administrative fees. As of December 31, 2024 and 2023, the revenue-sharing account balances were approximately \$351,700 and \$233,500, respectively, which will be used to fund future administrative expenses. During 2024, the Plan received a fee credit of approximately \$302,600, which is recorded as other income on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding increase to corrective distributions. As of December 31, 2024 and 2023, excess deferrals payable totaled \$153,516 and \$364,664, respectively. The excess contributions have been distributed to participants in March 2025 and March 2024, respectively, to comply with the statutory limitations on annual additions to participants' accounts.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

4. Tax Status

The Plan uses a pre-approved plan document sponsored by Fidelity. Fidelity received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, all participants' accounts shall become fully vested and distributed in accordance with the provisions of the Plan.

7. Related Party and Party-in-Interest Transactions

The Plan, the Plan Sponsor, and Fidelity are parties-in-interest with respect to the Plan under the provisions of ERISA. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

8. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - This level consists of unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 - This level consists of inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in markets that are not active.
- Observable inputs other than quoted prices that are used in the valuation of the asset or liability (e.g., interest rate and yield curve quotes at commonly quoted intervals).
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - This level consists of unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for investments measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

9. Fully Benefit-Responsive Guaranteed Investment Contract

The Plan has an interest in Guaranteed Income Fund. The Plan entered into a benefit-responsive guaranteed investment contract with Prudential Retirement Insurance and Annuity Company (PRIAC). Effective April 1, 2022, PRIAC was acquired by Empower Annuity Insurance Company (Empower). PRIAC maintains the contributions in a general account. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by PRIAC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.5%. The crediting rate is reviewed on a quarterly basis for resetting.

No events would limit the Plan's ability to transact at contract value.

10. Mutual Fund Fees

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

11. Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued. There were no significant events requiring adjustment to the financial statements or disclosure.
