INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of the PineBridge 401(k) Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PineBridge 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the PineBridge 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

[1] General:

The Plan is a defined-contribution plan covering eligible employees, excluding leased employees, of PineBridge Investments Holdings US LLC (the "Plan sponsor", as defined), PineBridge Investments LLC and PineBridge International Services LLC (collectively, the "Employer"), subsidiaries of PineBridge Investments Limited (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established March 26, 2010.

[2] Contributions:

Upon date of hire, employees are immediately eligible to voluntarily contribute to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, which the participant can amend. Each year, participants may contribute any amount up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code (the "Code") sections 402(g) and 414(v), not to exceed the limits of Code sections 401(k), 404 and 415, as defined in the Plan document. Participants may also roll over amounts representing distributions from other qualified plans. All employees who are eligible to make elective deferrals under the Plan and who have attained age 50 before the close of the Plan year shall be eligible to make catch-up contributions. Roth deferrals are permitted. The Company makes matching contributions of 100% of each participant's elective deferral up to 5% of pretax annual compensation, as defined. The maximum Employer contribution was \$17,250 in 2024 and \$16,500 in 2023. The Company may also choose to make a discretionary non-elective contribution on behalf of eligible employees. In 2024, the Company did not make such a contribution. All participant and Employer contributions and earnings and losses thereon are immediately vested and nonforfeitable. Participants direct the investment of their contributions and the employers into various investment options offered by the Plan. Starting August 1, 2022, the Plan was amended to permit participants the opportunity to contribute after-tax dollars. After-tax contributions can only be made once the pre-tax annual contribution limits have been met.

[3] Participant accounts:

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document.

[4] Vesting:

Participants are immediately vested in their contributions plus actual earning thereon. The participant's vesting in the Company's matching and discretionary contribution portion of their accounts, plus actual earnings are fully and immediately vested.

[5] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are to be repaid over a period not to exceed 5 years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates on outstanding loan balances range from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions or another approved manner. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

[6] Payment of benefits:

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may receive a full distribution of their benefits upon retirement, in the event of death or disability, upon termination of employment or upon attaining the age of 59½. Benefits payable under the Plan shall be made in a lump sum payment, installment payment or partial payment. The entire interest of a participant must be distributed or begin to be distributed no later than April 1 of the calendar year following the calendar year in which the participant attains the age of 70½ if the participant is a five-percent owner of the Employer, as defined by the Code. For all other participants that attain the age of 70½ while still an employee, the distribution date is the date service is terminated.

If the value of a terminated participant's account is \$1,000 or less, the Plan shall immediately distribute the participant's entire vested account balance. If the value of an eligible roll over of a terminated participant's account is greater than \$1,000 but not more than \$5,000, the Plan shall be subject to automatic roll over requirements.

[7] Administrative expenses:

Non-investment costs and administrative expenses of the Plan are generally paid by the Company. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions under ERISA. Certain Plan expenses are paid through revenue-sharing agreements with investment funds. Revenue share income is recorded as net realized and unrealized appreciation in fair value of investments, and can be utilized to pay Plan expenses. If the revenue generated is less than the expenses, the expenses will be paid by the Plan. During 2024, \$138,259 was received and expenses of \$131,043 were paid through such agreements. The expense budget account holds \$37,569 and \$30,353 as of December 31, 2024, and 2023, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of presentation:

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with generally accepted accounting principles.

[2] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[3] Payment of benefits:

Benefits are recorded when paid.

[4] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements, and changes therein, during the reporting period and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

[5] Subsequent events:

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued, to determine whether any subsequent events necessitate adjustment to or disclosure in the financial statements. The Plan Sponsor announced in December 2024 that it has reached a definitive agreement to be acquired by MetLife Investment Management, the institutional asset management business of MetLife, Inc. As of the date of the financial statements, the acquisition has not yet been finalized. In anticipation of the transaction, in 2025, ten participants of the Plan, that are excluded from the anticipated acquisition had their account balances be transferred to a new plan.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, State Street Bank and Trust Company ("State Street"), the custodian of the Plan, has certified the completeness and accuracy (inclusive of information provided by Transamerica Retirement Solutions, LLC on behalf of State Street) to the best of their knowledge, of non-interest bearing cash account, all investments and related activity and notes receivable from participants and related activities in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standard Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability, or (4) inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for investment assets and liabilities measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds: The Plan invests in the Transamerica Retirement Solutions Collective Trust Institutional Stable Pooled Fund (the "Trust"), which is offered through the Transamerica Retirement Solutions Collective Trust. The Trust has invested all of its assets in the Galliard Stable Return Fund W ("GW"). GW invests wholly in the Galliard Stable Return Fund Core ("Core"). GW and Core are collective investment trusts maintained by SEI Trust Company ("SEI"), as advised by Galliard Capital Management, LLC. Core seeks to provide investors with a moderate level of stable income without principal volatility and is primarily invested in investment contracts, including traditional guaranteed investment and security-backed contracts issued by insurance companies and other financial institutions. In addition, the Plan invests in the PineBridge High Yield CIT ("Yield") through the PineBridge Collective Trust ("PBTrust"), which is offered through SEI. PineBridge Investments LLC is the advisor to the PBTrust. Yield invests primarily in USD-denominated, non-investment grade, fixed-rate, taxable corporate bonds. Investments in Trust and Yield are valued at NAV per unit as determined as of the close of business each day. Unit prices are based on the market value of the underlying assets. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The redemption frequency for participant transactions in the collective funds is daily upon receipt of a written authorized withdrawal notice. Were the Plan to initiate a full redemption of the Trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. Such delay will be at least 90 days after receipt of written notice of termination, not to exceed 12 months. Yield reserves the right to temporarily suspend withdrawals from the trust where circumstances exist that would make security liquidation not reasonably practical. As of December 31, 2024 and 2023, there were no unfunded commitments in Trust and Yield.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

NOTE E - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in a common/collective trust offered through Transamerica Retirement Solutions LLC ("Transamerica") formed under an agreement and declaration of trust between Transamerica, the Plan record-keeper and State Street. Fees paid by the Plan to Transamerica were \$5,576, for the year ended December 31, 2024. The Plan also pays investment advisory fees. As service providers to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to these service providers were \$133,279 for the year ended December 31, 2024.

The Plan invests in Yield and PineBridge Dynamic Asset Allocation Fund, investment vehicles managed by the Company. The Company derives revenues from such advisory and administrative services which are charged monthly to the funds based on the average daily net assets under management.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, credit, liquidity and market perception risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE H - TAX STATUS

The Plan has adopted a Pre-Approved plan sponsored by Transamerica Retirement Solutions, LLC. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the Pre-Approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Code and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions.

NOTE I - MUTUAL FUND FEES
