NOTE 1 - DESCRIPTION OF PLAN

The following description of the Holladay Property Services Midwest, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Holladay Property Services Midwest, Inc. (the "Plan Sponsor") who elect to participate after completing three months of service. Plan entry occurs on the first day of each calendar quarter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Until 2024, the Plan also covered employees of Holladay Construction Group and Holladay Hospitality Group, which were part of the Plan Sponsor's controlled group. During 2024, ownership of these entities changed, and they were spun out of the Plan. As a result, related transfers of plan assets are reflected in the Statement of Changes in Net Assets Available for Benefits (see Note 9).

Contributions: The Plan is a contributory plan whereby an employee who elects to participate may contribute up to 100% of the participant's compensation subject to limitations as defined by the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows for Roth contributions and in-plan Roth rollover conversions. Participants may also contribute amounts representing distributions from other qualified defined contributions plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may also make discretionary matching and profit-sharing contributions at the option of the Company's board of directors. The Company matched 25% of the first 4% of eligible compensation that a participant contributed to the Plan in 2024. Matching contributions totaled \$227,111 and \$200,641 in 2024 and 2023, respectively. Discretionary profit-sharing contributions for the year ended totaled \$528 and \$48,000 in 2024 and 2023, respectively.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balance fund. Automatic enrollment deferral contributions are increased 1% each year up to 10%

Participant Accounts: Each participant's account is credited with their personal contributions, the Company's discretionary matching and profit-sharing contributions, and earnings on the account, and charged with benefit payments, losses on the account, and certain administration expenses. Allocations are based on the participant's earnings, account balances, or specific participant transactions, as defined. Forfeitures may be added to the discretionary profit-sharing contributions and allocated in the same manner or allocated among participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their deferral including Roth, catch up contributions and rollover contributions. Vesting in the Company's matching and profit-sharing contributions portion of participants' accounts, if any, plus actual earnings thereon based on years of continuous service, with one year of vesting defined as 1,000 hours of service during the Plan year. Participants vest in Company matching and profit-sharing contributions and earning thereon, 20 percent after one year with an additional 20 percent each year thereafter until fully vested after five years of service.

Retirement, Death, Disability: A participant is entitled to 100 percent of his or her account upon retirement, death, or disability.

Forfeitures: During 2024 and 2023, forfeited employer contributions were used to offset Plan administrative expenses and employer contributions. As of December 31, 2024, forfeited accounts held by the Plan totaled \$48,321. Forfeitures may first be applied to offset employer contributions and administrative expenses of the Plan which would otherwise be paid by the Company or reallocated to eligible participants based upon their respective compensation.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$500 up to the maximum amount equal to the lesser of \$50,000 or 50 percent of their vested account balance (reduced by any outstanding loan balance, outstanding during the previous 12 months). The loans are to be repaid over a period not to exceed five years, except as to loans used to acquire a principal residence, in which event the term is to be no more than 30 years. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with market rates for similar loans. Principal and interest are repayable through payroll deductions.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the event of death) may elect to receive the vested interest in his or her account as a lump-sum distribution. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Withdrawals may also be made when a participant attains age 59 ½ or demonstrates financial hardship. Other certain in-service withdrawals are also permitted.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan Year in which the excess deferrals were made to the Plan. If the excess contributions are refunded in a subsequent year, the prior liability is reversed through benefits paid, thereby reducing the current year benefits paid balance.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participant at the measurement date. See Note 4 for discussion of fair value measurements.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal. Interest income is recorded on accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan is reduced, and a benefit payment is recorded.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment and Administrative Expenses: The Plan's expenses are paid either by the Plan or the employer, as provided in the Plan document. Expenses paid directly by the employer are excluded from these financial statements. Certain fees are charged to the Plan for services provided by the investment custodian of the Plan and are netted with investment earnings.

Plan Transfers: From time to time, the Plan may transfer assets to or from other qualified retirement plans as a result of corporate transactions, such as mergers, acquisitions, or spin-offs. These transfers are accounted for as increases or decreases in net assets available for benefits and are presented as a separate line item within the Statement of Changes in Net Assets Available for Benefits. Such transfers do not represent benefit payments to participants or administrative expenses of the Plan.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to distribution and administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments on the statement of changes in net assets available for benefit.

NOTE 3 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Standard Insurance Company (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each of the pooled separate accounts invests either in domestic stocks, real estate, fixed income or in single mutual funds which are generally identified in the name of the pooled separate account. The underlying investment composition of the pooled separate account as of December 31, 2024, are approximately 7% Fixed Income, 5% International Equity, 1% Real Estate, 48% Target Date Mutual Funds, and 38% US Equity, respectively.

The underlying investment composition of the pooled separate account as of December 31, 2023, are approximately 10% Fixed Income, 6% International Equity, 1% Real Estate, 50% Target Date Mutual Funds, and 32% US Equity, respectively.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient are not required to be classified in the fair value hierarchy. Since the Plan's only investments at fair value are pooled separate accounts valued at net asset value, a fair value hierarchy table is not necessary. These pooled separate accounts have a total value of \$16,269,744 and \$16,715,231 at December 31, 2024 and 2023, respectively.

NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds a fully benefit-responsive investment contract with Minnesota Life. Minnesota Life maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Based upon Minnesota Life's recent credit ratings, Plan management has determined that no adjustment to contract value is required related to the credit quality of the issuer of this contract. There are no reserves against contract value for credit risk of the Issuer or otherwise.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which Minnesota Life may terminate the contract. Examples of circumstances that would allow Minnesota Life to terminate the contract include the Plan's loss of its qualified status or material and adverse changes to provisions of the Plan. If one of these events were to occur, Minnesota Life could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be effected by future economic and regulatory developments.

The contract value of the Plan's fully benefit-responsive investment contract was \$872,302 and \$381,216 at December 31, 2024 and 2023, respectively.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are in funds that are managed by The Standard Insurance Company. Participant loan and distribution processing fees are paid to The Standard Insurance Company by participants. The Plan pays for third-party administrator fees, investment advisory, and plan audit fees which qualify as party-in-interest transactions. Total fees paid by the Plan to service providers to the Plan for asset charges, administration fees, and loan fees amounted to \$34,596 for the year ended December 31, 2024.

The Plan holds notes receivable from participants at December 31, 2024 and 2023 of \$104,247 and \$100,897, respectively. These qualify as party-in-interest transactions.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA and its regulations. In the event of Plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 8 - TAX STATUS

The Internal Revenue Service (“IRS”) issued an opinion letter dated March 31, 2014, indicating that the plan document adopted by the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended from the original prototype document, plan management believes that the Plan is currently being operated in accordance with the IRC. On November 30 2020, Retirement Plan Concepts & Services, Inc. received an opinion letter from the IRS stating that its pre-approved plan satisfied the requirements of the IRC. Effective July 1, 2022, the Plan was restated for regulatory compliance purposes and adopted a pre-approved plan document of Retirement Plan Concepts & Services Inc.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021

NOTE 9 – PLAN TRANSFER

During the year ended December 31, 2024, the Plan transferred \$2,192,335 of net assets to newly established defined contribution plans in connection with the spin-off of certain business operations of the Plan sponsor. The transfer was completed in accordance with the provisions of the Internal Revenue Code and ERISA.

NOTE 10 - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through October 8, 2025, which is the date the financial statements were available to be issued.
