**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of West Coast Self-Storage Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 - Description of Plan

The following description of the West Coast Self-Storage Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan established on January 1, 2013. The Plan covers eligible employees of West Coast Self-Storage Group, LLC (“the Company”). The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### Eligibility

Employees are eligible to participate in the Plan upon hire, provided they are at least 21 years of age and completed sixty days of service.

#### Contributions

Participants may contribute up to 100% of their compensation (as defined in the Plan Document), subject to the maximum dollar amounts allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollover contributions”).

The Company contributes a discretionary matching contribution in an amount equal to 8% of each participant’s salary deferral. In addition, the Plan also allows for a Company discretionary profit-sharing contribution; however, no such discretionary profit-sharing contribution was made for the year ended December 31, 2024.

#### Vesting

Participants are immediately vested in their contributions. Any Company discretionary matching or discretionary profit-sharing contributions and related net earnings become vested to the participant based on the following schedule of years of service:

Additionally, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s discretionary matching contribution and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants have full discretion to direct their proportionate share (vested and non-vested) of Plan assets to a variety of investment funds.

#### Benefit Payments

Upon termination of employment, death, disability, or retirement (age 59½), the participant will receive the value of the vested interest in his or her account in the form of a lump-sum distribution or in installment payments, depending on the account balance. The Plan allows for in-service distributions if a participant reaches age 59½, as well as hardship distributions. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent.

#### Forfeited Accounts

The use of forfeited nonvested accounts is based on the discretion of the Plan. Forfeited nonvested accounts may be used to reduce administrative expenses or used to reduce future Company contributions. Forfeited nonvested accounts totaled \$6,741 and \$5,172 as of December 31, 2024 and 2023, respectively. Forfeitures amounted to \$1,380 for the year ended December 31, 2024. No forfeitures were used by the Plan to reduce Company contributions or administrative expenses for the year ended December 31, 2024.

#### Plan Changes

The Company has the right to amend or terminate the Plan at any time. However, no such amendment or termination shall deprive any participant of any vested interest in the Plan. In the event of Plan termination, participants will become fully vested in their accounts.

#### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## Note 2 - Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Contributions

Contributions from participants are recorded in the period in which they are withheld from the participant's compensation. Discretionary matching contributions from the Company are recorded in the period in which the related participant contributions are recorded.

### Investment Valuation and Income Recognition

The Plan's investments consist of mutual funds which are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. Net appreciation of investments represents the change in fair value of assets from one period to the next and includes realized gains and losses on investments.

### Administrative Expenses

The Plan provides that certain expenses of the Plan may be paid by the Plan or the Company. Certain expenses incurred to maintain the Plan are paid directly by the Company and are excluded from these financial statements.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the audited financial statements were available to be issued.

## **Note 3 - Fair Value Measurements**

Fair value is defined as an exit price, representing the amount that would be used to sell an asset or paid to transfer a liability in an orderly transaction between market participants. As such, fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability.

There are three levels that prioritize the inputs used in measuring fair values as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2: Observable market inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for the Plan's assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Mutual Funds:* Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### Note 4 - Information Prepared and Certified by Capital Bank and Trust Company

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, a qualified institution, has certified as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplementary Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### Note 5 - Tax Status

The Plan adopted a volume submitter plan developed by the volume submitted sponsor. Based in part on a favorable opinion letter received for the volume submitter plan dated June 30, 2020, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

In accordance with the guidance on accounting for uncertainty in income taxes, the Plan administrator evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 6 - Party-In-Interest Transactions

The Plan's investments are managed by affiliates of Capital Bank and Trust Company. The Plan has engaged Capital Bank and Trust Company for recordkeeping, custodian, and consulting services. Therefore, transactions with these entities are party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.
