NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the ARC Document Solutions 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan for employees of ARC Document Solutions, Inc. (the “Company” and plan administrator) covering all employees who are not nonresident aliens or residents of Puerto Rico. Employees who have attained age 21 are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Contributions

Participants may make voluntary contributions of up to 75% of pretax annual compensation, as defined in the Plan, subject to limitations by the Internal Revenue Code (“IRC”). Effective January 1, 2019, the Plan was amended to allow for automatic enrollment. Eligible newly hired and rehired employees, who do not make an affirmative election to defer compensation or opt out of the Plan, are auto-enrolled at a pre-tax contribution rate of 4% of eligible compensation. Rollover and catch-up contributions are permitted. The Company contributes 20% of the first 4% of each participant’s salary deferred. The Company made matching contributions of \$495,611 for the year ended December 31, 2024. There was no profit-sharing contribution in 2024.

C. Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company matching contributions, rollover contributions and allocations of: (a) the Company’s profit sharing contributions, and (b) Plan earnings. These amounts are invested in any of the available investment funds in whole percentages, as directed by the participant. Plan earnings are based on each participant’s investment election.

D. Vesting

Participants are immediately 100% vested in their voluntary contributions, rollover contributions and related earnings. Vesting in the Company’s profit sharing and matching contributions are based on years of credited service as follows:

E. Payment of Benefits

Normal retirement age is 65. A participant’s benefits will be distributed at retirement, death, total and permanent disability, or termination of employment in a lump-sum payment equal to the value of the participant’s vested interest in his or her account. Hardship withdrawals are permitted. Benefits are recorded when paid.

F. Forfeitures

Forfeitures will be used to pay administrative expenses or reduce future Company contributions. Forfeitures of \$948 were used to offset 2024 Company contributions and expenses. Participant forfeitures totaled \$49,945 in 2024. The forfeiture balance as of December 31, 2024 and 2023 was \$197,435 and \$150,760, respectively, and is included in the Guaranteed Income Fund for both years.

G. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the loan must be repaid to the Plan in 30 years. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

H. Administrative Expenses

All reasonable expenses related to plan administration will be paid from Plan assets, except to the extent the expenses are paid or reimbursed by the Company. In addition to the use of forfeitures, the plan administrator in its discretion may use the ERISA Fee Recapture Account ("ERISA Account") to pay for some plan expenses. In 2024, \$43,551 of the third-party expenses was paid from the ERISA Account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of these financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires plan management to make certain estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds that are reported based on quoted prices in an active market. Purchases and sales of investments are reported on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation of investments includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments include a variety of securities that are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants’ account balances and the amounts reported in the financial statements.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company, the trustee of the Plan.

NOTE 4 - GUARANTEED INCOME FUND

The Plan maintains a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company ("EAIC") through the Fixed Income Guaranteed Option ("Guaranteed Interest Account"). Contributions to the Guaranteed Interest Account are maintained in an insurance company general account and credited for interest and charged for participant withdrawals and administrative expenses. EAIC is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Guaranteed Interest Account meets fully benefit-responsive investment contract criteria and is reported at contract value of \$10,209,359 and \$13,684,768 at December 31, 2024 and 2023, respectively. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The Plan's ability to receive amounts due is dependent on EAIC's ability to meet its financial obligation. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Guaranteed Interest Account. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6 - INCOME TAX STATUS

The Company adopted a prototype plan that has received a favorable determination letter dated April 29, 2014 from the Internal Revenue Service ("IRS") stating that the form of the Plan qualifies under the applicable provisions of the IRC. The Plan has since been amended. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are issued or managed by the trustees or their related entities. Transactions involving these investments are considered party-in-interest transactions; however, they are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 15, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.

NOTE 1 - DESCRIPTION OF THE PLAN

The following brief description of the ARC Document Solutions 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan for employees of ARC Document Solutions, Inc. (the “Company” and plan administrator) covering all employees who are not nonresident aliens or residents of Puerto Rico. Employees who have attained age 21 are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Contributions

Participants may make voluntary contributions of up to 75% of pretax annual compensation, as defined in the Plan, subject to limitations by the Internal Revenue Code (“IRC”). Effective January 1, 2019, the Plan was amended to allow for automatic enrollment. Eligible newly hired and rehired employees, who do not make an affirmative election to defer compensation or opt out of the Plan, are auto-enrolled at a pre-tax contribution rate of 4% of eligible compensation. Rollover and catch-up contributions are permitted. The Company contributes 20% of the first 4% of each participant’s salary deferred. The Company made matching contributions of \$495,611 for the year ended December 31, 2024. There was no profit-sharing contribution in 2024.

C. Participant Accounts

Each participant’s account is credited with the participant’s contributions, Company matching contributions, rollover contributions and allocations of: (a) the Company’s profit sharing contributions, and (b) Plan earnings. These amounts are invested in any of the available investment funds in whole percentages, as directed by the participant. Plan earnings are based on each participant’s investment election.

D. Vesting

Participants are immediately 100% vested in their voluntary contributions, rollover contributions and related earnings. Vesting in the Company’s profit sharing and matching contributions are based on years of credited service as follows:

E. Payment of Benefits

Normal retirement age is 65. A participant’s benefits will be distributed at retirement, death, total and permanent disability, or termination of employment in a lump-sum payment equal to the value of the participant’s vested interest in his or her account. Hardship withdrawals are permitted. Benefits are recorded when paid.

F. Forfeitures

Forfeitures will be used to pay administrative expenses or reduce future Company contributions. Forfeitures of \$948 were used to offset 2024 Company contributions and expenses. Participant forfeitures totaled \$49,945 in 2024. The forfeiture balance as of December 31, 2024 and 2023 was \$197,435 and \$150,760, respectively, and is included in the Guaranteed Income Fund for both years.

G. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears interest at available market financing rates and must be repaid to the Plan in five years unless the loan is used for the purchase of a principal residence, in which case the loan must be repaid to the Plan in 30 years. The plan administrator establishes the specific terms and conditions of loans to participants. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50%.

H. Administrative Expenses

All reasonable expenses related to plan administration will be paid from Plan assets, except to the extent the expenses are paid or reimbursed by the Company. In addition to the use of forfeitures, the plan administrator in its discretion may use the ERISA Fee Recapture Account ("ERISA Account") to pay for some plan expenses. In 2024, \$43,551 of the third-party expenses was paid from the ERISA Account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

B. Use of Estimates

The preparation of these financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires plan management to make certain estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition

GAAP establishes a fair value hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market:

Level 1 – Inputs are quoted prices in an active market.

Level 2 – Inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data.

C. Investment Valuation and Income Recognition (Continued)

Level 3 – Inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds that are reported based on quoted prices in an active market. Purchases and sales of investments are reported on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation of investments includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments include a variety of securities that are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with investments, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants’ account balances and the amounts reported in the financial statements.

NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company, the trustee of the Plan.

NOTE 4 - GUARANTEED INCOME FUND

The Plan maintains a fully benefit-responsive group annuity contract with Empower Annuity Insurance Company ("EAIC") through the Fixed Income Guaranteed Option ("Guaranteed Interest Account"). Contributions to the Guaranteed Interest Account are maintained in an insurance company general account and credited for interest and charged for participant withdrawals and administrative expenses. EAIC is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Guaranteed Interest Account meets fully benefit-responsive investment contract criteria and is reported at contract value of \$10,209,359 and \$13,684,768 at December 31, 2024 and 2023, respectively. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The Plan's ability to receive amounts due is dependent on EAIC's ability to meet its financial obligation. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Guaranteed Interest Account. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6 - INCOME TAX STATUS

The Company adopted a prototype plan that has received a favorable determination letter dated April 29, 2014 from the Internal Revenue Service ("IRS") stating that the form of the Plan qualifies under the applicable provisions of the IRC. The Plan has since been amended. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain investments held by the Plan are issued or managed by the trustees or their related entities. Transactions involving these investments are considered party-in-interest transactions; however, they are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 8 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 15, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
